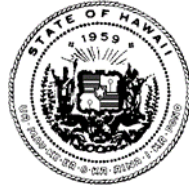
TESTIMONY:

SHPDA emphatically supports this bill as key to our primary responsibility to assuring universal access to high-quality, equitable, affordable health care for ALL.

The impacts of the HR1 (OBBBA) could increase uninsured persons in Hawai'i, including keiki, due to cuts on Medicaid and impacts on Obamacare Exchange tax incentive cuts. SHPDA's Health Data Advisory Council in 2025 estimated that, while Hawai'i enjoys having 96.4% of our population with health insurance, there are 5-9% uninsured persons including keiki on neighbor islands, and this situation could become worse because of HR1.

SHPDA strongly supports the intent of this bill and defers to DHS Med-QUEST Division on the details of implementation and financing of this humanitarian and important healthcare objective.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the bill's intent and offers comments. DHS respectfully requests that this program and appropriation not conflict with, reduce, or replace priorities identified in the executive budget. Additionally, for reference, DHS prefers that any increase in appropriation be included in the executive budget bill as a recurring appropriation to ensure ongoing coverage.

PURPOSE: This bill directs the Department of Human Services to adopt rules to expand Medicaid eligibility to all children in the State from birth to age 5 years without regard to household income. Appropriates moneys.

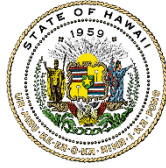
DHS believes there is a clear benefit to the state in ensuring that all residents have access to health care. Existing data sources estimate that approximately 77,000 children are between birth and age 5 in Hawaii. Currently, QUEST Integration, Hawaii's Medicaid program, already covers 49,700 (65%) of Hawaii's keiki in this age range. The approximate 27,000 children from birth to 5 who are not currently covered by QUEST Integration would require an annual appropriation of \$86,000,000. This program would be 100% State funded since the DHS Med-QUEST Division cannot

leverage Federal matching dollars for coverage that does not align with existing federal Medicaid eligibility rules.

Executive Office on Early Learning's Position: **COMMENTS**

The Executive Office on Early Learning (EOEL) offers the following comments in support of the intent of S.B. No. 1139, and defers to the Department of Human Services (DHS).

This measure is aligned with the Early Learning Board's current Framework of Policy Priorities, which are grounded in the Hawai'i's early childhood state plan. Specifically, the bill advances State Plan Building Block 1: Keiki and 'Ohana Health, Safety, and Well-Being, by increasing access to comprehensive health care during a critical period of child development. Ensuring consistent health insurance coverage for young children supports early screening, prevention, and timely intervention, all of which are foundational to positive lifelong outcomes.

While ensuring access to health care is a high priority for the early learning system and an important goal for the state, EOEL also notes that the Administration's supplemental budget request includes funding to respond to recent federal changes and preserve existing Medicaid coverage. Once the stability of this, and other essential safety-net programs are ensured, we encourage continued discussion around expanded support for young children.

We appreciate the Legislature's ongoing investment and shared commitment to strengthening Hawai'i's early learning system for our youngest keiki and their 'ohana. Thank you for the opportunity to share these comments regarding S.B. No. 1139.

Aloha Chair Aquino, Vice Chair Shimabukuro, and committee members.

I am Austin Martin, Chair of the Libertarian Party of Hawaii, testifying in opposition to SB 1139 (Relating to Medicaid).

By appropriating additional funds or broadening covered services under Medicaid, SB 1139 accelerates the growth of a program that already consumes a disproportionate share of the state budget while delivering poorer health outcomes than private alternatives in multiple national studies. Taxpayers are forced to finance this expansion under penalty of law, regardless of personal circumstances.

Sustained increases lock in intergenerational debt and reduce incentives for innovative private solutions. I recommend defeating this measure and beginning a phased transition toward voluntary, market-based healthcare arrangements.

AlohaCare appreciates the opportunity to provide testimony in **support of SB1139**. This measure directs the Department of Human Services to adopt rules to expand Medicaid eligibility to all children in the State from birth to age 5 years without regard to household income and appropriates moneys accordingly.

Founded in 1994 by Hawai'i's Community Health Centers and the Queen Emma Clinics, AlohaCare is a community-rooted, non-profit health plan serving over 66,000 Medicaid and Medicaid-Medicare dual-eligible residents on all islands. Approximately 37 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for equitable access to quality, whole-person care for all.

Consistent with our mission and our values, AlohaCare is committed to promoting access to quality, whole-person healthcare for all of Hawai'i's residents. Hawai'i is home to an estimated 97,391 children. Expanding coverage will contribute to our state's health equity and social determinants of health (SDOH) priorities at large by increasing healthcare access.¹ Under the SDOH framework, a person's social and community context are key factors that affect health outcomes. Expanding coverage will allow all keiki ages 5 and under to access primary and preventative care contributing to better life outcomes when keiki are undergoing significant growth and development.

RE SB 1139 Relating to Medicaid - Medicaid Eligibility; Med-QUEST; Children; DHS; Appropriation Position: Support

This measure would direct the Department of Human Services to adopt rules to expand Medicaid eligibility to all children in the State from birth to age 5 years without regard to household income, with appropriations.

Early access to healthcare will improve lifelong outcomes for Hawaii keiki. Continuous access to pediatric preventive care — including early medical and dental visits, as well as treatment for acute illnesses — reduces hospitalization rates and supports healthier school attendance and readiness.

Additionally, early uninterrupted coverage shifts care upstream toward prevention. There is growing evidence that shows that stable access to preventive services lowers costly emergency care, reduces untreated chronic conditions, and improves community health outcomes. This is especially important for infants and toddlers, where early developmental issues are best identified and addressed promptly.

Dear Chair San Buenaventura, Vice Chair McKelvey, and Committee Members,

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in **SUPPORT of SB 1139**, which would adopt rules to expand Medicaid eligibility to all children in Hawai'i from birth through age five without regard to household income.

In late 2024, the U.S. Department of Health and Human Services approved a federal waiver for Hawai'i to adopt multi-year continuous eligibility for children in Medicaid.¹ With this waiver, Hawai'i joined 12 states in expanding Medicaid continuous coverage protections.²

Under this waiver, children enrolled in Medicaid remain covered until their sixth birthday, which means families won't lose coverage due to paperwork delays or temporary income fluctuations — avoiding the detrimental effects of churning in and out of health coverage.

The earliest years of life are a pivotal window for growth and brain development. Children with uninterrupted health coverage are more likely to receive preventive care, have better nutrition and growth outcomes, and enter school ready to learn. This kind of continuity of care improves health outcomes and reduces long-term costs associated with untreated illness.

Ensuring that every child in our state has access to affordable, comprehensive health coverage in early childhood is one of the most effective investments we can make in the long-term health, educational success, and economic stability of Hawai'i's future.
