

- 1 **Fiscal Implications:** Approximately \$32,000 for two additional meetings, excluding staff resources. This measure may impact the priorities identified in the Governor's Executive Budget Request for the Department of Health's (Department's) appropriations and personnel priorities.
- 5 **Department Position:** The Department offers comments.
- 6 **Department Testimony:** The Environmental Management Division, Solid and Hazardous Waste Branch (EMD-SHWB) provides the following testimony on behalf of the Department.
 - 8 This measure requires the Department to hold at least one regular Fuel Tank Advisory Committee (FTAC) meeting during each calendar quarter.
 - 10 In October 2025, a majority of FTAC members voted to continue to hold two meetings per year. In addition to FTAC, information on closure activities is readily available and the Navy continues to hold public outreach activities as the party responsible for closure.

12 The Navy provides updates about Red Hill at other public meetings held by state and
13 federal agencies, such as Department of Land and Natural Resources Commission on Water
14 Resource Management's meetings, the House Special Committee on Red Hill's informational
15 briefs, and EPA webinars. The Department also understands that the Navy regularly attends
16 neighborhood board meetings and hosts open houses and information booths.

17 The Department has observed a steady decrease in public attendance and interest in
18 the FTAC's semiannual meetings after the Red Hill Bulk Fuel Storage Facility was defueled in
19 2024. Prior to the beginning of defueling, approximately 135 members of the public attended
20 the FTAC's June 2023 meeting. Existing efforts at Red Hill now include tank cleaning, pipeline
21 removal, and environmental site assessment. Only 24 members of the public attended the
22 FTAC's October 2025 meeting to receive updates related to these ongoing efforts.

23 While the Department continues to carefully oversee the safe closure of Red Hill, there
24 is only one additional remaining active facility listed in the FTAC's duties provided in Hawai'i

1 Revised Statutes (HRS) Chapter 342L-62. Located on Kaua'i, this facility's field-constructed
2 tanks are not over a drinking water aquifer, and there have been no reported releases. There
3 are also plans to replace these tanks with aboveground storage tanks. Of the FTAC's three
4 remaining locations of study in HRS 342L-62, one location has never had field-constructed
5 tanks, one location closed its tanks and is continuing long-term monitoring, and one location is
6 undergoing tank closure.

7 Given the decrease in activity at these sites within the FTAC's statutory duties, and the
8 length of time environmental site assessments and investigations typically take, this measure
9 may not be necessary at this time. It is unlikely that holding additional meetings at this time
10 would disseminate any significantly new information. The Department also notes that the
11 same staff resources used to plan and coordinate FTAC meetings are also used to oversee the
12 Navy's activities in the field and review environmental data and plans.

Subject: Senate Bill 2093: Relating to the Fuel Tank Advisory Committee

The Honolulu Board of Water Supply (BWS) strongly supports Senate Bill (SB) 2093. This measure proposes to amend Hawaii Revised Statutes (HRS) 342L-62, to require the Fuel Tank Advisory Committee to hold at least one regular meeting during each calendar quarter.

The purpose of the Fuel Tank Advisory Committee is to study issues related to leaks at the Red Hill Bulk Fuel Storage Facility (RHBFSF) among other responsibilities. Given the November 2021 fuel release that contaminated Oahu's sole source aquifer and the Joint Base Pearl Harbor Hickam (JBPHH) water system that affected almost 100,000 people including the release of 1,300 gallons of per- and polyfluoroalkyl substance (PFAS) containing aqueous film forming foam (AFFF) at the RHBFSF, the Committee needs more meetings to discuss and comment on the Navy and regulatory agencies' progress to characterize and remediate this contamination. The Legislature and the Fuel Tank Advisory Committee need to take swift and decisive action to restore our aquifer for future generations to come.

Aloha Chair Gabbard, Chair San Buenaventura, Vice Chair Richards, Vice Chair McKelvey, and Members of the Agriculture and Environment and Health and Human Services Committees,

On behalf of our over 20,000 members and supporters, the Sierra Club of Hawai'i **STRONGLY SUPPORTS SB2093**, which will allow the Fuel Tank Advisory Committee (FTAC) to more fully realize its potential in providing transparency, accountability, and action in the government's response to the ongoing Red Hill water crisis.

With representation from state and federal regulators, elected officials, the military, and the O'ahu community, FTAC has the unique and significant potential to coordinate and accelerate much-needed responses to address the myriad ongoing issues arising from the Red Hill catastrophe. However, this potential has been squandered for years, with the FTAC meeting only once every six months. The infrequency of FTAC's meetings has severely inhibited continuity and follow-through by its members, and effectively prevented the public from raising new and ongoing concerns or otherwise holding FTAC members accountable through timely, real-time questions and discussions with the community.

By requiring FTAC to meet once every three months, this bill would facilitate the multi-jurisdictional coordination and action necessary to address the ongoing and evolving threats of the Red Hill fuel tanks' contamination of our precious 'āina and wai – including through the increased public transparency, communication, and accountability provided by more frequent FTAC meetings.

To be clear: the situation with Red Hill is far from over. Our sole-source aquifer continues to be contaminated; incomplete groundwater flow models and water testing data indicate the potential for the contamination plume to threaten additional water sources; and we have not seen any specific proposal to remediate this plume, if and when it is located. Accordingly, we need to ensure much more proactive and comprehensive responses from the various agencies and entities responsible for dealing with this clear threat to the water security of our present and future generations. This measure provides one critical means of doing so.

Accordingly, the Sierra Club of Hawai'i respectfully but strongly urges the Committees to **PASS** this measure. Mahalo nui for the opportunity to testify.

We are the alaka‘i of ‘Ahahui o Hawai‘i (“the Hui”), an organization of law student advocates at the William S. Richardson School of Law. For over 50 years, the Hui has advocated for Native Hawaiian justice in all areas of law, especially those affecting Native Hawaiian communities, traditional and customary practices, resource management, and environmental protection.

We STRONGLY SUPPORT SB2093 ,which will help the Fuel Tank Advisory Committee realize its potential in navigating the Red Hill water crisis through greater public transparency and accountability.

With government regulators, state and federal elected officials, Navy leaders, and community representatives, the Fuel Tank Advisory Committee has tremendous potential to identify and address the many issues and community concerns surrounding the Red Hill water crisis.

Protecting our water is a core public trust obligation of the State and is essential to safeguarding the health, culture, and future of Hawai‘i’s people, particularly Native Hawaiians for whom wai is sacred.

However, by meeting only twice a year, FTAC’s potential has been severely limited. Infrequent, hours-long meetings do not allow for timely updates, meaningful discussion, or adequate opportunities for public testimony and questions, especially during an ongoing and evolving crisis.

By requiring FTAC to meet at least once per quarter, this bill will ensure more consistent oversight, transparency, public access, and accountability in the government’s response to the Red Hill water crisis, and will better align that response with the State’s duty to protect water for current and future generations.



Aloha Chair San Buenaventura, Chair Gabbard, Vice Chair McKelvey, Vice Chair Richards, and members of the committees:

The Association of Hawaiian Civic Clubs submits testimony in **STRONG SUPPORT** of SB2093 Relating to the Fuel Tank Advisory Committee (FTAC), which would require the FTAC to meet at least one time per calendar quarter.

The mission of the Association of Hawaiian Civic Clubs is to effectively advocate for the educational, civic, health, cultural, economic, and social well-being of our lāhui. We have advocated for the expedient and full remediation of the Red Hill Fuel Facility for many years, including the adoption of Association Resolution 2024-61 URGING THE UNITED STATES DEPARTMENT OF THE NAVY AND THE UNITED STATES DEPARTMENT OF DEFENSE TO IMMEDIATELY IMPLEMENT WEEKLY THIRD-PARTY TESTING OF ALL NAVY MONITORING WELLS AND DRINKING WATER WELLS FOR CHEMICAL CONTAMINANTS ASSOCIATED WITH THE NAVY'S BULK FUEL STORAGE FACILITY AT KAPŪKAKĪ (RED HILL) AND TAKE REMEDIATION ACTION IF NECESSARY. To date, the Navy has not adequately addressed the concerns raised by the Association and the adverse impacts to O'ahu from the 2021 fuel spill continue.

By meeting one time per calendar quarter, the FTAC will be enabled to listen to public input, and provide updates on all matters relating to the environmental impacts relating to the U.S. Army, Navy, Air Force fuel tanks in a more timely manner. The current schedule of meeting two times

per year does not adequately address our concerns and all public concerns over the health of our wai and delicate island ecosystem related to current and potential future fuel tank leaks. More timely information exchange will allow for more timely environmental responses.

Founded by Prince Kūhiō in 1918, the Hawaiian Civic Club movement is the oldest Native Hawaiian community-based advocacy movement. The Association of Hawaiian Civic Clubs is a not-for-profit organization that is a confederation of 61 individual and autonomous Hawaiian Civic Clubs and 3,000 members located across Hawai‘i and across the continental United States.

We appreciate your favorable consideration of this measure.

Aloha Chairs Gabbard and San Buenaventura, Vice Chairs Richards and Mckelvey and members of the committees:

Ke One O Kākuhihewa, the O‘ahu Council of the Association of Hawaiian Civic Clubs, respectfully submits this testimony in strong support of SB2093, which would require the Fuel Tank Advisory Committee to convene at least once each calendar quarter.

Our council represents the collective voices of Hawaiian Civic Clubs across O‘ahu. These clubs are rooted in their communities and grounded in a shared responsibility to protect the health, safety, and future of our people and our ‘āina. Few issues have affected O‘ahu as deeply or as personally as the Red Hill fuel contamination and the ongoing risks posed by military fuel storage facilities across the island.

For many years, Hawaiian Civic Clubs have raised concerns about fuel storage, water safety, and the long-term impacts on our wai and public health. Those concerns intensified after the 2021 Red Hill fuel spill, yet the pace of information-sharing, accountability, and visible progress has not met the urgency of the harm experienced by O‘ahu communities. Families are still seeking clarity, reassurance, and confidence that their drinking water is safe—now and into the future.

Requiring the Fuel Tank Advisory Committee to meet quarterly is a practical and necessary step. More frequent meetings create regular opportunities for public input, timely updates from agencies, and transparent discussion about environmental monitoring, remediation efforts, and risk mitigation. Meeting only twice a year is not sufficient given the scale of the issue or the level of public concern. Ongoing oversight and consistent communication are essential to restoring trust and ensuring that emerging issues are addressed before they become crises.

Ke One O Kākuhihewa supports SB2093 because it strengthens accountability and improves the flow of information between decision-makers and the communities most affected. Regular meetings will help ensure that environmental and public health concerns related to fuel storage on O‘ahu are not sidelined or delayed.

TESTIMONY IN STRONG SUPPORT OF SB2093: RELATING TO THE FUEL TANK ADVISORY COMMITTEE.

Aloha Chairs Gabbard and San Buenaventura, Vice Chairs Richards and Aquino, and Members of the Committees,

The Environmental Caucus of the Democratic Party of Hawai'i strongly supports SB 2093, which requires the Fuel Tank Advisory Committee (FTAC) to meet once per quarter rather than only twice per year. This simple but essential change strengthens public oversight, transparency, and accountability in the State's response to the ongoing Red Hill water crisis.

Why Quarterly Meetings Are Necessary

The Fuel Tank Advisory Committee was established to study and monitor issues related to leaks from field-constructed underground fuel storage tanks at Red Hill, Kuahua Peninsula, Barking Sands, Hickam, and Schofield. These facilities have a long history of contamination events, including the catastrophic Red Hill jet fuel releases that displaced thousands of residents and threatened O'ahu's sole-source aquifer.

Given the scale, complexity, and long-term nature of the Red Hill crisis, semiannual meetings are insufficient. Critical developments occur monthly—sometimes weekly—including groundwater monitoring results, remediation progress, health updates, and interagency coordination challenges. Quarterly meetings ensure that the public, the Legislature, and affected communities receive timely information and have meaningful opportunities to engage.

Strengthening Transparency and Public Trust

SB2093 enhances transparency by ensuring:

- More frequent public updates on groundwater data, health monitoring, and remediation progress
- Regular opportunities for community members to ask questions and raise concerns
- Improved coordination among the Navy, Department of Health, Board of Water Supply, and other agencies
- Greater accountability for commitments made under state and federal agreements

In the aftermath of the Red Hill disaster, rebuilding public trust requires consistent, predictable, and open communication. Quarterly FTAC meetings are a minimum standard for responsible governance.

Supporting Effective Oversight

The bill also appropriates funds to support the committee's expanded meeting schedule, including the option to contract with a third-party administrator. This is a prudent investment that strengthens the State's capacity to monitor complex technical, environmental, and public-health issues over the long term.

Conclusion

SB2093 is a practical, community-centered measure that improves oversight, transparency, and responsiveness in Hawai'i's management of fuel tank risks. The Environmental Caucus of the Democratic Party of Hawai'i urges the Committees to pass SB2093.

Well over four years after the November 2021 Red Hill fuel spill, and nearly three years after the Red Hill Water Alliance Initiative called for the complete clean up of this contamination, the Navy has failed to make any meaningful efforts to remediate our island's sole source aquifer. After having ignored years of public outcry, whistleblower complaints, and basic common sense prior to the 2021 catastrophe, the Navy must not be allowed to now ignore the harms it has inflicted on our 'āina and wai.

This bill would establish an enforceable legal standard that will also be binding on the federal government: there should be NO jet fuel in our precious and once-pure drinking water or in our environment, especially when it has been released by the reckless operation of a decrepit underground storage tank facility after years of objections by Hawai'i's residents.
