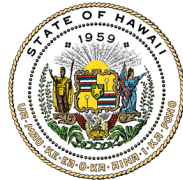

**SENATE BILL NO. 2126  
RELATING TO AGRICULTURAL GRANTS**

Chair Gabbard, Vice Chair Richards and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 2126 that establishes the Conventional Farming Grant Program to be administered by the Department of Agriculture and Biosecurity to provide grants to small and midsize farmers who practice conventional farming and appropriate funds. The Department supports the intent of the bill and offers comments.

Providing grant funding to small and midsize farms that utilize conventional farming methods supports the Department's mandate to increase food production, decrease imports, and move Hawaii toward food sustainability. The Department's comments relate to the intent and management of the grant program.

The bill is unclear as to the purpose of the grant program, grant amount limits, permitted uses of grant funds and any reporting requirements for the program. As currently drafted, an applicant would not be limited to the amount of grant funding and would not need to specify how grant funds would be expended. Providing grant limits would make the program more equitable and having permitted uses for grant funds will help provide direction to the Board of Agriculture and Biosecurity.

Supporting farmers who utilize conventional farming practices will acknowledge that they are often not able to participate in other programs, however, are currently responsible for the vast majority agricultural production in the state.

Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports SB 2126**, which establishes the Conventional Farming Grant Program within the Department of Agriculture and Biosecurity to provide grants to small and mid-sized farmers who predominately practice conventional farming.

HFB represents farmers, ranchers, and agricultural producers across the State and is committed to supporting all sectors of agriculture. Conventional farming plays a vital role in ensuring food security, sustaining rural economies, and strengthening Hawai'i's overall agricultural capacity.

Small and mid-sized farmers are the backbone of Hawai'i's agricultural industry. However, they face significant challenges, including high input costs, labor shortages, rising energy and transportation expenses, and limited access to capital. SB 2126 will provide targeted financial support to help alleviate these pressures, allowing farmers to invest in productivity, efficiency, and long-term viability.

Conventional farming remains one of the most efficient and reliable ways to produce large quantities of food to meet the needs of Hawai'i's communities. These operations are essential to maintaining a stable and diverse local food supply, particularly as Hawai'i works to reduce reliance on imported food and strengthen food self-sufficiency.

Agriculture is a critical contributor to Hawai'i's economy, supporting jobs, rural communities, and local supply chains. By providing grants to small and mid-sized conventional farms, this program will stimulate economic activity, encourage continued

agricultural use of land, and support the State's broader goals of increasing local food production.

SB 2126 is an important step toward recognizing and supporting the contributions of conventional farming to Hawai'i's food system, economy, and rural communities. We respectfully urge the committee to pass this measure and provide the necessary resources to help Hawai'i's farmers continue to feed our state.

Aloha Chair Gabbard, Vice Chair Richards, and Members of the Senate Agriculture and Environment Committee,

The Hawai'i Farmers Union is a 501(c)(5) agricultural advocacy nonprofit representing a network of over 2,500 family farmers and their supporters across the Hawaiian Islands. **HFU offers comments on SB2126.**

HFU recognizes the myriad hardships faced by agricultural producers across the state. However, this bill currently lacks a preamble or findings section clarifying the challenges it seeks to address through the Conventional Farming Grant Program. Without a stated purpose, it is unclear how this grant program aligns with broader state objectives for agriculture, sustainability, or climate resilience.

The bill's exclusion of farms using organic seeds or practices is especially concerning. By defining "conventional farming" in a way that omits producers committed to organic or regenerative methods, the measure risks marginalizing those who are advancing the very environmental protections enshrined in Article XI of the Hawaii State Constitution and the state's commitments under the Aloha+ Challenge.

## Recommended Amendments:

### Inclusivity for Organic and Sustainable Farmers

HFU supports diverse farming practices that contribute to ecological resilience, food security, and community well-being. We recommend expanding grant eligibility to include farms using sustainable, organic, or regenerative methods. This would align the program with Hawaii's constitutional environmental mandates and state-level climate and sustainability goals.

### Clarify Grant Use Parameters

To ensure funds meet real and measurable agricultural needs, the bill should specify allowable uses of grant funds. Examples may include:

- Infrastructure and irrigation improvements
- Equipment upgrades
- Soil health and nutrient management practices
- Adoption of climate-smart or water-conserving techniques

This clarity would help prevent misuse and improve accountability and impact assessment.

HFU encourages amendments that reflect a more inclusive and environmentally responsible vision for Hawaii's agricultural future.



SENATE BILL 2126 – RELATING TO AGRICULTURAL GRANTS

Position: Support Intent; seek clarification of Senate's understanding.

Me ke Aloha, Chair Gabbard and Members of the Committee on Agriculture and Environment:

SB2098 establishes a grant program for farmers who practice conventional farming. The definition clarifies that this will include those not certified as organic, but also excludes those genetically altered through biotechnology.

Because Hawaii is deep in food insecurity, it is essential that we, the people, support local agricultural food production to the greatest possible extent. This includes products that are available in harvested form or in value-added form, and may include some that can earn a premium as an export to help the bottom line.

Both small- and medium-sized agricultural operations have endless challenges to earn a living, so it is essential that grant-making also be supported by application assistance. It is also worth determining whether a multitude of grant programs require additional staff.

## Comments:

I **strongly oppose** this measure. This bill defines "conventional farming" as "growing crops from seeds that have been genetically altered using any traditional breeding method, excluding biotechnology, and that are not certified as organic."

As Hawaii has experienced "conventional farming" it also includes tilling plastic weed mat and irrigation tubing into the aina, and using chemical fertilizers, herbicides, and pesticides that impoverish our soils and cause erosion and polluted runoff to our streams and reefs.

I do not support my tax dollars going to pay for hybrid/genetically altered seed (I note that "traditional methods" have not been defined in this bill) or continuing the environmentally unsound agriculture practices and inputs of "conventional agriculture".

If someone wants to continue with those kinds of practices - pay for it yourselves! If you want to use genetically altered seed - let the industry pay for it. We're already paying the price for cleaning up 150 years of conventional agriculture mess on the land and on our reefs. And, many families have paid a steep price with their health for living near such farms, particularly those of the seed industry. We haven't forgotten. Haven't we learned our lesson by now? A'ole SB2126.

If this bill was for a grant program that helped conventional farmers transition to regenerative agriculture, then you might have my attention and support.

## Comments:

This bill would provide grants for "conventional farming," which it defines as "growing crops from seeds that have been genetically altered using any traditional breeding method, excluding biotechnology, and that are not certified as organic. This definition is both too broad and too narrow.

The State should not be making grants for genetically altered seed farming instead of encouraging additional certified organic farming.
