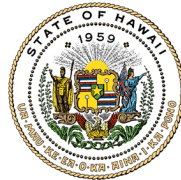

Chair Gabbard, Vice Chair Richards and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill 2154. The bill provides funds for the Department of Agriculture and Biosecurity to conduct a study of agricultural markets for Hawai'i farmers and establishes positions to conduct and collect relevant agricultural data. The bill includes an appropriation.

The Department of Agriculture and Biosecurity strongly supports this measure. Knowledge of agricultural markets both locally and abroad will help Hawai'i farmers make strategic decisions for their operations and increase the likelihood of success. Modern agriculture is a highly competitive business and is especially challenging in Hawai'i with high land and input costs, lack of timely production and market information and data makes strategic planning and production adjustments difficult. In addition, having staff that are experienced and knowledgeable about Hawaiian agriculture is key to interpreting and understanding data that is collected.

If the state is going to reach its goal of doubling local food production and increase its food self-sufficiency greater support will need to be provided to Hawai'i farmers and ranchers. This bill is a great step forward in that direction by providing key data and information that allows producers to make informed and timely decisions for their operations. The department will be able to hire additional permanent staffing that will be able to assist the industry over the long term.

Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

**The Hawai'i Farm Bureau supports SB 2154**, which requires the Department of Agriculture and Biosecurity to conduct a study of agricultural markets for Hawai'i farmers, appropriates funds for a one-year agricultural markets study, and establishes and funds two full-time equivalent (2.0 FTE) positions to collect agricultural data and conduct data analysis for public consumption.

Hawai'i's farmers and ranchers face unique challenges, including high production costs, limited market access, and competition from imported goods. A comprehensive study of agricultural markets will provide valuable insights into consumer demand, market opportunities, and supply chain inefficiencies, helping farmers and ranchers make informed business decisions.

Identifying viable markets for Hawai'i-grown products is critical to strengthening local agriculture, promoting food security, and reducing reliance on imported food. Market research will empower farmers to diversify crops, target new markets, and better align production with consumer preferences. By strengthening agricultural markets, this study supports Hawai'i's broader goals of sustainability, self-sufficiency, and rural economic development.

Accurate and timely agricultural data is essential for effective decision-making by farmers, policymakers, and industry stakeholders. The lack of localized, accessible agricultural data continues to create barriers to understanding industry trends and making evidence-based policy and business decisions.

SB 2154 represents a strategic investment in the future of Hawai'i's agricultural industry. By supporting an agricultural markets study, funding dedicated positions for data collection and analysis, and requiring reporting to the Legislature, this measure will provide essential tools to help farmers succeed in an increasingly competitive marketplace.

The Hawai'i Farm Bureau urges the committee to pass SB 2154 and stands ready to collaborate on its implementation for the benefit of Hawai'i's farmers and agricultural community.

Chair Gabbard, Vice Chair Richards, and Members of the Committee,

The Hawaii Cattlemen's Council **supports SB2154** which requires the Department of Agriculture and Biosecurity to conduct a study of agricultural markets for Hawai'i farmers. It appropriates funds for a one-year study of agricultural markets for Hawaii farmers and establishes two full-time equivalent positions.

Concrete data allows us to understand trends and identify where opportunities for markets are. However, the state has very little data on agriculture. This bill places an emphasis on the value of collecting this data and allowing it to be shared publicly for producers to strategize their operations for optimization. Investing in high-quality data and establishing access to this data can lead to growing the agricultural sector as a whole, while minimizing risk for producers.

We appreciate the opportunity to testify on this measure. The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Ranchers produce a high-quality protein and are the stewards of almost 750 thousand acres of land in Hawaii, or nearly 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.



**Re: Testimony in Support of SB2154 Relating to Agriculture, on Agricultural Statistics**

On behalf of Agriculture Stewardship Hawai'i, we write in support of SB2154, which establishes an agricultural markets study, authorizes positions, and appropriates funds to rebuild critical agricultural statistics capacity.

Agriculture Stewardship Hawai'i is a nonprofit organization dedicated to improving the viability and sustainability of Hawai'i's farmers and ranchers through technical assistance, resource coordination, business education, and policy support. In our day-to-day work with producers across the state, **we consistently hear a clear and urgent need for better, more accessible agricultural market data.** Farmers and ranchers need timely, reliable information to understand market conditions, assess risk, plan production, and make informed business decisions.

**For many producers, the lack of localized, Hawai'i-specific data is a significant barrier to success.** This challenge has grown over time as agricultural data collection capacity declined following the 2008 financial crisis. More recently, federal funding reductions to the USDA National Agricultural Statistics Service (NASS) have further eroded the availability of the data our agricultural community relies on. The result is a widening information gap at a time when farmers are facing unprecedented volatility in input costs, climate impacts, and market access.

SB2154 directly responds to this need by investing in the restoration and strengthening of agricultural market analysis and reporting capacity in Hawai'i. **Accurate, consistent agricultural data is foundational infrastructure for a healthy food system.** It supports farmers, informs policymakers, strengthens investment decisions, and ultimately contributes to food security and economic stability across the state. We believe this bill is a practical and necessary step toward supporting Hawai'i's agricultural sector in a changing and uncertain environment.
