Thank you for the opportunity to testify on this bill. The Campaign Spending Commission (“Commission”) supports the intent of this bill and provides the following comments.

This bill establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices to beginning with the 2028 general election year, appropriates funds to the Hawaii Election Campaign Fund, and appropriates funds to the Commission. This public financing program is modeled after the pilot Hawaii County Council Comprehensive Public Funding Project<sup>1</sup> that ran in 2010 and 2012.

The bill establishes the maximum amount of comprehensive public funds (“CPF Max”) for each office as well as the minimum qualifying \$5 contributions (“\$5 MQC”) that must be raised for each office. The following table shows the \$5 MQC and CPF Max for each office:

If one candidate for each office qualified and received the CPF Max in the 2028 election period, this program will pay out **\$15,110,000** in public financing to the qualified candidates. In contrast, if one candidate for each office qualified to receive partial public funding in the 2026 elections, the state will pay a maximum of **\$2,948,612** in public financing. Under §11-O of the proposed new subpart to Part XIII of Chapter 11, Hawaii Revised Statutes, there must be a minimum of \$30,000,000 in the Hawaii Election Campaign Fund on September 1, 2027, in order for the Commission to run the comprehensive public financing program established by the bill.

The Commission notes this bill includes \$30,200,000 in general fund appropriation to the Hawaii Election Campaign Fund which is necessary to implement the new comprehensive public financing program. The Commission appreciates the appropriation of \$200,000 in this and the next fiscal years from the Hawaii Election Campaign Fund in Section 7 of the bill for the Commission to hire two full-time equivalent (2.0 FTE) permanent positions to prepare for comprehensive public financing in the 2028 elections. Currently, the Commission has 5 staff and is in the process of hiring an investigator and elections assistant due to the increase in candidates, candidate committees, and noncandidate committees which require hundreds of staff hours to assist with over the phone, in person, and by email. In contrast to Hawaii County Council Comprehensive Public Funding Project for which this program is modeled, this bill addresses all elected offices, and therefore, the scope and magnitude of providing at least four trainings set forth in Section 11-N will be significant especially in consideration of the penalties set forth in Section 11-M. This further underscore the importance of increasing staff at the Commission.

The balance in the Hawaii Election Campaign Fund is \$2,412,282.94 as of June 30, 2025. This amount is insufficient to pay for the comprehensive public funding program, including the additional personnel the Commission will need, and thus, the total appropriation of \$30,200,000 in Section 6 of the bill is necessary.

The Commission recommends amending page 4, lines 7-8 to read “a comprehensive public funding program” so the term is consistent throughout the bill.

The Commission respectfully requests that this Committee pass this bill as amended.

Chair Rhoads, Vice Chair Gabbard, and Committee Members:

The League of Women Voters of Hawaii thanks the Committee Chairs and members for hearing this valuable and popular bill.

**The League of Women Voters of Hawaii strongly supports SB2313 which: Establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State, to begin with the 2028 general election year. Requires the Campaign Spending Commission to submit reports to the Legislature. Appropriates funds. We also offer comments.**

The League of Women Voters of the United States believes that methods of financing political campaigns should enhance political equality for all citizens; protect representative democracy from being distorted by big spending in election campaigns; ensure the public's right to know who is using money to influence elections; enable candidates to compete equitably for public office; ensure that candidates have sufficient funds to communicate their messages to the public; and combat corruption and undue influence in government.

Delegates and voters in the 1978 Constitutional Convention in Hawaii realized the importance of this concept, resulting in the creation of the Hawaii Election Campaign Fund and Hawaii's partial public funding option. Below is a quote from the Convention during the discussion of the HECF: ". . . if we think these tremendous sums being spent [on elections], these tremendous sums being contributed, are not sums for which we are

going to ultimately pay because of poor government . . . and because of undue influence . . . we are fooling ourselves." Delegate Naomi Campbell during the 1978 Constitutional Convention.

**Public financing of campaigns for political office is an investment in good governance**, like budgeting for the Office of Elections or the Campaign Spending Commission or the Legislature itself. (See the recommendations of the Commission to Improve Standards of Conduct). Public Financing can return the value invested in it by increasing the extent to which elected officials work for the benefit of all state residents, rather than wealthy businesses or individuals; increasing voter confidence in government; and encouraging more citizen participation in elections and communication with their representatives.

The cost of this investment in good governance would not be a major portion of the state budget. The writers of this bill, as well as the Campaign Spending Commission (CSC), calculate that to pay for the comprehensive public funding program, even including personnel the CSC would need for implementation, would require an appropriation of \$30,200,000.

It is also probable that legislative spending and state contracts would be more effective and efficient when directed by the needs and values of the population, rather than being swayed by financial relationships with special interests.

Aloha Chair, Vice Chair, and Members of the Senate Judiciary Committee;

The Kalihi Palama Hawaiian Civic Club submits this testimony in support of the intent of SB 2313 and respectfully offers targeted amendments to address a remaining parity issue affecting elections for the Office of Hawaiian Affairs (OHA).

**PURPOSE AND LEGAL CONTEXT**

SB 2313 establishes a voluntary public financing framework intended to promote fairness, transparency, and equal access across Hawai‘i’s electoral system. The inclusion of OHA trustee elections within this framework is appropriate and consistent with the statewide nature of those elections.

However, from a statutory parity and equal-treatment perspective, the bill as currently drafted applies a funding and qualification structure to OHA elections that is not fully aligned with how those elections function in practice or how comparable offices are treated under the same bill.

**STATEWIDE STATUS AND PARTICIPATION REALITIES OF OHA ELECTIONS**

Certified statewide election results from the 2025 General Election demonstrate that Office of Hawaiian Affairs elections are statewide ballot contests.

We recognize that between 37.5% and 45.4% of voters who returned a ballot left OHA races blank, resulting in an effective participating electorate of approximately 55%–62% of statewide voters.

This participation pattern is significantly different from that of State House and State Senate races, where blank-vote rates are substantially lower.

Importantly, however, even accounting for this differential participation, the number of voters who actively participate in OHA elections remains substantially larger than the electorate of any single legislative district.

From a legal and structural standpoint, OHA elections therefore occupy a hybrid position as they are statewide in administration and ballot access, but are decided by a distinct, self-selecting electorate.

### **PARITY CONCERNS UNDER SB 2313**

Under SB 2313 as drafted:

- Candidates for the State House of Representatives may receive up to \$50,000 in public financing.
- Candidates for the Office of Hawaiian Affairs are capped at \$40,000.
- Qualifying contribution and certification provisions rely on a district-based framework that does not clearly correspond to the statewide electorate that determines OHA elections.

This structure raises parity concerns because:

1. OHA elections are administered statewide and require statewide compliance, reporting, and ballot placement;
2. OHA candidates must communicate across multiple islands and jurisdictions;
3. The effective participating electorate for OHA elections is larger than that of legislative districts;
4. OHA candidates are afforded less public financing support than State House candidates.

From a Judiciary perspective, this raises questions of internal consistency within the statutory scheme, rather than questions of policy preference.

### **SUGGESTED AMENDMENTS TO ADDRESS PARITY**

To better align SB 2313 with principles of equal treatment and rational classification, the Kalihi Palama Hawaiian Civic Club respectfully suggests the following amendments:

- **Public Financing Cap Adjustment**
  - Amend the bill to provide that public financing for OHA trustee candidates shall be no less than the amount provided for State House candidates, recognizing the statewide scope and larger effective electorate of OHA elections.
- **Clarification of Qualifying Contribution Electorate**
  - Clarify that, for purposes of qualifying contributions and certification, the relevant electorate for OHA candidates is **statewide registered voters**, notwithstanding trustee residency requirements.
- **Retention of Reasonable Qualification Thresholds**
  - Maintain modest qualification thresholds for OHA candidates to ensure accessibility for community-based Native Hawaiian candidates while preserving program integrity.

These amendments are narrowly tailored and do not seek to elevate OHA elections to the funding level of gubernatorial or other executive offices.

SB 2313 represents a meaningful advancement in Hawai‘i’s public financing framework. With modest amendments to address parity for OHA elections, the bill can better reflect consistent statutory treatment of similarly situated offices, grounded in actual voter participation and election administration realities.

The Kalihi Palama Hawaiian Civic Club respectfully urges the Committee to move SB 2313 forward with amendments that align OHA public financing provisions with principles of fairness, consistency, and proportionality.

On behalf of Indivisible Hawai'i, thank you for this opportunity to testify in strong support of SB2313.



*Dear Chair and Members of the Committee,*

*I am writing in strong support of Senate Bill 2313, which would strengthen Hawaii's public campaign financing system and help reduce the influence of money in our elections.*

*Hawai'i's political system is broken. The heavy reliance on campaign contributions from wealthy donors and special interests has led to a system where 2 in 3 people believe elected officials are more focused on the interests of their donors than the needs of their communities. As a result, good policies are often blocked while harmful ones move forward. This dynamic erodes public trust and encourages corruption. SB 51 is a critical step toward fixing this broken system by allowing candidates to run competitive campaigns without being dependent on special interest money.*

*By providing full public financing for qualified candidates, SB 2313 will break the link between private money and electoral success. This will create a fairer and more honest system where elected officials are accountable to their constituents rather than big donors. Importantly, similar programs in other states show that public financing does not lead to higher incumbent turnover or drastic shifts in political makeup, but it does change who holds influence in government—ensuring that everyday people, not just the wealthy few, have a voice.*

*Public financing is both popular and cost-effective. Three out of four voters support a clean elections program. States like Connecticut and Maine have successfully run similar programs for decades, and Hawai'i County piloted a version in 2010 and 2012. Even if Hawai'i saw higher participation rates than any other state, estimates show the cost would be less than \$10 million per year—just 0.05% of the state budget. That's under \$7 per resident or less than \$1 per tourist—a small price to pay for a more transparent, accountable government.*

*For these reasons, I urge you to pass SB 2313. This bill will restore trust in our democracy, empower candidates to focus on their communities rather than fundraising, and ensure that our government truly serves the people of Hawai'i.*
