**SB2355**  
**RELATING TO VEHICLE SAFETY**

Senate Committee on Transportation

---

The Department of Transportation (DOT) submits comments on Senate Bill 2355, relating to mobile vehicle safety inspections.

This bill proposes to amend Hawaii Revised Statutes § 286-209 to require the Director of Transportation to adopt rules allowing for mobile motor carrier vehicle safety inspections at locations determined by the vehicle owner and inspector.

The DOT recognizes the potential benefits of mobile vehicle safety inspections in terms of convenience for vehicle owners and potentially increasing compliance with safety inspection requirements. However, we have several concerns and considerations regarding the implementation of such a program:

1. **Quality Control:** Ensuring consistent inspection quality and adherence to safety standards across various mobile inspection locations may be challenging. The current centralized inspection stations allow for better oversight and standardization of inspection procedures.
2. **Equipment and Technology:** Mobile inspections would require inspectors to have portable equipment capable of performing all necessary safety checks. This may increase costs and potentially limit the thoroughness of inspections.
3. **Inspector Safety:** Conducting inspections at various locations may pose safety risks to inspectors, especially in areas with limited space or high traffic.
4. **Environmental Concerns:** Mobile inspections may not have access to proper facilities for handling hazardous materials or emissions testing equipment, potentially compromising environmental standards.
5. **Costs:** The implementation of a mobile inspection program, including equipment, training, and logistics, may result in increased costs that could be passed on to consumers.

6. Fraud Prevention: A decentralized inspection system may be more susceptible to fraudulent activities. Additional measures need to be implemented to ensure the integrity of the inspection process.

While the DOT is open to exploring innovative approaches to commercial vehicle safety inspections, we believe that careful consideration and further study are necessary before implementing a mobile inspection program. We would recommend conducting a pilot program to assess the feasibility, effectiveness, and potential challenges of mobile inspections before full-scale implementation.

The DOT is committed to maintaining the highest standards of vehicle safety while also seeking ways to improve convenience for Hawaii's motorists. We look forward to working with the legislature to explore this concept further and ensure that any changes to the inspection system prioritize both safety and efficiency.

My name is Nicolas Wong and my testimony is in support of SB2355 to allow for mobile vehicle inspections.

The current rules only allow for safety inspections to be performed at a licensed site. This rule is outdated and all information is through a tablet and program licensed by the state. Furthermore vehicles are not needed to be lifted on a car lift or driven to be inspected.

I personally have experienced multiple instances where I have made an appointment to have a safety inspection performed, only to be told the inspector is on lunch or there is no inspector today come back later, or come back next week etc. By allowing mobile safety inspections companies would be allowed to focus on safety inspections and provide this service to people their offices, warehouses, workplaces etc. and help alleviate the issue of safety inspections.

Allowing of mobile safety inspections does not negatively impact car repair facilities as most facilities view it as a burden on their mechanics. A mechanic would make far more money by fixing a vehicle instead of doing a safety inspection.
