Comments:

My name is **Kainoa Kaku**, President of the **Hawai‘i Rifle Association**, and I respectfully submit testimony **in opposition to SB 2720**.

SB 2720 proposes to establish a Hawai‘i Firearm Injury Restitution Fund, funded through mandatory licensing and contribution requirements imposed on firearm manufacturers as a condition of market participation. While framed as a no-fault, public health financing mechanism, this bill effectively **reassigns public health costs to a single, lawful industry regardless of fault, conduct, or causation**.

Firearm injuries arise from a wide range of circumstances, including criminal acts, suicide, accidents, and misuse by third parties. SB 2720 explicitly acknowledges that manufacturers would bear financial responsibility without any finding of wrongdoing, while simultaneously asserting that the program is not punitive. In practice, this is a cost-shifting scheme that treats lawful commerce as a proxy for liability.

The bill grants broad rulemaking authority to the Department of Health to create “risk categories” based on product characteristics and aggregated injury data. This approach relies on generalized public health data rather than individual conduct and allows administrative agencies to assign financial burdens without clear statutory limits or legislative oversight. That is not transparency or fairness. It is regulatory uncertainty.

Although the bill states that it does not regulate firearm ownership or impose civil liability, its real-world effect will be to **increase costs, restrict availability, and reduce consumer choice** for lawful firearm owners in Hawai‘i. These costs will not remain with manufacturers. They will be passed on to local retailers and law-abiding residents who already comply with one of the most heavily regulated firearm systems in the nation.

Public health costs are a shared societal responsibility. Singling out one constitutionally protected industry to subsidize broad public expenditures sets a troubling precedent. If lawful products can be financially penalized based on third-party misuse, there is no principled limiting line.

Hawai‘i already has mechanisms to compensate victims of crime and to address violence directly. SB 2720 does not target criminal behavior, improve enforcement, or enhance

prevention. Instead, it creates a new administrative structure that expands government control while offering no clear evidence of improved public safety outcomes.

For these reasons, the **Hawai‘i Rifle Association respectfully urges this Committee to reject SB 2720.**

I submit this testimony in opposition to SB2720.

This bill imposes a requirement on a single, lawful industry that is not applied to any other business operating in Hawai‘i. There is no precedent for the State requiring a lawful manufacturer or seller to establish or contribute to a special fund as a condition of doing business. For example, automobile manufacturers are not required to provide or finance a fund for car crashes or traffic fatalities in order to operate in Hawai‘i. Singling out one industry in this manner is inequitable and sets a troubling policy precedent.

SB2720 effectively assigns collective financial liability to lawful businesses for the criminal misuse of their products by third parties. This approach undermines basic principles of fairness and responsibility, and it does nothing to directly address criminal behavior or improve public safety.

Additionally, there is significant concern that any such fund would not be preserved for its stated purpose over time. I am writing to strongly oppose SB2720, which would establish the Hawai‘i Firearm Injury Restitution Fund by requiring firearm manufacturers to obtain licenses and pay fees as a condition of market participation in Hawaii, with those funds covering no-fault medical and related costs for firearm injuries. While addressing the costs of firearm injuries is a valid public health concern, this approach is flawed, likely ineffective, and imposes unfair burdens. Key concerns include:

1. **Impractical and ineffective funding mechanism:** Hawaii has a very small firearm market compared to the mainland. Few (if any) major manufacturers sell directly here or would find it economically viable to obtain a special license and pay fees just for our tiny share of the national market. This could lead manufacturers to simply exit the Hawaii market entirely, reducing lawful access to firearms and ammunition for residents without meaningfully funding the proposed restitution fund.
2. **Unfair targeting of manufacturers:** Firearm injuries stem from a wide range of causes—criminal acts, accidents, suicides, lawful self-defense, etc. Shifting costs exclusively to manufacturers (who have no control over misuse after sale) is arbitrary and punitive. It resembles failed attempts elsewhere to regulate firearms through litigation or fees, many of which have been struck down or proven unworkable.
3. **Constitutional and legal issues:** Imposing licensing and fee requirements as a condition of "market participation" raises serious interstate commerce concerns (U.S. Constitution Article I, Section 8) and could burden Second Amendment rights (post-Bruen scrutiny for regulations that indirectly restrict access). It also risks duplicating or conflicting with federal firearms regulations.
4. **Better alternatives exist:** If the goal is to cover injury costs, improve enforcement against illegal firearms/trafficking, invest in mental health/suicide prevention, or promote safe storage **education.** These target root causes more directly without creating new bureaucratic funds or driving lawful commerce away.

I urge the committees to reject SB2720. It is unlikely to generate significant revenue, could harm lawful firearm owners and dealers in Hawaii, and diverts focus from evidence-based violence prevention. Mahalo for considering my testimony. I respectfully request that this bill be defeated.

Chair, Vice Chair, and Members of the Committee:

I submit this testimony in strong opposition to SB2720. While the bill is presented as a public safety measure, it establishes a new **Hawaii Firearm Injury Restitution Fund** that fundamentally shifts legal responsibility for firearm injuries onto manufacturers in a manner inconsistent with constitutional and statutory law.

SB2720 would impose a requirement that firearm manufacturers obtain a license and contribute to a Firearm Injury Restitution Fund as a condition of market participation, creating a form of strict liability payment obligation for all firearm injuries regardless of causation, fault, or illegal use.

This structure departs from established principles of tort law and constitutional protections. Under U.S. Supreme Court jurisprudence, the Due Process Clauses of the Fifth and Fourteenth Amendments require that liability be tied to fault or culpable conduct. In *Texaco Inc. v. Dagher*, the Court reaffirmed that statutory liability schemes must rest on clearly articulated and constitutionally permissible grounds. SB2720's approach, imposing industry charges for injuries without proof of manufacturer fault, risks classifying lawful firearm production alongside inherently dangerous products with no basis in causation.

The bill's funding mechanism also raises serious questions under the Commerce Clause. The U.S. Supreme Court has held that state laws may not place undue burdens on interstate commerce or effectively regulate beyond state borders. In *Camps Newfound/Owatonna, Inc. v. Town of Harrison*, the Court struck down state statutes that burdened extraterritorial commerce without legitimate local benefit. SB2720 would effectively condition the market on regulatory fees that apply to all manufacturers, including out-of-state entities, without sufficient nexus to activities within Hawaii.

SB2720 conflates criminal and civil liability by imposing a no-fault financial obligation for any firearm injury, without requiring legal causation, wrongdoing, or negligence. This departs from well-established injury compensation systems in the U.S., which require proof of fault or strict product liability based on defective design or warning. In *Grimshaw v. Ford Motor Co.*, courts upheld product liability only where design defects posed unreasonable risks; SB2720 would require restitution for lawful, non-defective products used in unpredicted ways.

There is no persuasive evidence that such a fund would improve public safety. Rather than addressing the underlying causes of firearm misuse — such as criminal behavior, lack of enforcement, and failures in mental health systems — SB2720 shifts costs onto lawful producers with the expectation that funds will be used for injury compensation. This approach sets a dangerous precedent where the costs of injuries caused by unlawful conduct are socialized without accountability tied to culpable action.

From a practical standpoint, SB2720 could chill lawful commerce and discourage manufacturers from participating in the Hawaii market, effectively limiting lawful consumer access to firearms and related products. Any law that conditions market participation on punitive restitution risks legal challenge under both federal and state constitutions.

Public safety legislation must be constitutionally rooted, evidence-based, and narrowly tailored. **SB2720 fails these standards.** It imposes a broad financial scheme untethered from fault or traditional liability principles, burdens interstate commerce, and departs from established legal frameworks governing product liability and injury compensation.

For these reasons, I respectfully urge the Committee to oppose SB2720.

I respectfully submit this testimony in opposition to SB 2720.

SB 2720 proposes to create a Firearm Injury Restitution Fund financed by licensed firearm manufacturers as a condition of participating in the Hawaii market. While the goal of addressing firearm-related injuries is understandable, the mechanism proposed by this bill raises serious concerns regarding fairness, constitutional principles, and sound public policy.

The bill would impose financial liability on firearm manufacturers for actions and outcomes that are beyond their direct control. Manufacturers lawfully produce and distribute products in compliance with extensive federal and state regulations. Holding them financially responsible for the criminal misuse or negligent actions of third parties departs from long-standing legal principles that tie liability to direct wrongdoing or negligence.

From a constitutional perspective, this approach raises concerns related to due process and equal protection. Singling out a lawful industry for mandatory financial penalties without a showing of fault creates a precedent that weakens traditional standards of liability and fairness.

These concerns are particularly meaningful when viewed through Hawaii's historical and cultural lens. Traditional Hawaiian society emphasized kuleana—personal responsibility and accountability for one's own actions. Justice was grounded in balance and fairness, with responsibility placed on those who caused harm, rather than shifted to unrelated parties.

Imposing collective financial responsibility on manufacturers departs from these principles. While addressing violence and injury is an important goal, solutions should focus on those who commit harmful acts and on evidence-based prevention strategies, rather than on imposing indirect liability on lawful businesses.

Public safety is best served by policies that respect constitutional limits, uphold principles of individual responsibility, and direct resources toward proven interventions that reduce violence and support victims.

For these reasons, I respectfully oppose SB 2720 and urge lawmakers to carefully consider its constitutional implications, its alignment with Hawaii's cultural values of fairness and personal

The bill expressly claims compliance with **15 U.S.C. §§ 7901–7903 (PLCAA)**, but **substance matters more than labels**.

I oppose this measure based on the following:

Artificial Price Hikes: By requiring manufacturers to pay for expensive licensing fees as a condition of selling in Hawaii, this bill forces companies to pass those costs directly to the consumer. - Conduct audits
- Reclassify products

This gives the State the power to **financially manipulate the firearm market**, raising prices at will.

This is unprecedented economic control over a constitutionally protected product.

4. Establishes a Financial Punishment for Lawful Commerce

The bill claims to be “economic regulation,” but the structure is punitive:

- Manufacturers must pay for **accidental, self-inflicted, criminal, and unintended** injuries
- No other industry is treated this way
- The fund is a **first payer**, meaning it pays before insurance
- Manufacturers are forced to subsidize the entire cost of firearm-related injuries statewide

This is not neutral regulation — it is a **targeted financial burden** on a single lawful industry.

5. Creates a Dangerous Precedent for Regulating Other Rights

If the State can impose a financial restitution fund on firearms, it could theoretically do the same for:

- Free speech (e.g., “misinformation harm fund”)
- Vehicles (“traffic injury restitution fund”)
- Alcohol (“alcohol injury restitution fund”)

This bill opens the door to **rights-based taxation**, which is constitutionally unacceptable.

6. The “Risk Category” System Is Vague and Abusible

The Department of Health can classify firearms into “risk categories” based on:

- “Objective product characteristics”
- “Aggregated public-health cost data”

This is dangerously broad.

It allows the State to:

- Label certain firearms as “high risk”
- Assign them higher contribution rates
- Financially pressure manufacturers to stop selling certain models

This is a **backdoor method of banning disfavored firearms** without passing a ban.

7. The Bill Forces Manufacturers to Fund Injuries Caused by Criminals

The fund covers:

- Criminal shootings
- Accidental shootings
- Suicides
- Any discharge of a firearm

Manufacturers are being forced to pay for:

- Crimes they did not commit
- Misuse they did not cause
- Injuries unrelated to product defects

This is the exact type of liability PLCAA was designed to prevent.

8. Creates a State-Run Insurance Scheme Without Calling It Insurance

The bill describes the fund as:

- “No-fault”
- “First payer”
- Covering medical care, mental health, rehab, lost wages, funeral costs

This is **insurance**, but:

- It is mandatory
- It is imposed only on one industry
- It is not regulated as insurance
- It bypasses insurance law entirely

This is a **shadow insurance mandate** disguised as a licensing requirement.

9. Violates Due Process Through Mandatory Participation

Manufacturers must:

- Participate in the fund
- Pay whatever the State demands
- Accept reclassification
- Accept actuarial adjustments
- Accept audits

Failure results in:

- License denial
- License suspension
- License revocation

This is coercive economic regulation that deprives manufacturers of due process protections.

10. Will Dramatically Increase Firearm Prices for Hawai‘i Residents

- Reduced access for low-income residents
- A disproportionate burden on lawful owners

SB 2720 does not appear to reduce gun violence nor improve public safety. I believe that firearms manufactureres does not have any part of it. This bill only prioritizes reallocating cost after harm has taken place as opposed to investing in proven prevention strategies such as mental health services, violent prevention as a community, and enforcement against criminal activies such as illegal firearm trafficking.

Second, this bill can potentially affect local firearm businesses and manufacturers which they do not have to control of firearm misuse. Manufacturers operate under extensive federal and state regulation. Hawai‘i Firearms Coalition respectfully submits testimony in opposition to SB2720.

While this bill is framed as a public health financing measure rather than a restriction on firearms, its structure and effect raise serious legal, policy, and constitutional concerns. SB2720 seeks to impose a mandatory cost-recovery scheme on firearm manufacturers for injuries caused by third-party misuse, accidents, or self-harm, regardless of fault, negligence, or unlawful conduct by the manufacturer.

Although the bill expressly disclaims civil liability and punishment, it functionally operates as a liability substitute. Conditioning market participation on mandatory payments tied to aggregate injury data shifts public costs onto a lawful industry for conduct it does not control. This approach conflicts with long-established principles that responsibility for criminal or negligent misuse rests with the individual actor, not the manufacturer of a lawful product.

The bill also raises serious concerns under federal law. Congress enacted the Protection of Lawful Commerce in Arms Act to prevent states from imposing liability, directly or indirectly, on firearm manufacturers for harms caused by third parties. Recharacterizing liability as a licensing fee or restitution fund does not change its substance. Courts look to practical effect, not labels, and SB2720 risks being viewed as an impermissible end-run around federal protections.

From a policy standpoint, SB2720 sets a troubling precedent. If manufacturers of constitutionally protected products may be required to subsidize injuries arising from misuse or criminal acts, there is no principled limiting rule. This logic could be extended to automobiles, alcohol, pharmaceuticals, or other lawful products, transforming public health costs into industry-specific taxes untethered from fault.

Additionally, the bill grants broad discretion to the Department of Health to classify firearms into “risk categories” and assign contribution rates through rulemaking. These determinations would be made without direct legislative standards and could result in arbitrary or politically driven classifications that affect market access, consumer choice, and pricing in Hawai‘i.

Finally, SB2720 risks significant unintended consequences. Increased compliance costs will be passed on to consumers, reduce lawful market participation, and further isolate Hawai‘i from

national supply chains, all without evidence that the proposed fund will reduce violence or improve public safety outcomes.

Hawai‘i already has mechanisms to compensate crime victims and address public health needs. SB2720 does not address misuse, criminal behavior, or enforcement gaps. Instead, it reallocates costs in a manner that undermines legal accountability principles and invites extensive litigation.

For these reasons, Hawai‘i Firearms Coalition respectfully urges the Legislature to reject SB2720.

Aloha I respectfully submit testimony in opposition to this bill establishing a Hawai‘i Firearm Injury Restitution Fund funded by firearm manufacturers as a condition of market participation.

While providing assistance to victims of firearm-related injuries is a worthy goal, this proposal is legally unsound and unlikely to withstand judicial scrutiny. Similar efforts in other jurisdictions have already faced serious legal challenges, and recent court decisions make clear that this approach conflicts with federal law and constitutional principles.

In a recent unanimous decision, the United States Supreme Court reaffirmed the broad protections provided to firearm manufacturers under the federal Protection of Lawful Commerce in Arms Act. In *Smith & Wesson Brands, Inc. v. Estados Unidos Mexicanos*, the Court rejected an attempt to hold firearm manufacturers financially responsible for harms caused by third parties who criminally misuse lawfully sold firearms. The Court made clear that liability cannot be imposed without specific allegations of wrongdoing by the manufacturer itself. This decision underscores that states may not impose no-fault financial responsibility on firearm manufacturers simply because their products were misused by others.

Similarly, California’s Firearm Industry Responsibility Act, which attempted to impose sweeping liability and regulatory burdens on firearm manufacturers, has been blocked by a federal court. The court found the law likely unconstitutional and in conflict with federal protections governing lawful firearm commerce. This demonstrates that state efforts to single out firearm manufacturers for special financial penalties are vulnerable to being struck down.

This bill raises the same fundamental problems. It requires firearm manufacturers to fund a restitution program regardless of fault, negligence, or unlawful conduct, effectively punishing a lawful and heavily regulated industry for the actions of third parties. Such an approach raises serious concerns under federal law, the Commerce Clause, and due process protections, and would almost certainly result in costly litigation borne by Hawai‘i taxpayers.

Rather than risking years of litigation and uncertainty, the Legislature should pursue constitutionally sound, evidence-based approaches to victim support that do not rely on legally questionable funding mechanisms.

For these reasons, I urge the committee to oppose this measure.

Having experienced gun violence after my daughter was found dead due to a single bullet to the back of her head, I am grateful to its introducers - Senators Rhoads and Chang - for considering the needs of survivors, well beyond the thoughts and prayers.

This type of no fault, no shame fund would have helped me tremendously to avoid having to expend my modest savings, just to survive the first eight months.

Though not quite ready to return to work, the lack of resources and the inability of other non profits to really meet our needs meant that I had to return to work sooner than I should have.

It also led to me living at a half dozen locations over the ten years since my daughter died and my own brush with domestic violence, recently.

The impacts are no less devastating for my grandson, Ikaika, who is now 14 years old and will never know a peaceful nights sleep.

If my daughter had died from cancer, a car accident or some other incident, there would likely be more community support, but those of us who have lost loved ones to gun violence are forced to shoulder these burdens on our own.

Survivors of gun violence must navigate a completely uncharted path and - beyond the flowers and well wishes, the availability of financial resources is amongst the best ways to help us to ease our burdens while we recover from our tremendous loss.

SB2720 imposes an unconstitutional financial burden on the exercise of Second Amendment rights by forcing firearm manufacturers to pay into a state-controlled restitution fund as a condition of selling firearms in Hawai‘i. Although the bill claims not to impose liability, it effectively assigns manufacturers financial responsibility for accidental, self-inflicted, and criminal firearm injuries they did not cause. This structure conflicts with the Protection of Lawful Commerce in Arms Act and creates a de-facto tax on a constitutionally protected product. The bill grants the Department of Health sweeping authority to classify firearms into “risk categories,” set contribution rates, and adjust those rates at will, enabling the State to manipulate firearm pricing and indirectly restrict access. This unprecedented economic regulation will raise firearm prices for Hawai‘i residents, disproportionately burden lawful owners, and establish a dangerous precedent for taxing constitutional rights. SB2720 is not a public-health measure — it is a targeted financial penalty on lawful commerce and should not advance.

Aloha Chair and Members of the Committee,

My name is Mr James H Smith from and I submit this testimony in strong opposition to S.B. 2720.

S.B. 2720 creates a Hawai‘i Firearm Injury Restitution Fund and requires firearm manufacturers to obtain a “Firearm Injury Cost Recovery License” and pay state-set contributions as a condition of selling lawful products in Hawai‘i. Although the bill repeatedly states this is “not civil liability,” “not punishment,” and “not regulation of ownership,” the practical effect is the same: it forces manufacturers, as a class, to pay for harms caused by third-party misuse of a lawful product.

Congress enacted the Protection of Lawful Commerce in Arms Act (PLCAA), 15 U.S.C. §§ 7901–7903, to prevent exactly this type of cost-shifting for criminal misuse by third parties. Courts have applied PLCAA broadly. In *City of New York v. Beretta U.S.A. Corp.*, 524 F.3d 384 (2d Cir. 2008), and *Ileto v. Glock, Inc.*, 565 F.3d 1126 (9th Cir. 2009), federal courts rejected efforts to impose industry-wide responsibility for third-party misuse. While S.B. 2720 is structured as an administrative “license and contribution” system rather than a lawsuit, courts look at substance over labels. If the payments function as a damages proxy tied to injury costs from downstream misuse, PLCAA and federal preemption arguments will be unavoidable.

Beyond PLCAA, the bill invites additional constitutional challenges. The rate-setting, risk categorization, audits, and penalties delegated to an agency raise Due Process concerns if standards are vague or arbitrary. Conditioning market access on payments tied to statewide injury data implicates Commerce Clause issues, especially when it pressures out-of-state manufacturers. If the contribution operates like a punitive exaction untethered to any

individualized wrongdoing, Excessive Fines or Takings-style arguments will also arise. This means costly litigation for the State, funded by taxpayers, with uncertain outcomes.

There is also a serious practical concern for Hawai‘i’s local small businesses. Even if the contribution is imposed on manufacturers, costs will be passed down the supply chain to distributors, retailers, and ultimately consumers. Reduced manufacturer participation could mean less inventory, fewer lawful models available, higher prices, and longer wait times. Small, compliant local FFL dealers and ranges will be squeezed hardest. This does not target criminals; it burdens lawful commerce and local jobs.

Finally, S.B. 2720 does not clearly state what happens to surplus funds at the end of a fiscal year if claims are lower than projected. If contributions exceed payouts, do funds return to manufacturers? Are they rolled forward into the next year? Are they used for unrelated programs? The bill is silent on this. That raises important fairness, transparency, and constitutional questions. If the payments are truly a cost-recovery mechanism tied to actual injuries, there should be clear statutory direction on how excess funds are handled. Without that clarity, the contributions begin to look less like reimbursement and more like an open-ended revenue mechanism, which further weakens the State’s claim that this is not punitive or liability-based in nature.

If the goal is reducing firearm injury, Hawai‘i has better options that do not attempt to work around federal law, such as focused enforcement against straw purchasing, improved prosecution of prohibited possessors, mental health intervention, and community-based violence prevention programs.

For these reasons—federal conflict with PLCAA, constitutional concerns, likely litigation costs to taxpayers, economic harm to local lawful businesses, and lack of clarity regarding surplus funds—I respectfully ask the Committee to HOLD S.B. 2720.
