Hawai'i Alliance for Progressive Action (HAPA) Supports SB2737 SD1
Wednesday, March 18, 2026, at 2:00 PM | Conference Room 325 & Videoconference**

Aloha Chair Tarnas, Vice Chair Poepoe, and members of the Committee,

HAPA supports SB2737 SD1, which establishes a new misdemeanor offense for state elected officials who witness or know about bribery and fail to report it within sixty days.

This bill does not exist in a vacuum. Hawai'i has watched two members of the state legislature plead guilty to corruption charges in recent years. The House has already passed HR8 this session urging the Attorney General to expedite investigation into allegations that a legislator accepted \$35,000 in cash to influence a political campaign. These are not abstract concerns. They are documented, ongoing failures of accountability in our own legislature.

SB2737 SD1 responds to that reality with a straightforward requirement: if you are a state elected official and you witness or learn about bribery, you have sixty days to report it to the Attorney General, a county prosecutor, a law enforcement agency, the State Ethics Commission, or a county ethics board. If you don't, that is a misdemeanor.

This matters because silence enables corruption. When elected officials know about bribery and say nothing, they become part of the problem. The culture of looking the other way, of protecting colleagues over constituents, is exactly what has allowed misconduct to persist. SB2737 SD1 puts a legal obligation behind what should already be a moral one.

The bill is narrowly written. It applies only to state elected officials, defined as those whose salaries are set by the Commission on Salaries. It requires actual knowledge or witnessing, not rumor or suspicion. And it provides a sixty-day window and multiple reporting options to ensure the requirement is workable.

The people of Hawai'i deserve elected officials who not only refuse to engage in corruption themselves, but who actively refuse to tolerate it around them.

HAPA respectfully urges this committee to pass SB2737 SD1.

Aloha Chair Rhoads, Vice Chair Gabbard, and Members of the Committee,

I am writing in **strong support** of SB2737, which would establish the offense of failure to report bribery by a state or county elected official as a misdemeanor.

Bribery is a crime that thrives in the shadows. It is an act of profound betrayal that corrodes public trust, undermines the integrity of our democratic processes, and places private gain above the public good. While Hawai‘i has laws on the books to prosecute those who offer or accept bribes, our legal framework currently lacks a critical component: accountability for witnesses who stand by and do nothing.

SB2737 closes this dangerous gap.

This bill requires any elected official who knows of or witnesses the conferring, offering, solicitation, or acceptance of a bribe to report that conduct to the Department of the Attorney General within 60 days. Failure to do so would be a misdemeanor.

The need for this legislation has never been clearer. We are currently in the midst of an ongoing state investigation into an unidentified lawmaker who, according to federal records, was recorded accepting \$35,000 in cash—a scandal that has cast a long shadow over the Capitol this session. While the federal government declined to prosecute, the conduct alleged is exactly the kind of corrupt influence that this bill seeks to expose.

But this bill is not just about any single case. It is about creating a culture of accountability. When bribery occurs, it is rarely a victimless crime committed in a vacuum. These transactions often happen in the presence of staffers, other officials, or intermediaries. Currently, those who look the other way face no consequences for their silence. By creating a legal duty to report, SB2737 transforms passive witnesses into active guardians of integrity.

The consequences of inaction are severe. Unchecked bribery festers, leading to more corruption, skewed public policy, and a citizenry that loses faith in its government. This bill sends a clear and necessary message: silence is complicity.

We urge this committee to pass SB2737. It is a straightforward, common-sense measure that strengthens transparency, reinforces ethical standards, and safeguards Hawai'i's democracy for its residents and future generations.

TESTIMONY IN SUPPORT OF SB 2737, SD1 - RELATING TO BRIBERY.

Aloha Chair Tarnas, Vice Chair Poepoe, Rep. Cochran of Maui, and Members of the Committee,

My name is Christine Andrews, and I live in Wailuku, Maui. I write to you today in **support of SB 2737, SD1, Relating to Bribery**, which establishes the offense of failure to report bribery by a state elected official as a misdemeanor; requires a state elected official who knows of or witnesses the conferring, offering, solicitation, or acceptance of a pecuniary benefit in violation of the bribery statute to report the conduct to the Department of the Attorney General, a county prosecuting attorney, a law enforcement agency, the State Ethics Commission, or a county ethics board within sixty days; and defines "state elected official".

I have been an attorney licensed in Hawai'i for over 25 years. I am sure the members of the Committee are aware of the New York Times article, "Inside the Late-Night Parties Where Hawaii Politicians Raked In Money," published in January, 2024, with the tagline, "[a]fter the state passed a law barring government contractors from donating to politicians, fund-raising parties showed just how completely the reform effort failed"¹. As a long-term resident of Maui, at a time when my Lahaina neighbors were depending on the kindness of donations pouring in from around the world to help with recovery from the wildfire, an article in a major newspaper highlighting apparent corruption and apparent bribery in Hawaii is not only shameful, it directly impairs the recovery of the people of Lahaina by creating a chilling effect on charitable contributions.

We must act together now to establish norms and standards that address unethical behavior on the part of our elected officials and those who attempt to influence them in a manner contrary to the public interest. Currently, bribery often continues not because it goes unnoticed, but because it goes unreported. While bribery is illegal, current law does not require elected officials to report it, allowing misconduct to remain hidden or unaddressed.

This bill is important because bribery often persists when it is treated as an "open secret." Even when people are aware something is wrong, the lack of a reporting requirement allows unethical behavior to remain hidden, uninvestigated, and normalized. I request your support of SB2737, SD1 which will establish a clear duty for state elected officials to report known or witnessed bribery. Public service should carry an obligation to speak up when bribery occurs.
