Aloha President Kouchi, Speaker Nakamura and Members of the Legislature:

Transmitted herewith are proposed changes to the FY 27 Executive Supplemental Budget for the operating and capital improvement program (CIP) budget requests, as applicable, for the Departments of Human Services (HMS), Land and Natural Resources (LNR), Transportation (TRN) and the University of Hawai'i (UOH). Amendments to CIP and provisos are also proposed.

Your favorable consideration would be appreciated for the following budget requests to amend the FY 27 Executive Supplemental Budget.

1. Adjustments to the Operating Budget Request:

The following budget requests are being proposed to update amounts requested in the operating budget:

Department of Human Services

Health Care Payments – Fee-For-Service Payments (HMS 401/PE)

Add \$16,500,000 in general funds in FY 27 to cover costs from the expiration of the enhanced Affordable Care Act tax credits for individuals that qualify for Cost Share Reductions.

Department of Land and Natural Resources

Public Lands Management – Land Management Division (LNR 101/EA)

Add \$7,000,000 in special funds in FY 27 to increase the expenditure ceiling for land management activities that include hazardous material remediation, debris removal, and tree trimming.

Department of Transportation

Ellison Onizuka Kona International Airport at Keahole (TRN 114/BE)

Reduce \$143,481 in special funds in FY 27 to withdraw the request to redescribe a vacant position (Visitor Information Program Assistant (VIPA) II) to three new positions (Painter II, Electrician I, and Airport Maintenance Repairer I).

Trade-off 3.00 permanent full-time equivalent (FTE) positions and \$336,672 in special funds from fringe and collective bargaining to fund and redescribe 3.00 permanent VIPA II positions to 1.00 permanent Painter II, 1.00 permanent Electrician I, and 1.00 permanent Airport Maintenance Repairer I positions.

Airports Administration (TRN 195/BB)

Add \$2,500,000 in special funds in FY 27 to implement the Seamless Border Entry to streamline and speed up the customs clearance experience for travelers and increase funds pertaining to the ongoing maintenance and software licensing.

Add \$500,000 in special funds in FY 27 to support the continued implementation and expansion of the Internship and Workforce Development Program (IWDP), including resources for coordination, program administration, participant support, and other related improvements throughout the airports statewide.

Harbors Administration (TRN 395/CB)

Add \$200,000 in special funds in FY 27 to support the continued implementation and expansion of IWDP, including resources for coordination, program administration, participant support, and other related improvements.

Hawai'i Highways – Hawai'i District (TRN 511/DD)

Add \$15,000 in special funds in FY 27 to support the continued implementation and expansion of the IWDP, including resources for coordination, program administration, participant support, and other related improvements.

Maui Highways – Maui District (TRN 531/DF)

Transfer \$83,328 in special funds from payroll savings to personal services in FY 27 to fund a General Laborer II position.

Add \$35,000 in special funds in FY 27 to support the continued implementation and expansion of IWDP, including resources for coordination, program administration, participant support, and other related improvements.

Highways Administration (TRN 595/DA)

Transfer in 1.00 permanent FTE position (Highway Landscape Architect) and \$165,000 in special funds from General Administration (TRN 995/AA) in FY 27 to more appropriately align the budget with program operations.

Reduce 4.00 permanent FTE positions (2.00 Highways Administration Engineer IV, 1.00 Highways Administration Land Boundary Surveyor IV, and 1.00 Highways Administration Land Surveyor II positions) and \$510,030 in special funds in FY 27 for a trade-off/transfer to establish 4.00 new permanent FTE positions (1.00 Highway Safety Manager, 1.00 Program Specialist V, and 2.00 Information Specialist III positions) in Highways Safety (TRN 597/AB) to support the Automated Red Light and Speed Enforcement Program (ARLSEP) and to provide dedicated assistance with federal compliance requirements.

Highways Administration (TRN 595/DB)

Add \$240,000 in special funds in FY 27 for Systems, Applications, and Products in Data Processing consulting services to provide specialized technical expertise to support initial version upgrade, review and test version upgrade deliverables, and ensure a seamless transition that preserves system functionality and data integrity.

Add \$201,000 in special funds in FY 27 to support the continued implementation and expansion of IWDP, including resources for coordination, program administration, participant support, and other related improvements.

Reduce \$3,283,087 in special funds in FY 27 to withdraw the request in FY 27 to provide additional State Highway special funds (SHSF) for the Automated Speed Enforcement Program (ASEP).

Reduce \$790,500 in special funds in FY 27 to withdraw the request in FY 27 to provide additional funding for the 5% surcharge payment to Central Services as required by Chapter 36-28, HRS, for the ASEP Special Fund (ASEPSF).

Reduce \$3,283,087 in special funds in FY 27 to withdraw the request in FY 27 to provide additional SHSF for the Photo Red Light Imaging Detector System (PRLIDS).

Reduce \$172,422 in special funds in FY 27 to withdraw the request in FY 27 to provide funding for the 5% surcharge payment to Central Services as required by Chapter 36-28, HRS, for the Photo Red Light Imaging Detector Systems Special Fund (PRLIDSSF).

Highways Safety – Motor Vehicle Safety Office (TRN 597/AB)

Add 4.00 new permanent FTE positions (1.00 Highway Safety Manager, 1.00 Program Specialist V, and 2.00 FTE Information Specialist III positions) and \$510,030 in special funds in FY 27 to support the ARLSEP and to provide dedicated assistance with federal compliance requirements. Equivalent FTE positions and funds are being traded off/transferred from Highways Administration (TRN 595/DA).

Add \$3,283,087 in special funds in FY 27 to provide additional SHSF for ASEP.

Add \$790,500 in special funds in FY 27 to provide additional funding for the 5% surcharge payment to Central Services as required by Chapter 3628, HRS, for the ASEPSF.

Add \$3,283,087 in special funds in FY 27 to provide additional SHSF for the PRLIDS.

Add \$172,422 in special funds in FY 27 to provide funding for the 5% surcharge payment to Central Services as required by Chapter 36-28, HRS, for the PRLIDSSF.

Aloha Tower Development Corporation (TRN 695/AC)

Reduce 1.00 permanent FTE position and \$221,400 in special funds in other current expenses and add 1.00 temporary FTE position and \$221,400 in special funds in personal services in FY 27 to convert the Aloha Tower Development Corporation Program Specialist to a temporary position, which will provide flexibility to respond to the changes associated with development and management demands.

General Administration – Departmental Administration (TRN 995/AA)

Add \$231,000 in special funds in FY 27 to increase payment to the Transportation Division of the Department of the Attorney General for services of one additional Deputy Attorney General.

Transfer out 1.00 permanent FTE position (Highway Landscape Architect) and \$165,000 in special funds in FY 27 to Highways Administration (TRN 595/DA) to more appropriately align the budget with program operations.

Transfer \$61,632 in special funds out from other personal services in FY 27 to support the reclassification of a Human Resources Assistant (HRA) V to a Departmental Program Officer (DPO) (Workforce Development (WD)).

Transfer \$61,632 in special funds into personal services in FY 27 to support the reclassification of a HRA V to a DPO (WD).

University of Hawai'i

University of Hawai'i (UH), Mānoa – Student Services – Mānoa (UOH 100/AE)

Add \$5,000,000 in general funds in FY 27 to establish an institutional Name, Image, and Likeness Program to recruit and retain elite student-athletes.

UH, Cancer Center (CC) – Organized Research – UH, CC (UOH 115/AR)

Add \$5,000,000 in general funds in FY 27 to support salaries and operating expenses of UHCC.

Conservation and Resources Enforcement (LNR 405)

Amend project description and title for Division of Conservation and Resources Enforcement (DOCARE) Hawai'i Branch Office Building Renovation, Hawai'i, to amend the scope from renovation to replacement of the office building.

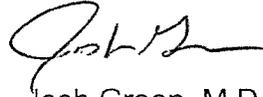
