
A BILL FOR AN ACT

RELATING TO HUMAN AND COMMUNITY RESILIENCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that food security and
2 healthy diets are essential for positive youth development,
3 thriving families, and resilient communities. Yet according to
4 the Hawaii Foodbank, more than thirty per cent of households are
5 food insecure, a level that is higher than during the COVID-19
6 pandemic.

7 The legislature further finds that one of the university of
8 Hawaii at Manoa college of tropical agriculture and human
9 resilience's core missions is to help local families with food
10 security, and the college intends to build a new human and
11 community resilience institute that is community-based and data-
12 driven. The institute plans to unite the centers and programs
13 with a shared purpose to increase children's food and
14 nutritional security, positive youth development and health
15 outcomes, family well-being, and community resilience. The
16 institute plans to include a center on the family, children's
17 healthy living center, Hawaii nutrition center, expanded food



1 and nutrition education program, and a statewide Hawaii 4-H
2 youth development program. The objectives of the institute are
3 to:

4 (1) Conduct community needs assessments, policy analyses,
5 and program evaluations to drive family and community
6 resilience in collaboration with governmental agencies
7 and nonprofit organizations;

8 (2) Develop and implement data-driven, family, and
9 community-based approaches to enhance food and
10 nutritional security, family well-being, and community
11 resilience;

12 (3) Build 4-H youth development programs that foster food
13 and farming entrepreneurship, healthy eating habits,
14 and resilient food systems and community leadership;

15 (4) Build capacity for basic nutrition and healthy eating
16 education in communities, K-12 schools, and colleges;
17 and

18 (5) Develop a new community-engaged scholarship and
19 learning program, a master community nutrition
20 education volunteer program, and a new master's degree
21 program in family and community resilience.



1 The purpose of this Act is to appropriate funds to the
2 university of Hawaii at Manoa college of tropical agriculture
3 and human resilience for the development of its human and
4 community resilience institute.

5 SECTION 2. There is appropriated out of the general
6 revenues of the State of Hawaii the sum of \$ or so
7 much thereof as may be necessary for fiscal year 2026-2027 for
8 the development of a human and community resilience institute at
9 the university of Hawaii at Manoa college of tropical
10 agriculture and human resilience and to establish twelve staff
11 positions, which shall include four community nutrition
12 associates, four 4-H program coordinators, one analytical
13 chemist, one nutrient data analyst, one data center manager, and
14 one community-based program impact evaluator.

15 The sum appropriated shall be expended by the university of
16 Hawaii for the purposes of this Act.

17 SECTION 3. This Act shall take effect on July 31, 2055.
