
A BILL FOR AN ACT

RELATING TO THE HAWAII STATE LESBIAN, GAY, BISEXUAL,
TRANSGENDER, QUEER, PLUS COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 369-3, Hawaii Revised Statutes, is
2 amended as follows:

3 1. By amending subsection (b) to read:

4 "(b) The commission shall consist of the following:

5 (1) Six ex officio, nonvoting members or their designees,
6 including the:

7 (A) Superintendent of education;

8 (B) President of the University of Hawaii system;

9 (C) Director of labor and industrial relations;

10 (D) Director of human resources development;

11 (E) Director of human services; and

12 (F) Director of health; and

13 (2) [~~Eight~~] Nine voting members who shall be appointed by

14 the governor in accordance with section 26-34;

15 provided that of these [~~eight~~] nine members:

16 (A) One member shall be from the county of Hawaii;



- 1 (B) One member shall be from the county of Kauai;
- 2 (C) One member shall be from the county of Maui;
- 3 (D) Four members shall be from the city and county of
4 Honolulu; [~~and~~]
- 5 (E) One member shall represent the Hawaii sexual and
6 gender minority workgroup of the department of
7 health[~~-~~]; and
- 8 (F) One member shall be under the age of twenty-nine
9 at the time of the member's appointment; and
- 10 (3) Two voting members, one of whom shall be appointed by
11 the speaker of the house of representatives and one of
12 whom shall be appointed by the senate president."

13 2. By amending subsection (d) to read:

14 "(d) A chairperson of the commission shall be elected
15 annually from the [~~eight~~] eleven appointed members of the
16 commission. A quorum to do business or validate any act of the
17 commission shall consist of a majority of the [~~eight~~] eleven
18 appointed members of the commission."

19 SECTION 2. Statutory material to be repealed is bracketed
20 and stricken. New statutory material is underscored.



1 SECTION 3. This Act shall take effect on July 1, 3000.
