
A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST
ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. This Act is recommended by the governor for
3 immediate passage in accordance with section 9 of article VII of
4 the Constitution of the State of Hawaii.

5 PART II

6 SECTION 2. There are appropriated from the sources of
7 funding indicated below to collective bargaining statewide (BUF
8 102) the following sums or so much thereof as may be necessary
9 to fund for fiscal biennium 2025-2027 all collective bargaining
10 cost items in the agreement negotiated with the exclusive
11 representative of collective bargaining unit (11):

7 funding indicated below to collective bargaining statewide (BUF
8 102) the following sums or so much thereof as may be necessary
9 to fund for fiscal biennium 2025-2027 the salary increases and
10 other cost adjustments authorized by chapter 89C, Hawaii Revised
11 Statutes, for state officers and employees who are excluded from
12 collective bargaining and belong to the same compensation plans
13 as those officers and employees within bargaining unit (11):

19 SECTION 5. Funds appropriated by this part shall be
20 allotted by the director of finance to the appropriate state

4 SECTION 6. Salary increases and cost adjustments provided
5 in this Act for any officer or employee whose compensation is
6 paid, in whole or in part, from federal, special, or other funds
7 shall be paid wholly or proportionately, as the case may be,
8 from the respective funds.

9 SECTION 7. Funds appropriated or authorized by this Act
10 that are not expended or encumbered by June 30, 2026, and June
11 30, 2027, of the respective fiscal years, shall lapse as of
12 those dates.

13 SECTION 8. This Act shall take effect on July 1, 3000.
