
A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, until June 30,
2 2020, section 302A-431.9, Hawaii Revised Statutes, authorized
3 the department of education to award high school diplomas to
4 qualified persons who did not receive a high school diploma as a
5 result of compulsory induction into active service in the armed
6 services of the United States, or any person whose high school
7 education was interrupted due to wartime practices such as
8 internment during World War II.

9 The purpose of this Act is to authorize the department of
10 education to award a high school diploma to a qualified person
11 who did not receive a high school diploma as a result of
12 compulsory or voluntary induction into active service in the
13 armed services of the United States or whose high school
14 education was interrupted due to wartime practices during World
15 War II, the Korean War, or the Vietnam War.



1 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
2 amended by adding a new section to part II to be appropriately
3 designated and to read as follows:

4 **§302A- High school diploma; armed services veterans**

5 **and other qualified persons.** (a) The department is authorized
6 to establish a program to award a high school diploma to any
7 qualified person who:

8 (1) Did not receive a high school diploma as a result of
9 compulsory or voluntary induction into active service
10 in the armed services of the United States during

11 World War II, the Korean War, or the Vietnam War; or

12 (2) Did not receive a high school diploma and whose high
13 school education was interrupted due to wartime
14 practices during World War II, the Korean War, or the
15 Vietnam War.

16 (b) A qualified person seeking a high school diploma shall
17 submit information establishing eligibility for the award of a
18 high school diploma pursuant to subsection (a) to the
19 department, on forms prescribed by the department.

20 (c) For purposes of this section, a "qualified person"

21 means any individual who:



1 (1) Was enrolled in a high school in the State or the
2 Territory of Hawaii between:
3 (A) December 1, 1941, and August 30, 1945;
4 (B) June 1, 1950, and July 31, 1953; or
5 (C) August 1, 1964, and January 31, 1973;
6 (2) Was compulsorily or voluntarily inducted into the
7 armed services of the United States or whose high
8 school education was interrupted; and
9 (3) Did not complete a high school curriculum and receive
10 a high school diploma."

11 SECTION 3. New statutory material is underscored.

12 SECTION 4. This Act shall take effect on July 1, 3000.
