
HOUSE CONCURRENT RESOLUTION

REQUESTING THE CITY AND COUNTY OF HONOLULU TO PLAN, DESIGN, AND
CONSTRUCT A COMMUNITY RECREATION COMPLEX IN 'EWA BEACH AT
OR NEAR PU'ULOA DISTRICT PARK.

1 WHEREAS, the 'Ewa region, including 'Ewa Beach, Ocean
2 Pointe, Ho'opili, and surrounding communities, has experienced
3 significant population growth over the past four decades; and
4

5 WHEREAS, the population of the 'Ewa area is estimated to
6 exceed eighty five thousand residents and continues to grow
7 rapidly as new housing developments are completed; and
8

9 WHEREAS, despite this rapid growth, the number of
10 recreational facilities available to serve residents has not
11 kept pace with community needs; and
12

13 WHEREAS, existing park facilities are frequently
14 overcrowded, limiting opportunities for youth sports, community
15 gatherings, and healthy outdoor activities; and
16

17 WHEREAS, residents of the 'Ewa community have expressed
18 strong interest in expanded recreational opportunities,
19 including basketball courts, volleyball courts, soccer fields,
20 and community recreation space; and
21

22 WHEREAS, the development of a modern recreation complex
23 would support youth sports leagues, promote physical health and
24 wellness, and provide a safe and welcoming gathering place for
25 families and residents of all ages; and
26

27 WHEREAS, a twenty acre recreation complex could include
28 multiple basketball courts, volleyball courts, pickleball
29 courts, soccer fields, baseball or softball fields, a gymnasium,
30 playgrounds, walking paths, community meeting space, and other

1 amenities that serve the needs of the growing 'Ewa community;
2 and

3

4 WHEREAS, collaboration between the State and the City and
5 County of Honolulu can help identify resources, land use
6 opportunities, and planning strategies to support the
7 development of new recreational facilities in the 'Ewa region;
8 now, therefore,

9

10 BE IT RESOLVED by the House of Representatives of the
11 Thirty-third Legislature of the State of Hawaii, Regular Session
12 of 2026, the Senate concurring, the City and County of Honolulu
13 is requested to plan, design, and construct a community
14 recreation complex in 'Ewa Beach at or near Pu'uloa District
15 Park; and

16

17 BE IT FURTHER RESOLVED that the City and County of Honolulu
18 is encouraged to include facilities such as basketball courts,
19 volleyball courts, pickleball courts, soccer fields, baseball or
20 softball fields, playground areas, walking paths, community
21 meeting rooms, and a gymnasium or recreation center in the
22 recreation complex; and

24 BE IT FURTHER RESOLVED that the City and County of Honolulu
25 Department of Parks and Recreation is requested to work with the
26 State of Hawai'i, community organizations, and residents to
27 evaluate potential locations, facility needs, and funding
28 opportunities for the development of this recreation complex;


