
HOUSE CONCURRENT RESOLUTION

REQUESTING THE OFFICE OF PLANNING AND SUSTAINABLE DEVELOPMENT TO
CONVENE A DEMOLITION WASTE REDUCTION WORKING GROUP.

1 WHEREAS, Hawaii's landfills are nearing capacity, with the
2 State facing significant community opposition to the expansion
3 of existing facilities or the establishment of new facilities;
4 and
5

6 WHEREAS, according to the United States Environmental
7 Protection Agency, construction and demolition waste constitutes
8 approximately twenty-one to forty percent of landfill mass
9 nationwide and represents one of the largest contributors to
10 solid waste in Hawaii, further exacerbating landfill pressures;
11 and
12

13 WHEREAS, a comprehensive and coordinated cross-industry
14 approach is critical to advancing the circular construction
15 economy, reducing waste, and promoting sustainable practices
16 across the State's construction and demolition sectors; and
17

18 WHEREAS, local recycling nonprofits and community-based
19 organizations in the State have made significant progress in
20 advocating for deconstruction, reuse, and circular economy
21 principles, but face barriers in scaling these efforts to have a
22 broader policy and economic impact; and
23

24 WHEREAS, a construction and demolition waste reduction
25 working group could serve as a catalyst to coordinate efforts
26 across industries, identify resources, remove systemic barriers,
27 and recommend targeted incentives that promote sustainable
28 practices and economic growth; and
29

30 WHEREAS, the adoption of reclaimed and reused materials,
31 which are often low-embodied carbon alternatives to virgin
32 materials, could significantly reduce greenhouse gas emissions
33 and support the State's carbon reduction goals, as outlined in



1 Act 15, Session Laws of Hawaii 2018, which committed the State
2 to achieving carbon neutrality by 2045; and

3
4 WHEREAS, landfills have historically been located near
5 disadvantaged communities, disproportionately exposing these
6 communities to health risks, such as air pollution, groundwater
7 contamination, and other environmental hazards, and addressing
8 these injustices should be a central goal of sustainable waste
9 management policies; and

10
11 WHEREAS, the establishment of a working group will help
12 make actionable recommendations, including reviewing potential
13 approaches, proposing solutions, and prioritizing actions to
14 promote deconstruction, materials reuse, and waste reduction;
15 and

16
17 WHEREAS, the Office of Planning and Sustainable Development
18 plays a key role in coordinating statewide planning,
19 sustainability initiatives, and cross-agency collaboration, and
20 is well positioned to convene stakeholders to address
21 construction and demolition waste challenges; now, therefore,

22
23 BE IT RESOLVED by the House of Representatives of the
24 Thirty-third Legislature of the State of Hawaii, Regular Session
25 of 2026, the Senate concurring, that the Office of Planning and
26 Sustainable Development is requested to convene a Demolition
27 Waste Reduction Working Group; and

28
29 BE IT FURTHER RESOLVED that the Working Group is requested
30 to:

- 31
32 (1) Identify and implement solutions to reduce
33 construction and demolition waste statewide;

35 (2) Develop strategies to scale deconstruction and
36 materials reuse to reduce landfill dependency;
37
38 (3) Support the growth of the circular construction
39 economy by fostering public and private sector
40 collaboration;

42 (4) Ensure alignment with the State's goals; and

(5) Create a framework for policy and economic incentives that promote sustainable practices; and

BE IT FURTHER RESOLVED that the Working Group is requested to include the following members:

- (1) The Director of the Office of Planning and Sustainable Development, or the Director's designee, who is requested to serve as chair of the Working Group;
- (2) The Comptroller, or the Comptroller's designee;
- (3) Private sector leaders invited to participate by the chair, including:
 - (A) One representative from the construction industry;
 - (B) One representative from the demolition and deconstruction industry;
 - (C) One representative from the reuse retail industry;
 - (D) One representative from the real estate development industry;
 - (E) One representative with expertise in historic preservation;
 - (F) One representative with expertise in architecture;
 - (G) One representative with expertise in urban planning; and
 - (H) One representative from the waste management industry; and

BE IT FURTHER RESOLVED that the Working Group is requested to invite and involve community groups with expertise in

1 workforce development, public policy, and environmental justice;
2 and

3

4 BE IT FURTHER RESOLVED that the Working Group is requested
5 to focus on policy innovation and cross-industry collaboration,
6 exploring best practices from successful circular economy
7 programs in other regions, such as those implemented in Denmark
8 and the Netherlands; and

9

10 BE IT FURTHER RESOLVED that the Working Group is requested
11 to submit annual reports of its findings and recommendations,
12 including any proposed legislation, to the Legislature no later
13 than twenty days prior to the convening of each Regular Session;
14 and

15

16 BE IT FURTHER RESOLVED that the reports are requested to
17 include the Working Group's successes and opportunities for
18 further action in advancing the circular construction economy;


21 BE IT FURTHER RESOLVED that certified copies of this
