
HOUSE CONCURRENT RESOLUTION

URGING THE CITY AND COUNTY OF HONOLULU TO ESTABLISH A MAKAKILO
DRIVE EXTENSION TASK FORCE.

1 WHEREAS, traffic congestion and limited roadway access in
2 west Oahu, particularly in the Makakilo area, have created
3 persistent safety, mobility, and economic challenges for
4 residents; and

5
6 WHEREAS, an extension of Makakilo Drive has long been
7 identified as a critical infrastructure project to improve
8 connectivity, reduce emergency response times, and support
9 responsible residential and commercial growth; and

10
11 WHEREAS, fragmented jurisdiction between state and
12 municipal entities has contributed to delays in the planning,
13 permitting, and implementation of the Makakilo Drive extension
14 project; and

15
16 WHEREAS, sustainable infrastructure practices, including
17 environmentally responsible design and energy-efficient
18 technology, are essential to Hawaii's long-term climate
19 resilience and environmental stewardship goals; and

20
21 WHEREAS, public transparency in major state and county
22 infrastructure projects strengthens government accountability,
23 trust, and fiscal responsibility; and

24
25 WHEREAS, a task force focusing on the Makakilo Drive
26 extension project could significantly streamline interagency
27 coordination, encourage sustainable infrastructure practices,
28 and enhance public transparency; now, therefore,

30 BE IT RESOLVED by the House of Representatives of the
31 Thirty-third Legislature of the State of Hawaii, Regular Session



1 of 2026, the Senate concurring, that the City and County of
2 Honolulu is urged to establish a Makakilo Drive Extension Task
3 Force to streamline and collaboratively advance efforts for the
4 Makakilo Drive extension project; and
5

6 BE IT FURTHER RESOLVED that the City and County of Honolulu
7 is requested to invite the following members or their designees
8 to participate as members of the task force:
9

10 (1) The Director of the Department of Transportation
11 Services of the City and County of Honolulu, who is
12 requested to serve as co-chair of the task force;
13

14 (2) The Managing Director of the City and County of
15 Honolulu, who is requested to serve as co-chair of the
16 task force;
17

18 (3) The Director of the Department of Planning and
19 Permitting of the City and County of Honolulu; and
20

21 (4) Two individuals whose primary residence is in west
22 Oahu, including the areas of Makakilo, Ewa Beach,
23 Kapolei, Waianae, or Waipahu, and whom the Mayor of
24 the City and County of Honolulu is requested to
25 appoint; and
26

27 BE IT FURTHER RESOLVED that the City and County of Honolulu
28 may invite representatives from state agencies as members of the
29 task force; and
30

31 BE IT FURTHER RESOLVED that the City and County of Honolulu
32 is requested to establish the following responsibilities for the
33 task force:
34

35 (1) Coordinating planning, land acquisition, permitting,
36 and construction activities;
37

38 (2) Identifying and resolving administrative or regulatory
39 delays;

41 (3) Ensuring extension project compliance with
42 sustainability and transparency best practices;

- 2 (4) Submitting quarterly progress reports to the Honolulu
- 3 City Council and state legislators representing Senate
- 4 District 22 and House District 43; and

- 6 (5) Submitting an annual report to the Legislature at
- 7 least twenty days prior to the convening of each
- 8 Regular Session that the task force exists; and
- 9

10 BE IT FURTHER RESOLVED that the task force is requested to
11 cease to exist on June 30, 2028, or upon the submission of its
12 eighth quarterly progress report, which shall serve as its final
13 report, whichever is sooner; and

15 BE IT FURTHER RESOLVED that certified copies of this
16 Concurrent Resolution be transmitted to the Mayor of the City
17 and County of Honolulu, Chair of the Honolulu City Council,
18 Managing Director of the City and County of Honolulu, Director
19 of Transportation Services of the City and County of Honolulu,
20 and Director of the Department of Planning and Permitting of the
21 City and County of Honolulu.
