
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES AND
DEPARTMENT OF EDUCATION TO COLLABORATE TO ESTABLISH A
FORMAL, LONG-TERM COLLABORATIVE PROGRAM TO EXPAND,
EQUITABLY DISTRIBUTE, AND SUSTAIN TREE-CANOPY COVERAGE
ACROSS PUBLIC SCHOOLS STATE WIDE.

1 WHEREAS, increasing heat in Hawaii threatens student health
2 and limits outdoor-learning and recreational opportunities
3 across public schools statewide; and
4

5 WHEREAS, only twenty-one percent of elementary schools
6 currently meet the recommended thirty-percent tree-canopy
7 coverage needed to provide adequate shade and cooling; and
8

9 WHEREAS, Title I schools and schools that serve lower-
10 income communities often have less tree-canopy coverage and
11 suffer from higher heat exposure, raising significant concerns
12 about equity; and
13

14 WHEREAS, in addition to lowering the temperature on school
15 campuses through shade, transpiration, and reduction of the
16 heat-island effect, trees also absorb storm water, clean the
17 air, beautify spaces, and help achieve state and county
18 environmental goals; and
19

20 WHEREAS, there are twenty-nine agricultural or natural-
21 resource programs on Department of Education campuses statewide,
22 where tree propagation, planting, and care offer relevant
23 educational opportunities for students; and
24

25 WHEREAS, the Department of Land and Natural Resources,
26 through its Kaulunani Urban and Community Forestry Program,
27 successfully partnered with the Department of Education under a
28 2025 Memorandum of Agreement to implement the Shade Trees for

1 Schools initiative and successfully partnered in 2024 in a Fruit
 2 Trees for Schools pilot program initiative on campuses with
 3 agricultural programs; and
 4

5 WHEREAS, these efforts demonstrate strong demand and
 6 measurable benefits but have been tied to specific short-term
 7 funding opportunities; now, therefore,
 8

9 BE IT RESOLVED by the House of Representatives of the
 10 Thirty-third Legislature of the State of Hawaii, Regular Session
 11 of 2026, the Senate concurring, that the Department of Land and
 12 Natural Resources and Department of Education are requested to
 13 establish a formal, long-term collaborative program to expand,
 14 equitably distribute, and sustain tree-canopy coverage across
 15 public schools statewide; and
 16

17 BE IT FURTHER RESOLVED that the program is requested to
 18 incorporate and plan for the long-term maintenance of the trees
 19 and the selection of species and locations that would ensure
 20 durable climate, health, and educational benefits for Hawaii's
 21 students; and
 22

23 BE IT FURTHER RESOLVED that this body supports the creation
 24 of staff positions to implement and sustain the work of this
 25 formal, long-term collaborative program; and
 26

27 BE IT FURTHER RESOLVED that certified copies of this
 28 Concurrent Resolution be transmitted to the Chairperson of the
 29 Board of Land and Natural Resources and Superintendent of
 30 Education.
