
A BILL FOR AN ACT

RELATING TO THE STADIUM AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 109-1, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "**§109-1 Stadium authority; appointment, terms.** (a) There
4 shall be established within the department of business, economic
5 development, and tourism for administrative purposes only, a
6 stadium authority whose responsibility shall be to maintain,
7 operate, and manage the stadium development district. The
8 stadium authority shall consist of eleven members. Eight
9 members shall be appointed by the governor in the manner
10 prescribed by section 26-34.

11 Of the eight public members:

12 (1) One member shall be designated as the Aiea community
13 representative and be a resident of one of the
14 following areas:

15 (A) Excluding Ford Island, the area beginning at the
16 intersection of the shoreline and Admiral Clarey
17 (Ford Island) Bridge and running:



- 1 (i) Easterly along [~~said~~] that bridge to Salt

4 Luapele drive;

- 15 (viii) Southwesterly along [~~said~~] that drive to

- 17 (ix) Northwesterly along [~~said~~] that drive to
18 Kamehameha highway;
- 19 (x) Northerly along [~~said~~] that highway to
20 Halawa stream;



- 1 (xi) Westerly along [~~said~~] that stream to the
2 shoreline; and
- 3 (xii) Northerly along [~~said~~] that shoreline to its
4 intersection with Admiral Clarey (Ford
5 Island) Bridge;
- 6 (B) The area beginning at the intersection of Kaonohi
7 street and H-1 freeway and running:
- 8 (i) Southeasterly along [~~said~~] that freeway to
9 the Moanalua freeway - Kamehameha highway
10 connector;
- 11 (ii) Northwesterly along [~~said~~] that highway
12 connector to Kamehameha highway;
- 13 (iii) Northwesterly along [~~said~~] that highway to
14 Aiea stream;
- 15 (iv) Southerly along [~~said~~] that stream to the
16 shoreline;
- 17 (v) Northwesterly along [~~said~~] that shoreline to
18 Kalauao stream;
- 19 (vi) Northeasterly along [~~said~~] that stream to
20 Kamehameha highway;



1 (vii) Northwesterly along [~~said~~] that highway to
2 Kaonohi street; and

3 (viii) Northeasterly along [~~said~~] that street to
4 its intersection with H-1 freeway; or

5 (C) The area beginning at the intersection of Waimalu
6 stream and Koolau ridge and running:

7 (i) Southeasterly along [~~said~~] that ridge to
8 Ewa-Honolulu district boundary;

9 (ii) Southwesterly along [~~said~~] that boundary to
10 Red Hill Naval Reservation boundary;

11 (iii) Southwesterly along [~~said~~] that boundary to
12 Tampa drive;

13 (iv) Westerly along [~~said~~] that drive to the
14 unnamed road;

15 (v) Northerly along [~~said~~] that road to Icarus
16 way;

17 (vi) Westerly along [~~said~~] that way to the
18 unnamed road;

19 (vii) Southwesterly along [~~said~~] that road to
20 Moanalua freeway (H-201);



- 1 (viii) Westerly along [~~said~~] that freeway to H-1
2 freeway;
- 3 (ix) Northwesterly along [~~said~~] that freeway to
4 Kaonohi street;
- 5 (x) Southwesterly along [~~said~~] that street to
6 Moanalua road;
- 7 (xi) Westerly along [~~said~~] that road to Kaahumanu
8 street;
- 9 (xii) Northerly along [~~said~~] that street to Komo
10 Mai drive;
- 11 (xiii) Easterly along [~~said~~] that drive to Punanani
12 gulch;
- 13 (xiv) Northeasterly along [~~said~~] that gulch to the
14 powerline;
- 15 (xv) Southeasterly along [~~said~~] that powerline to
16 Waimalu stream;
- 17 (xvi) Northeasterly along [~~said~~] that stream to
18 Aiea stream;
- 19 (xvii) Easterly along [~~said~~] that stream to Waimalu
20 stream; and



- 1 (xviii) Southeasterly along [~~said~~] that stream to
2 its intersection with Koolau ridge; and
- 3 (2) One member shall be designated as the west Honolulu
4 community representative and be a resident of the area
5 beginning at the intersection of H-1 freeway and
6 Moanalua freeway (H-201) and running:
- 7 (A) Southeasterly along [~~said~~] that freeway to
8 Aliamanu Military Reservation southern boundary;
- 9 (B) Westerly along [~~said~~] that boundary to Wanaka
10 street;
- 11 (C) Southwesterly along [~~said~~] that street to Likini
12 street;
- 13 (D) Northwesterly along [~~said~~] that street to Ukana
14 street;
- 15 (E) Southwesterly along [~~said~~] that street to Keaka
16 drive;
- 17 (F) Northwesterly along [~~said~~] that drive to Manuwa
18 drive;
- 19 (G) Southeasterly along [~~said~~] that drive to Pakini
20 street;



- 1 (H) Southwesterly along [~~said~~] that street to Keaka
2 drive;
- 3 (I) Southerly along [~~said~~] that drive to Puolo drive;
- 4 (J) Westerly along [~~said~~] that drive to Likini
5 street;
- 6 (K) Southerly along [~~said~~] that street to Maluna
7 street;
- 8 (L) Westerly along [~~said~~] that street to Salt Lake
9 boulevard;
- 10 (M) Southeasterly along [~~said~~] that boulevard to the
11 former street entrance to U.S. Naval Reservation;
- 12 (N) Southwesterly along [~~said~~] that feature to Reeves
13 loop;
- 14 (O) Southwesterly along [~~said~~] that loop to Radford
15 drive;
- 16 (P) Westerly along [~~said~~] that drive to H-1 freeway;
17 and
- 18 (Q) Northerly along [~~said~~] that freeway to its
19 intersection with Moanalua freeway (H-201).
- 20 Each public member of the stadium authority shall have been a
21 citizen of the United States and a resident of the State for at



1 least five years [~~next preceding~~] immediately before the
2 member's appointment. The remaining three members shall include
3 the director of business, economic development, and tourism or
4 the director's designee, who shall be an ex officio voting
5 member, and the president of the [~~University~~] university of
6 Hawaii and superintendent of education, or their designees, who
7 shall be ex officio nonvoting members of the stadium authority.

8 (b) The chairperson of the stadium authority shall be
9 elected by the majority of the voting members of the stadium
10 authority. The term of each member shall be four years;
11 provided that:

12 (1) Of the members initially appointed, three members
13 shall serve for four years, three members shall serve
14 for three years, and the remaining three members shall
15 serve for two years; and

16 (2) The terms of the members added by Act 146, Session
17 Laws of Hawaii 2021, shall commence on July 1, 2021.

18 No person shall be appointed consecutively to more than two
19 terms as a member of the stadium authority. Vacancies shall be
20 filled for the remainder of any unexpired term in the same
21 manner as original appointments.



1 (c) A majority of all of the voting members currently
2 serving on the stadium authority shall constitute a quorum to do
3 business, and the concurrence of a majority of all of the voting
4 members currently serving on the stadium authority shall be
5 necessary to make any action of the stadium authority valid.

6 [~~(e)~~] (d) The members of the stadium authority shall serve
7 without compensation and shall be allowed their actual and
8 necessary expenses incurred in the performance of their duties."

9 SECTION 2. Statutory material to be repealed is bracketed
10 and stricken. New statutory material is underscored.

11 SECTION 3. This Act shall take effect upon its approval.
