A BILL FOR AN ACT

RELATING TO SAFE ROUTES TO SCHOOL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that traffic safety
2 around Hawaii's schools must be strengthened to enable and
3 encourage children to walk and bicycle to school and make these
4 transportation alternatives more appealing to students and their
5 families. The legislature further finds that ensuring
6 sufficient funding for projects is a significant part of the
7 safe routes to school program. As such, Act 212, Session Laws
8 of Hawaii 2025, established the safe routes to school program
9 vehicle registration surcharge to be deposited into the safe
10 routes to school special fund to help pay for safe routes to
11 school project. As there is set to be an increase in the
12 funding for safe routes to school projects, the legislature also
13 finds that ensuring that safe routes to school funds are
14 appropriately spent is equally important.

15 Therefore, the purpose of this Act is to clarify
16 eligibility and improve accountability for the use of safe
17 routes to school funds.



1 SECTION 2. Section 291C-3, Hawaii Revised Statutes, is
2 amended to read as follows:

3 "~~§291C-3 [State and county safe routes to school programs;~~

5 counties; allocation and expenditure of funds; unused funds;
6 **reports.** (a) There is established, within the department of
7 transportation, a safe routes to school program that shall [~~;~~
8 ~~among other things, enhance traffic safety around Hawaii's~~
9 ~~schools, enable and]~~ encourage and enable children to walk and
10 bicycle to school [~~;~~ ~~and make bicycling and walking to school a~~
11 ~~safer and more appealing transportation alternative. Beginning~~
12 ~~July 1, 2024, the program shall be responsible for developing~~
13 ~~and publishing goals and performance measures in coordination~~
14 ~~with the safe routes to school advisory committee and providing~~
15 ~~technical assistance to counties and community organizations in~~
16 ~~support of projects and programs that advance state and county~~
17 ~~goals.] safely.~~

18 (b) [~~There is created, within the department of~~
19 ~~transportation, the position of safe routes to school program~~
20 ~~coordinator. The safe routes to school program coordinator~~

2 administer the safe routes to school program and may plan,
3 design, construct, implement, and administer eligible safe
4 routes to school projects. For purposes of this section,
5 eligible safe routes to school projects may be undertaken by the
6 department of transportation, a county, or in partnership with
7 other public agencies or schools.

8 (c) ~~[A county designated office, through the county safe~~
9 ~~routes to school program coordinator, and in consultation with~~
10 ~~the department of education, department of health, and Hawaii~~
11 ~~Association of Independent Schools, shall provide safe routes to~~
12 ~~school funds for school-based and community-based workshops and~~
13 ~~infrastructure and non-infrastructure projects that will reduce~~
14 ~~vehicular traffic and congestion, encourage walking and~~
15 ~~bicycling, and promote health and safety around Hawaii's~~
16 ~~schools.]~~ Any safe routes to school funds allocated to a county
17 shall be obligated within two years of the date of allocation
18 and expended within four years of obligation, unless an
19 extension is approved by the department of transportation for
20 good cause shown.



1 (d) ~~[The department of transportation shall expend funds~~
2 ~~from the safe routes to school program special fund in~~
3 ~~coordination with the safe routes to school advisory committee~~
4 ~~to be used for the implementation of the safe routes to school~~
5 ~~program plan and projects pursuant to section 291C-6(b)(2) and~~
6 ~~(3). No later than twenty days prior to the convening of each~~
7 ~~regular session, each county shall submit to the legislature an~~
8 ~~annual report on the status and progress of its county safe~~
9 ~~routes to school program, including an accounting of all grants~~

- 1 ~~(1) Fill a permanent, full-time position of safe routes to~~
- 2 ~~school coordinator within the county designated~~

- 4 ~~(2) Maximize the participation of school officials and~~

- 6 ~~(3) Work in conjunction with county designated safe routes~~
- 7 ~~to school stakeholders and train volunteer~~

- 9 ~~based projects, including flexible training schedules;~~

1 streamlined process for the safe routes to school program that
2 meets federal and state requirements, simplifies the grant
3 proposal application process, and expedites release of funding
4 after completion of school-based and community-based projects for
5 infrastructure and non-infrastructure.



12 of each regular session."
