
A BILL FOR AN ACT

RELATING TO CIVIC EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that a thriving democracy
2 depends on an engaged, informed, and empowered citizenry. Yet
3 the systems that sustain democratic participation--critical
4 thinking, media literacy, collaborative problem-solving, and
5 knowledge of governmental processes--must be intentionally
6 cultivated. For students, education received in middle school
7 or intermediate school is a pivotal period in which young people
8 form lasting understandings of their role in public life and
9 their connection to community, government, and aina. To meet
10 this moment, the State's public schools require stable,
11 dedicated resources that expand opportunities for students to
12 develop civic knowledge and the habits of democratic
13 participation.

14 The legislature further finds that existing funding
15 structures do not adequately support the development of civic
16 knowledge for students. Civic education is often reliant on
17 uneven school-level capacity, discretionary funds, or short-term



1 grants that cannot sustain long-range program design. These
2 structural gaps limit access to experiential civic learning,
3 professional development for social studies teachers, and
4 curriculum aligned with the State's civic-mission priorities.
5 Without a reliable funding mechanism, the State's obligation to
6 prepare young people for informed participation in our shared
7 governance is weakened, and disparities in civic opportunity
8 widen.

9 The legislature also finds that to address the systemic
10 challenges that impede the pursuit of civic knowledge, a special
11 fund dedicated solely to advancing civic education in the
12 State's public middle and intermediate schools is needed. By
13 establishing a permanent, purpose-restricted funding source, the
14 legislature affirms that civic education is a core public good
15 essential to the health of our democratic systems and will
16 ensure that every middle and intermediate school student in
17 Hawaii, regardless of geography, income, or school resources,
18 has meaningful access to high-quality civic-learning
19 opportunities that prepare them to participate fully in the life
20 of the State's democracy.



1 Accordingly, the purpose of this Act is to strengthen
2 Hawaii's civic infrastructure by establishing a civic education
3 grant program and civic education trust fund and dedicating
4 their use exclusively to support civic education in Hawaii's
5 public middle and intermediate schools.

6 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
7 amended by adding two new sections to be appropriately
8 designated and to read as follows:

9 "§302A-A Civic education grant program; establishment;
10 administration. (a) There is established within the department
11 for administrative purposes a civic education grant program, to
12 be administered by the department's office of curriculum and
13 instructional design, to support public middle and intermediate
14 schools in providing civic education to students through
15 department-approved programming that shall be integrated within
16 existing social studies curricula.

17 (b) Applications for grants shall be made to the
18 department. At a minimum, the applicant shall:

19 (1) Provide a detailed plan outlining the scope,
20 objectives, and projected impact of the project or



- 1 projects and a clear breakdown of how grant funds will
- 2 be used;
- 3 (2) Agree to use state funds exclusively for the purposes
- 4 of this program;
- 5 (3) Indicate capability to properly use the grant for the
- 6 purpose of the grant program;
- 7 (4) Comply with all applicable federal and state laws
- 8 prohibiting discrimination against any person on the
- 9 basis of race, color, national origin, religion,
- 10 creed, sex, age, sexual orientation, disability, or
- 11 any other characteristic protected under applicable
- 12 federal or state law;
- 13 (5) Agree not to use state funds for purposes of
- 14 entertainment or perquisites;
- 15 (6) Comply with other requirements as the department may
- 16 prescribe;
- 17 (7) Comply with all applicable federal, state, and county
- 18 statutes, rules, and ordinances;
- 19 (8) Agree to indemnify and save harmless the State of
- 20 Hawaii and its officers, agents, and employees from
- 21 and against any and all claims arising out of or



1 resulting from activities carried out or projects
2 undertaken with funds provided hereunder and procure
3 sufficient insurance to provide this indemnification
4 if requested to do so by the department; and

5 (9) Agree to make available to the department all records
6 the applicant may have relating to the grant to allow
7 state agencies to monitor the applicant's compliance
8 with this subsection.

9 (c) Grant awards shall be funded by the civic education
10 trust fund established pursuant to section 302A-B; provided that
11 no grant shall be awarded without the approval of a social
12 studies educational specialist pursuant to section 302A-B(d).

13 (d) Each participating school shall submit an annual
14 report to the department no later than December 1 of each year
15 on how awarded grant funds were used to further civic education,
16 including updates or status reports on the following:

17 (1) Implementation of civic education programming and
18 curriculum;

19 (2) Teacher development; and



1 (3) Progress in meeting any evaluation metrics for civic
2 education programming as established by the
3 department.

4 (e) The department shall compile the reports received from
5 participating schools pursuant to subsection (d) into one report
6 and submit the report to the legislature no later than twenty
7 days prior to the convening of each regular session.

8 (f) The department may adopt rules pursuant to chapter 91
9 necessary to carry out the purposes of this section.

10 **§302A-B Civic education trust fund; established.** (a)

11 There is established within the state treasury a civic education
12 trust fund to be administered by the office of curriculum and
13 instructional design of the department.

14 (b) The civic education trust fund shall consist of:

15 (1) Any appropriations made by the legislature;

16 (2) Grants, gifts, and donations from public sources,
17 including federal funding, or private sources; and

18 (3) Interest or other income earned from the investment of
19 moneys in the fund.

20 (c) The department shall expend moneys in the civic
21 education trust fund exclusively to support civic education



1 programming, curriculum implementation, teacher professional
2 development, and student civic-learning opportunities in public
3 middle and intermediate schools, including through the provision
4 of funding for grants under the civic education grant program
5 established pursuant to section 302A-A.

6 (d) Expenditures from the civic education trust fund shall
7 be approved by a social studies educational specialist, as
8 designated by the superintendent.

9 (e) The department shall submit an annual report on the
10 civic education trust fund to the legislature no later than
11 twenty days prior to the convening of each regular session. The
12 report shall include:

- 13 (1) Expenditures from and contributions to the trust fund
14 during the preceding fiscal year; and
15 (2) Results and outcomes achieved from expenditures from
16 the trust fund.

17 (f) Moneys deposited into or appropriated to the trust
18 fund shall remain available until they are obligated or until
19 the trust fund is terminated. If the trust fund is terminated,
20 all funds, including interest or other income earned from the



1 investment of moneys in the fund, shall be transferred to the
2 general fund."

3 SECTION 3. In codifying the new sections added by section
4 2 of this Act, the revisor of statutes shall substitute
5 appropriate section numbers for the letters used in designating
6 the new sections in this Act.

7 SECTION 4. New statutory material is underscored.

8 SECTION 5. This Act shall take effect on July 1, 2050.
