A BILL FOR AN ACT

RELATING TO CONDOMINIUM ASSOCIATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 514B-154, Hawaii Revised Statutes, is
2 amended by amending subsection (j) to read as follows:

3 "(j) Any fee charged to a member to obtain copies of
4 association records under this section shall be reasonable;
5 provided that a reasonable fee shall include administrative and
6 duplicating costs and shall not exceed [~~\$1~~] 75 cents per page,
7 or portion thereof, except the fee for pages exceeding eight and
8 one-half inches by fourteen inches may exceed [~~\$1~~] 75 cents per
9 page."

10 SECTION 2. Section 514B-154.5, Hawaii Revised Statutes, is
11 amended by amending subsections (e) and (f) to read as follows:

12 "(e) An association may comply with this section or
13 section 514B-152, 514B-153, or 514B-154 by making the required
14 documents, records, and information available to unit owners or
15 owners' authorized agents for download through an internet site,
16 at the option of each unit owner or owner's authorized agent and
17 at no cost to the unit owner or owner's authorized agent[~~-~~];




1 provided that an association shall make the following documents,
2 or their successor documents, available through an internet site
3 at no cost to unit owners or unit owners' authorized agents:

- 4 (1) General ledgers;
- 5 (2) Project information form (RR-105C); and
- 6 (3) Statement of account.

7 (f) Any fee charged to a unit owner or owner's authorized
8 agent to obtain copies of the association's documents, records,
9 and information, whether maintained, kept, or required to be
10 provided pursuant to this section or section 514B-152, 514B-153,
11 or 514B-154, shall be reasonable; provided that a reasonable fee
12 shall include administrative and duplicating costs and shall not
13 exceed [~~\$1~~] 75 cents per page, or portion thereof, except that
14 the fee for pages exceeding eight and one-half inches by
15 fourteen inches may exceed [~~\$1~~] 75 cents per page."

16 SECTION 3. Statutory material to be repealed is bracketed
17 and stricken. New statutory material is underscored.

18 SECTION 4. This Act shall take effect upon its approval.

Report Title:

Condominium Associations; Documents; Availability; Fee

Description:

Requires a condominium association to make available on an internet site the association's general ledgers, project information form (RR-105C), and statement of accounts at no cost to a unit owner or the unit owner's authorized agent. Reduces the reasonable fee a condominium association may charge to provide copies of association documents from \$1 per page to 75 cents per page.
