# A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST  
ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. This Act is recommended by the governor for  
3 immediate passage in accordance with section 9 of article VII of  
4 the Constitution of the State of Hawaii.

5 PART II

6 SECTION 2. There are appropriated or authorized from the  
7 sources of funding indicated below to collective bargaining  
8 statewide (BUF 102) the following sums or so much thereof as may  
9 be necessary to fund for fiscal biennium 2025-2027 all  
10 collective bargaining cost items in the agreement negotiated  
11 with the exclusive representative of collective bargaining  
12 unit (14):

2 SECTION 3. Funds appropriated or authorized by this part  
3 shall be allotted by the director of finance to the appropriate  
4 state departments for expenditure in the respective fiscal year  
5 for the purposes of this part.

7 SECTION 4. There are appropriated or authorized from the  
8 sources of funding indicated below to collective bargaining  
9 statewide (BUF 102) the following sums or so much thereof as may  
10 be necessary to fund for fiscal biennium 2025-2027 the salary  
11 increases and other cost adjustments authorized by chapter 89C,  
12 Hawaii Revised Statutes, for state officers and employees who  
13 are excluded from collective bargaining and belong to the same  
14 compensation plans as those officers and employees within  
15 bargaining unit (14):

1 SECTION 5. Funds appropriated or authorized by this part  
2 shall be allotted by the director of finance to the appropriate  
3 state departments for expenditure in the respective fiscal year  
4 for the purposes of this part.

6 SECTION 6. Salary increases and cost adjustments provided  
7 in this Act for any officer or employee whose compensation is  
8 paid, in whole or in part, from federal, special, or other funds  
9 shall be paid wholly or proportionately, as the case may be,  
10 from the respective funds.

11 SECTION 7. Funds appropriated or authorized by this Act  
12 that are not expended or encumbered by June 30, 2026, and  
13 June 30, 2027, of the respective fiscal years, shall lapse as of  
14 those dates.

15 SECTION 8. This Act shall take effect on January 1, 2077.
