## A BILL FOR AN ACT

RELATING TO SCHOOL LICENSURE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Historically, the regulation of private trade,  
2 vocational, and technical schools was primarily aimed at  
3 ensuring the quality of education and instruction below the  
4 college level. As vocational education has become more diverse  
5 and specialized, the focus has shifted toward protecting  
6 consumers from false, deceptive, misleading, and unfair  
7 practices while ensuring adequate educational quality.

8           Various audits and legislative assessments, including those  
9 conducted in 1997, 2002, and subsequent years, consistently  
10 highlight the department of education's lack of expertise,  
11 capacity, and alignment with consumer protection functions  
12 necessary for effective oversight of private trade, vocational,  
13 and technical schools. This gap in capability has raised  
14 concerns about the adequacy of consumer protection measures and  
15 the quality of education provided by these institutions.

16           In response to these findings, recommendations have been  
17 made over the years to transfer the responsibilities of private  
18 trade, vocational, and technical schools out of the department

1 of education. The university of Hawaii is better suited to  
2 administer this program, particularly the university of Hawaii  
3 community colleges. Given that the university of Hawaii  
4 community colleges 2023-2029 strategic plan imperative 3 has a  
5 stated goal to "Partner with industry stakeholders and  
6 community-based organizations to be the premier training  
7 provider to meet the state's workforce needs in sustainable  
8 ways" and that these professions include education, healthcare,  
9 technology, and skilled trades; the university of Hawaii is  
10 better equipped than the department of education with the  
11 requisite expertise to oversee private trade, vocational, and  
12 technical schools.

13 Given that the department of education's primary mission is  
14 to provide primary and secondary education to students in grades  
15 kindergarten through twelfth grade, the purpose of this Act is  
16 to transfer the licensing responsibilities of private trade,  
17 vocational, and technical schools from the department of  
18 education to the university of Hawaii.

19 SECTION 2. The Hawaii Revised Statutes is amended by  
20 adding a new chapter to be appropriately designated and to read  
21 as follows:

2       **§ -1 Definitions.** As used in this chapter, unless the  
3 context clearly requires otherwise:

4       "Private trade, vocational, or technical school" means an  
5 organization or corporation that provides instruction in any  
6 form or manner in any trade, occupation, or vocation for a  
7 consideration, reward, or promise of whatever nature, except:

- 8       (1) Schools maintained, or classes conducted, by employers  
9             for their own employees where no fee or tuition is  
10            charged;
- 11       (2) Courses of instruction given by any fraternal society,  
12             benevolent order, or professional organization to its  
13             members, which courses are not operated for profit;
- 14       (3) Classes conducted for less than five students at one  
15             and the same time;
- 16       (4) Classes or courses of instruction that are conducted  
17             for twenty or fewer class sessions during any twelve-  
18             month period;
- 19       (5) Avocational, hobby, recreation, or health classes or  
20             courses;
- 21       (6) Courses of instruction on religious subjects given

5 "University" refers to the university of Hawaii.

6 **§ -2 Licensure of private trade, vocational, or technical**  
7 **school.** (a) The university shall license private trade,  
8 vocational, and technical schools as necessary for:

9 (1) Compliance with federal regulations or accreditation  
10 requirements;

11 (2) Qualifying the private trade, vocational, or technical  
12 school for federal, state, or private funding; or

13 (3) Qualifying graduates of the private trade, vocational,  
14 or technical school for professional licensure.

15 The purpose of the licensing is to protect consumers  
16 against practices by private trade, vocational, or technical  
17 schools that are false, deceptive, misleading, or unfair.

18 (b) A private trade, vocational, or technical school that  
19 requires licensure under subsection (a) shall submit the  
20 following to the university in such form as the university may  
21 direct:

- 1           (1) Proof that the school is accredited by an accrediting  
2           commission of career schools and colleges, accrediting  
3           council for continuing education and training, or an  
4           accrediting bureau of health education schools;  
5           provided that in lieu of such accreditation, the

7           federal, or other licensing authority demonstrating  
8           that the private trade, vocational, or technical  
9           school's curriculum is sufficient to prepare a  
10          graduate to qualify for professional licensure;  
11          (2) Proof of current business registration demonstrating  
12          good standing;  
13          (3) A copy of the school's current general excise and tax  
14          license, including a current tax clearance; and  
15          (4) Proof that the school has secured a surety bond in the  
16          sum of \$50,000, payable in a form satisfactory to the  
17          university, to provide indemnification to any student  
18          suffering a financial loss as a result of the school  
19          not fulfilling its obligations under the terms of its  
20          license; provided that the bonding requirement may be  
21          reduced at the discretion of the university.

2 applying for initial licensure shall pay an initial license fee

14 (e) Complaints alleging unfair or deceptive acts or  
15 practices by a private trade, vocational, or technical school

19 (f) Fees collected pursuant to this section shall be  
20 deposited into the general fund.

21 (g) The university may adopt reasonable rules relating to  
22 the implementation of this section and section -3.

1           **§ -3 Suspension and revocation of license; procedure.**

2       (a) The university, after notice and opportunity for a hearing,  
3 may suspend or revoke a license at any time when, in the  
4 judgment of the university, the licensee is not complying with  
5 section -2 or the rules that may be adopted by the university.  
6 The notice of hearing shall be served personally or sent to the  
7 licensee by registered or certified mail with return receipt at  
8 the licensee's last known address.

9           (b) Notice of suspension or revocation shall be served  
10 personally upon the licensee or sent to the licensee by  
11 registered or certified mail with return receipt, and the  
12 licensee shall forward the licensee's license at once to the  
13 university, and cease at once to operate the private trade,  
14 vocational, or technical school.

15           (c) All proceedings shall be subject to chapter 91."

16           SECTION 3. Section 302A-101, Hawaii Revised Statutes, is  
17 amended as follows:

4 SECTION 6. All rights, powers, functions, and duties  
5 previously performed by the department of education under  
6 sections 302A-425 through 302A-426, Hawaii Revised Statutes, are  
7 transferred to the university of Hawaii.

8 SECTION 7. All rules, policies, procedures, guidelines,  
9 and other material adopted or developed by the department of  
10 education to implement provisions of the Hawaii Revised Statutes  
11 that are reenacted or made applicable to the university of  
12 Hawaii by this Act shall remain in full force and effect until  
13 amended or repealed by the university of Hawaii pursuant to  
14 chapter 91, Hawaii Revised Statutes.

15 In the interim, every reference to the department of  
16 education or the superintendent of education in those rules,  
17 policies, procedures, guidelines, and other material is amended  
18 to refer to the university of Hawaii or the president of the  
19 university of Hawaii, as appropriate.

20 SECTION 8. All deeds, leases, contracts, loans,  
21 agreements, permits, or other documents executed or entered into  
22 by or on behalf of the department of education pursuant to

8 machines, files, supplies, contracts, books, papers, documents,

12 transferred with the functions to which they relate.

13 SECTION 10. All officers and employees whose functions are  
14 transferred by this Act shall be transferred with their  
15 functions and shall continue to perform their regular duties  
16 upon their transfer, subject to the state personnel laws and  
17 this Act.

18 No officer or employee of the State having tenure shall  
19 suffer any loss of salary, seniority, prior service credit,  
20 vacation, sick leave, or other employee benefit or privilege as  
21 a consequence of this Act, and such officer or employee may be  
22 transferred or appointed to a civil service position without the

1 necessity of examination; provided that the officer or employee  
2 possesses the minimum qualifications for the position to which  
3 transferred or appointed; and provided that subsequent changes  
4 in status may be made pursuant to applicable civil service and  
5 compensation laws.

7 tenure and who may be transferred or appointed to a civil  
8 service position as a consequence of this Act shall become a  
9 civil service employee without the loss of salary, seniority,  
10 prior service credit, vacation, sick leave, or other employee  
11 benefits or privileges and without the necessity of examination;  
12 provided that such officer or employee possesses the minimum  
13 qualifications for the position to which transferred or  
14 appointed.

15 If an office or position held by an officer or employee  
16 having tenure is abolished, the officer or employee shall not  
17 thereby be separated from public employment, but shall remain in  
18 the employment of the State with the same pay and classification  
19 and shall be transferred to some other office or position for  
20 which the officer or employee is eligible under the personnel  
21 laws of the State as determined by the head of the department or  
22 the governor.



5 services provided.

7 and stricken. New statutory material is underscored.

8           SECTION 13. This Act, upon its approval, shall take effect  
9 on July 1, 2026.

**Description:**

Transfers the licensing authority of private trade, vocational, and technical schools from the Department of Education to the University of Hawaii.

JUSTIFICATION SHEET

DEPARTMENT: Education

TITLE: A BILL FOR AN ACT RELATING TO SCHOOL LICENSURE.

PURPOSE: To transfer the private trade, vocational, and technical (PTVT) schools licensing authority from the Department to the University of Hawaii (UH).

MEANS: Add a new chapter to the Hawaii Revised Statutes (HRS), amend section 302A-101, HRS, and repeal sections 302A-425 and 302A-426, HRS.

JUSTIFICATION: Originally established in 1939, the current system for oversight of PTVT schools does not adequately address the diverse and specialized nature of today's vocational education. Audits and legislative assessments have consistently highlighted the Department's lack of expertise and capacity to effectively oversee PTVT schools, raising concerns about consumer protection and educational quality.

The UH is better equipped to handle these responsibilities, particularly at the community colleges. The UH Community Colleges 2023-2029 Strategic Plan highlights their goal to strengthen ties with industry, specifically calling out education, healthcare, technology, and skill trades. This would make the UH better suited to improve efficiency, and ensure high-quality vocational training.

Impact on the public: This proposal would positively impact the public by enhancing consumer protection and ensuring high-quality vocational training.

Impact on the department and other agencies: This bill removes the administrative burden of PTVT from the Department by transferring

the licensing authority and administration  
of PTVT schools to the UH.
