SENATE CONCURRENT RESOLUTION

URGING THE CONVENING OF A MENTAL HEALTH EMERGING THERAPIES TASK FORCE TO PREPARE THE STATE FOR THE INTEGRATION OF BREAKTHROUGH THERAPIES AND TO EXPLORE OPPORTUNITIES TO EXPAND CLINICAL TRIALS, RESEARCH PARTNERSHIPS, AND TREATMENT CAPACITY IN THE STATE.

1 WHEREAS, Hawaii continues to face a significant mental
2 health crisis affecting residents across the State, including
3 veterans, first responders, trauma survivors, and individuals
4 experiencing treatment-resistant mental health conditions; and
5

6 WHEREAS, suicide remains one of the leading causes of
7 preventable death in Hawaii and across the United States,
8 underscoring the need to explore safe and effective treatment
9 options supported by scientific evidence; and
10

11 WHEREAS, the United States Food and Drug Administration has
12 granted breakthrough therapy designation to several emerging
13 treatments, including 3,4-methylenedioxymethamphetamine (MDMA)-
14 assisted therapy for post-traumatic stress disorder and
15 psilocybin-assisted therapy for treatment-resistant depression,
16 recognizing their potential to provide significant improvement
17 over existing interventions; and
18

19 WHEREAS, as federal rescheduling and regulatory approval of
20 these therapies are anticipated, states must proactively prepare
21 public health systems, clinical providers, and research
22 institutions for their safe and responsible implementation; and
23

24 WHEREAS, several states, including New Mexico, Texas,
25 Oregon, and Connecticut, have begun establishing frameworks to
26 support clinical research, pilot programs, and responsible
27 access pathways for emerging therapies; and
28

29 WHEREAS, without similar planning and coordination, Hawaii
30 risks falling behind in preparing its health care systems,

1 research institutions, and workforce to responsibly implement
2 these therapies when federally authorized; now, therefore,

3
4 BE IT RESOLVED by the Senate of the Thirty-third
5 Legislature of the State of Hawaii, Regular Session of 2026, the
6 House of Representatives concurring, that the Thompson School of
7 Social Work and Public Health is urged to convene a Mental
8 Health Emerging Therapies Task Force to prepare the State for
9 the integration of breakthrough therapies and to explore
10 opportunities to expand clinical trials, research partnerships,
11 and treatment capacity in the State; and

12
13 BE IT FURTHER RESOLVED that the Task Force is urged to
14 include representatives of the Department of Health; University
15 of Hawaii; and mental health professionals, legal and regulatory
16 experts, Native Hawaiian health organizations, and individuals
17 with lived experience, including veterans, first responders, and
18 caregivers to be invited by the chairpersons of the Task Force;
19 and

21 BE IT FURTHER RESOLVED that a member representing the
22 Thompson School of Social Work and Public Health with
23 demonstrated history and expertise in breakthrough and emerging
24 therapies is requested to serve as the chairperson of the Task
25 Force; and

26
27 BE IT FURTHER RESOLVED that the Task Force is urged to:

29 (1) Prepare the State for federal rescheduling and medical
30 approval of 3,4-methylenedioxymethamphetamine (MDMA),
31 psilocybin, and other drugs or treatments designated
32 as breakthrough therapies by the United States Food
33 and Drug Administration;

35 (2) Identify opportunities and requirements for expanding
36 local clinical trials, investigator-initiated
37 research, and university-based research partnerships;

39 (3) Develop educational partnerships to help expand
40 awareness of clinical research opportunities for
41 potential beneficiaries of breakthrough therapies;



- 1 (4) Recommend training, certification, and workforce
2 development pathways for licensed professionals who
3 may administer or support emerging therapies;
4
- 5 (5) Evaluate best practices from other jurisdictions
6 regarding patient safety, culturally-informed care,
7 equity, access, and harm reduction;
8
- 9 (6) Develop a statewide implementation roadmap for
10 integrating emerging therapies pending federal
11 approval; and
12
- 13 (7) Make legislative, administrative, and other
14 recommendations to support long-term adoption of
15 mental health emerging therapies in the State.
16

17 BE IT FURTHER RESOLVED that the Task Force is requested to
18 submit a report summarizing its findings and recommendations,
19 including any proposed legislation, to the Legislature no later
20 than twenty days prior to the convening of the Regular Sessions
21 of 2027 and 2028; and
22

23 BE IT FURTHER RESOLVED that certified copies of this
24 Concurrent Resolution be transmitted to the Governor, Director
25 of Health, President of the University of Hawaii, and Dean of
26 the Thompson School of Social Work and Public Health.
