SENATE CONCURRENT RESOLUTION

REQUESTING THE AUDITOR TO CONDUCT A COMPREHENSIVE PERFORMANCE
AND FINANCIAL AUDIT OF THE DEPARTMENT OF EDUCATION'S
CAPITAL IMPROVEMENT PROJECT BACKLOG.

1 WHEREAS, the Department of Education manages the largest
2 public infrastructure portfolio in the State, including hundreds
3 of public school campuses and facilities that require ongoing
4 maintenance, renovation, and construction; and

5
6 WHEREAS, capital improvement projects are critical to
7 ensuring that public school facilities are safe, functional,
8 modern, and capable of supporting student learning and
9 educational outcomes; and

10
11 WHEREAS, the State has appropriated significant funding
12 over time for school facility planning, design, construction,
13 and deferred maintenance projects; and

14
15 WHEREAS, concerns have been raised regarding the size and
16 duration of the Department of Education's capital improvement
17 project backlog and the pace at which projects are implemented
18 and completed; and

19
20 WHEREAS, policymakers and the public would benefit from a
21 comprehensive and transparent accounting of the Department of
22 Education's capital improvement project backlog, including the
23 status of projects and the amount of funding required to
24 complete the projects; and

26 WHEREAS, the Office of the Auditor is authorized to conduct
27 performance and financial audits of state agencies and programs
28 to improve accountability, transparency, and effectiveness in
29 the use of public funds; now, therefore,

31 BE IT RESOLVED by the Senate of the Thirty-third
32 Legislature of the State of Hawaii, Regular Session of 2026, the

1 House of Representatives concurring, that the Auditor is
2 requested to conduct a comprehensive performance and financial
3 audit of the Department of Education's capital improvement
4 project backlog; and

5
6 BE IT FURTHER RESOLVED that the audit is requested to
7 include but not be limited to:

- 8
- 9 (1) A complete inventory of the backlog of all Department
10 of Education capital improvement projects;
 - 11
12 (2) The total funding that has been appropriated,
13 allocated, encumbered, obligated, or expended for each
14 project;
 - 15
16 (3) The current status of each project, including
17 planning, design, procurement, construction,
18 completion, or delay;
 - 19
20 (4) The original estimated project cost compared with the
21 most current cost estimate;
 - 22
23 (5) Any identified delays, cost overruns, or
24 administrative barriers affecting project delivery;
 - 25
26 (6) The projected funding necessary to complete each
27 project and to eliminate the existing backlog; and
 - 28
29 (7) Recommendations to improve capital improvement project
30 planning, budgeting, management, and execution within
31 the Department of Education; and

33 BE IT FURTHER RESOLVED that the Auditor is requested to
34 submit a report of its findings and recommendations, including
35 any proposed legislation, to the Legislature no later than
36 twenty days prior to the convening of the Regular Session of
37 2027; and

39 BE IT FURTHER RESOLVED that certified copies of this
40 Concurrent Resolution be transmitted to the Governor,
