SENATE CONCURRENT RESOLUTION

RECOGNIZING THE FIFTIETH ANNIVERSARY OF THE RESTORATION OF
AHU'ENA HEIAU AND AFFIRMING ITS UNPARALLELED ROLE IN THE
SPIRITUAL, POLITICAL, AND CULTURAL HISTORY OF THE STATE.

1 WHEREAS, Ahu'ena Heiau is located at Kamakahonu,
2 traditionally known as the "eye of the turtle", within the
3 ahupua'a of Lanihau in Kailua, Kona, on the island of Hawai'i,
4 and is among the most historically and culturally significant
5 sites in the Hawaiian Islands; and
6

7 WHEREAS, Ahu'ena Heiau served as the religious temple of
8 Kamehameha the Great, following his conquest of the Hawaiian
9 Island and return to Hawai'i Island in 1812, and functioned as
10 the center of political and spiritual governance during the
11 final years of his reign; and
12

13 WHEREAS, during Kamehameha the Great's golden years, his
14 most trusted advisors convened nightly at Ahu'ena Heiau, where
15 matters of governance, loyalty, agriculture, and the welfare of
16 chiefs and commoners deliberated, and where his heir, Liholiho,
17 who would become Kamehameha II, was instructed in the
18 responsibilities of leadership; and
19

20 WHEREAS, Ahu'ena Heiau was the site of several pivotal
21 moments in Hawaiian history, including the death of Kamehameha I
22 on May 8, 1819; the abolition of the kapu system later that year
23 by Kamehameha II, which averted civil war and forever
24 transformed Hawaiian governance and society; and the grant of
25 permission for the first Christian missionaries from New England
26 to come ashore on April 4, 1820; and
27

28 WHEREAS, Kamakahonu was also home to Governor John Adams
29 Kuakini, a residence of King Kalākaua, and a place of refuge for
30 Prince William Pitt Leleiohoku II, further underscoring the
31 site's central role in the political and royal history of the
32 Hawaiian Kingdom; and

2 WHEREAS, constructed before his establishment as ruler of a
3 united Hawaii in 1812, Kamehameha the Great restored and
4 maintained Ahu'ena Heiau until his death in 1819, as documented
5 by John Papa I'i who described Ahu'ena Heiau as a Hale o Lono
6 where religious ceremony, governance, and instruction of future
7 rulers took place; and
8

9 WHEREAS, Kamakahonu was designated a National Historic
10 Landmark on December 29, 1962, and was placed on the Hawai'i
11 Register of Historic Places on July 17, 1993, in recognition of
12 its exceptional national and state significance; and
13

14 WHEREAS, more than one hundred fifty years after the
15 historic events that defined Ahu'ena Heiau, an accurate
16 archaeological restoration began in 1975 through a collaboration
17 between the Bernice P. Pauahi Bishop Museum, community members,
18 cultural practitioners, and archaeologists; and
19

20 WHEREAS, reconstruction of Ahu'ena Heiau began in 1975 and
21 was guided by archaeological research and historical
22 documentation, including the 1816 sketches of Louis Choris, with
23 design contributions by Herb Kawainui Kāne and fieldwork led by
24 distinguished scholars and practitioners, including Dr.
25 Yoshihiko H. Sinoto, Dr. Kenneth P. Emory, Patrick V. Kirch, and
26 many dedicated community members; and
27

28 WHEREAS, the restoration effort relied upon extraordinary
29 community support, including the donation of materials, labor,
30 and cultural knowledge, the processing of approximately two
31 hundred fifty thousand tī leaves for thatching, and the careful
32 reconstruction of traditional structures using historically
33 accurate methods; and
34

35 WHEREAS, restoration of Ahu'ena Heiau and the adjacent Hale
36 Nana Mahina'ai was completed in March 1977, returning the site to
37 its appearance and dignity as it stood during the time of
38 Kamehameha the Great; and

1 WHEREAS, Ahu'ena Heiau, Inc., a federally recognized
2 501(c)(3) nonprofit organization incorporated in 1993, was
3 established to guide the long-term preservation, maintenance,
4 and cultural stewardship of the site and to promote appreciation
5 and understanding of Hawaiian history; and
6

7 WHEREAS, the stewardship of Ahu'ena Heiau, Inc., is guided
8 by cultural protocol and 'ike kupuna, with ongoing cultural
9 restoration supported by the Royal Order of Kamehameha and its
10 Ali'i 'Aimoku Ali'i and by the continued care of dedicated
11 directors, officers, and cultural practitioners; and
12

13 WHEREAS, the land upon which Ahu'ena Heiau stands has passed
14 through generations of ali'i, private ownership, and stewardship,
15 and is currently owned by HKK Hawai'i, LLC, which continues to
16 support the upkeep and maintenance of this sacred and historic
17 site; and
18

19 WHEREAS, the fiftieth anniversary of the restoration of
20 Ahu'ena Heiau provides an important opportunity to honor the
21 vision, scholarship, community advocacy, and cultural commitment
22 that returned this national treasure to the people of Hawai'i and
23 ensured its preservation for future generations; now, therefore,
24

25 BE IT RESOLVED by the Senate of the Thirty-third
26 Legislature of the State of Hawaii, Regular Session of 2026, the
27 House of Representatives concurring, that this body recognizes
28 the fiftieth anniversary of the restoration of Ahu'ena Heiau and
29 affirms its unparalleled role in the spiritual, political, and
30 cultural history of the State; and
31

32 BE IT FURTHER RESOLVED that this body expresses its deepest
33 appreciation to the kūpuna; cultural practitioners;
34 archaeologists; historians; community members; Ahu'ena Heiau,
35 Inc.; and all those whose dedication and stewardship have
36 preserved Ahu'ena Heiau as a living place of history, learning,
37 and reverence; and

39 BE IT FURTHER RESOLVED that certified copies of this
40 Concurrent Resolution be transmitted to the Chairperson of the
41 Board of Directors of Bishop Museum, Chairperson of the Board of



1 Directors of Ahu'ena Heiau, Inc., and General Manager of the
2 Courtyard by Marriott King Kamehameha Kona Beach Hotel.
