SENATE CONCURRENT RESOLUTION

REQUESTING THE CITY AND COUNTY OF HONOLULU TO CONSIDER CHANGING
THE CONFIGURATION OF BICYCLE LANES AND ON-STREET PARKING
STALLS TO ALIGN WITH THE FLOW OF VEHICULAR TRAFFIC,
ESPECIALLY ON ONE-WAY STREETS.

1 WHEREAS, the City and County of Honolulu is committed to
2 ending traffic violence on the island of Oahu through its Oahu
3 Vision Zero Action Plan; and

4
5 WHEREAS, the goal of the Oahu Vision Zero Action Plan is to
6 eliminate all fatalities and severe injuries on Honolulu's roads
7 while supporting safe, healthy, and equitable transportation
8 choices; and

10 WHEREAS, the safety of bicyclists is of great importance to
11 the State and to the City and County of Honolulu; and

12
13 WHEREAS, bicycle lanes on the island of Oahu are intended
14 to provide bicyclists with safe paths for transportation; and

15
16 WHEREAS, bicycle lanes that allow bicyclists to travel
17 against the flow of vehicular traffic can be a safety hazard to
18 bicyclists, as well as to pedestrians and motorists, especially
19 at one-way streets where the visibility is restricted; and

20
21 WHEREAS, when bicycle lanes allow bicycles to travel in
22 both directions on one-way streets, persons exiting abutting
23 business driveways often have difficulty seeing the oncoming
24 bicyclists, who may approach from either direction; and

25
26 WHEREAS, when bicycle lanes are adjacent to on-street
27 parking stalls, this further limits the viewing angle of drivers
28 exiting abutting driveways, increasing the risk of accidents;

1 BE IT RESOLVED by the Senate of the Thirty-third
2 Legislature of the State of Hawaii, Regular Session of 2026, the
3 House of Representatives concurring, that the City and County of
4 Honolulu is requested to consider changing the configuration of
5 bicycle lanes and on-street parking stalls to align with the
6 flow of vehicular traffic, especially on one-way streets; and
