Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1643, H.D. 2, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO PHARMACY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- (1) Specify a framework for the administration of audits of records of registered pharmacists and pharmacies; and
- (2) Amend the definition of "pharmacy benefit manager" for the purposes of the pharmacy benefit manager registry to exclude certain health maintenance organizations.

Your Committee on Conference has amended this measure by:

- (1) Changing the effective date to upon approval; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.


