Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1721, H.D. 2, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO HOUSING,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to:

- (1) Clarify insurance, indemnification, and certain certificate of occupancy requirements for purposes of expedited permits; and
- (2) Require state or county inspectors to inspect all projects with expedited permits.

Your Committee on Conference has amended this measure by changing the effective date to July 1, 2026.




