Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2293, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE HARM TO STUDENTS REGISTRY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to clarify the scope of the Department of Education's harm to students registry by excluding K-12 students and by providing that contractors and volunteers are included only if their roles involve interaction with students.

Your Committee on Conference has amended this measure by changing the effective date to upon approval.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your


