SB 2709 Status & Testimony	RELATING TO BIOSECURITY. Requires the Department of Agriculture and Biosecurity to establish rules to enforce the Akamai Arrival Program. Requires DAB to strengthen enforcement of plant and non-domestic animal quarantine and microorganism importations.	AEN/TRS, WAM
SB 3154 Status & Testimony	RELATING TO TRANSPORTATION ENVIRONMENTAL REVIEW. Authorizes the Department of Transportation to assume responsibilities under the National Environmental Policy Act of 1969 for highway projects, as well as railroad, public transportation, or multimodal projects within the State, allowing streamlined environmental reviews. Provides a limited waiver of sovereign immunity to comply with federal requirements under 23 U.S.C. §§326 and 327.	TRS/AEN, JDC
