RELATING TO DISPOSABLE BODYBOARDS.

AEN, CPN/JDC

Prohibits the sale, rental, or distribution of disposable bodyboards in the State. Establishes penalties.

RELATING TO HEMP.

AEN, WAM/JDC

Establishes the Hawaii Hemp Fiber Special Fund. Establishes the Hemp Paper Packaging Pilot Program. Establishes the Industrial Hemp License Surcharge. Requires reports to the Legislature. Appropriates funds. Sunsets 6/30/2030.

RELATING TO TRESPASS.

AEN, JDC

Prohibits persons being prosecuted for or convicted of the crime of criminal trespass on agricultural land from owning, possessing, or controlling a firearm or ammunition.

RELATING TO ADDITIVES IN FOOD.

AEN, CPN

Beginning January 1, 2027, bans the manufacture, sale, offer of sale, or distribution in the State of any food that contains petroleum-based synthetic food dyes and synthetic chemical additives.

Decision Making to follow, if time permits.

- Testifiers for this hearing will be limited to **1 minute** each.
