<a href="#">SB 2908</a> <a href="#">Status &amp; Testimony</a>	RELATING TO PERMITTING. Implements certain recommendations of the SPEED Task Force. Requires the Department of Business, Economic Development, and Tourism to develop a statewide permitting intake platform. Appropriates funds for the development of the platform, subject to a matching funds requirement from the counties.	EDT/EIG, WAM
<a href="#">SB 2987</a> <a href="#">Status &amp; Testimony</a>	RELATING TO LIGHT POLLUTION. Beginning 7/1/2027, establishes outdoor light fixture requirements throughout the State.	EDT/EIG, WAM

- Testifiers for this hearing will be limited to **2 minutes** each.
