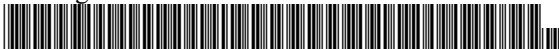

Appropriates funds for the University of Hawaii to expand and sustain services provided by the Maui Wildfire Exposure Study and Maui Health Registry. Effective 7/1/3000. (HD1)



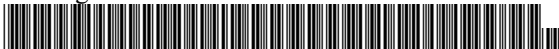
SB 3263, SD2, HD2 (HSCR1533-26) Status	<p>RELATING TO THE UNIVERSITY OF HAWAII.</p> <p>Affirms student-athletes' rights to engage in name, image, and likeness activities for compensation. Requires the University of Hawaii to adopt policies governing institutional name, image, and likeness agreements and other aspects of name, image, and likeness activity consistent with federal law, rules by an intercollegiate athletics governing body such as the National Collegiate Athletic Association, and Title IX. Requires the University to provide independent advisors to student-athletes. Establishes certain transparency and accountability requirements in the administration of institutional name, image, and likeness activities. Provides protections and educational support for student-athletes who enter into name, image, and likeness agreements. Sunsets 6/30/2030. Effective 7/1/3000. (HD2)</p>	<p>HED, CPC, FIN</p>

SB 2877, SD1, HD1 (HSCR1509-26) Status	<p>RELATING TO EDUCATION.</p> <p>Requires the Department of Education to establish a one-year Student-Authored Book Publication Pilot Program. Authorizes the Pilot Program to be conducted for fifth graders at Kalihi public elementary schools to be integrated into existing curricula. Requires a report to the legislature. Appropriates funds. SB 2024, SD2, HD1 (HSCR1384-26) Status	<p>RELATING TO CHARTER SCHOOL FACILITIES.</p> <p>Authorizes the School Facilities Authority to use public-private partnerships for the development of public school facilities, including facilities at public charter schools. Requires the School Facilities Authority to establish a pilot program to develop three new public schools in areas based on demonstrated need through public-private partnerships. Requires the approval of the Department of Education prior to the development of a public school for the pilot program on Department lands. Requires reports to the Legislature. Appropriates funds. Directs the conveyance of land on which Kaimuki Middle School is located from the City and County of Honolulu to the Department of Education. Effective 7/1/3000. (HD1)</p>	AGR, FIN



SB 2800, SD1, HD1 (HSCR1523-26) Status	RELATING TO IRRIGATION SYSTEMS. Appropriates funds to the Department of Agriculture and Biosecurity, Department of Land and Natural Resources, and Agribusiness Development Corporation to acquire, repair, and maintain irrigation systems in the State. Effective 7/1/3000. (HD1)	AGR, WAL, FIN
SB 2892, SD1, HD1 (HSCR1393-26) Status	RELATING TO FERAL CHICKENS. Appropriates funds to each county to facilitate the receipt, handling, and humane disposition of feral chickens that have already been caught. Effective 7/1/3000. (HD1)	AGR, FIN
SB 2321, SD1, HD1 (HSCR1390-26) Status	RELATING TO THE TWO-LINED SPITTLEBUG. Establishes a two-year Two-Lined Spittlebug Response Pilot Program to mitigate and control the spread of the two-lined spittlebug. Requires reports to the Legislature. Appropriates funds. Effective 7/1/3000. (HD1)	AGR, FIN

SB 2805, SD2, HD1 (HSCR1391-26) Status	RELATING TO AGRICULTURE. Establishes a nonrefundable income tax credit to incentivize significant investment in agricultural production and support the expansion of agricultural crops that take longer to become productive. SB 2153, SD2, HD1 (HSCR1389-26) Status	RELATING TO AGRICULTURE. Requires the Department of Agriculture and Biosecurity to convene a Bona Fide Farmer Working Group to develop multi-tiered, matrix-based definitions for the terms "bona fide farmer" and "bona fide agricultural activity". SB 2595, SD1, HD1 (HSCR1398-26) Status	RELATING TO THE AGRIBUSINESS DEVELOPMENT CORPORATION. Requires payments to the Agribusiness Development Corporation for letting, licensing, or renting of its properties to be at appraised market value rates or higher, except where the lessees, licensees, and tenants grow, raise, and harvest fresh local agricultural products for the Department of Education or are partner members of the Food and Product Innovation Network. SB 2781, SD1, HD1 (HSCR1394-26) Status	RELATING TO LEI. Requires and establishes benchmarks for each state executive agency to ensure that a certain percentage of lei purchased by that executive agency consists of lei made entirely of natural objects and plant materials grown, harvested, and assembled in the State. Establishes labeling requirements for lei and lei materials. Requires the disclosure of the geographic origin for the plant materials and natural objects that comprise a lei or lei materials. Requires state agencies that administer agricultural leases, licenses, development programs, or procurement involving agricultural products to award points or preferences to agricultural projects incorporating agricultural workforce housing. Requires the Department of Agriculture and Biosecurity to submit a report to the Legislature. Effective 7/1/3000. (HD2)

Amends the definition of "eligible business activity" for the purposes of the Enterprise Zone Program to include certain retail sales of tangible personal property, processing of certain value-added agricultural products, the Hawaii food and product innovation network, and the provision of certain professional services by health care professionals. For taxable years beginning after 12/31/2026, extends the eligibility period of the state business tax credit for qualified businesses within state enterprise zones. Beginning 1/1/2028, extends the eligibility period of the general excise tax exemption for qualified businesses within state enterprise zones. Applies to qualified businesses who join the Enterprise Zone Program on or after a specific date. Effective 7/1/3000. (HD1)

Authorizes the Department of Health to continue providing services statewide to Hansen's disease patients living in the community. Repeals sections of Chapter 326, HRS, to take effect upon the two-year anniversary of the passing of the last patient resident of Kalaupapa, as affirmed in a Governor's proclamation. Clarifies the HCDA's permitting and consultation powers regarding public projects within community development districts. Establishes the HCDD Special Fund. Appropriates funds. PART II: Appropriates funds from the Stadium Development Special Fund for the planning, design, and development of the HCDD, contingent upon certain requirements. Requires the Office of Planning and Sustainable Development to plan and serve in a coordinating role to develop shoreline adaptation pathways plans for regional shoreline mitigation districts designated by OPSD. Requires OPSD to coordinate shoreline adaptation pathways planning with the Department of Land and Natural Resources, applicable county and federal agencies, and the community. Requires OPSD to collaborate with community stakeholders and consider certain criteria when developing a shoreline adaptation pathways plan. Requires OPSD, upon finalization of a shoreline adaptation pathways plan to transmit the plan to the Board of Land and Natural Resources for approval. Authorizes BLNR to adopt a shoreline adaptation pathways plan after determining that the plan satisfies certain requirements. Establishes procedures for the review of state and county permits associated with regional shoreline mitigation districts. Establishes the support and integration of shoreline adaptation pathways planning as a policy under the Coastal Zone Management Program. Appropriates funds. Effective 7/1/3000. (HD1)
