| <u>SB 2448</u> <u>Status & Testimony</u> | RELATING TO THE DISCLOSURE OF INTIMATE IMAGES. Enacts the Uniform Civil Remedies for Unauthorized Disclosure of Intimate Images Act. | LBT, JDC |
| <u>SB 3046</u> <u>Status & Testimony</u> | RELATING TO INCOME TAX CREDIT. Establishes a nonrefundable Workforce Builder Tax Credit for employers who employ qualified interns and apprentices, to be applied to taxable years beginning after 12/31/2026. Requires a report to the Legislature. Appropriates funds. | LBT, WAM |
| <u>SB 2231</u> <u>Status & Testimony</u> | RELATING TO WORKFORCE DEVELOPMENT. Amends the State Internship and Workforce Development Program for the public sector by expanding the program to the Legislative and Judicial branches; limiting the internships to full-time placements of ten to eleven months; establishing eligibility criteria, application requirements, and selection preferences; and requiring the Department of Labor and Industrial Relations to collaborate with coordinating agencies to promote the program and recruit eligible applicants. Appropriates funds. | LBT, WAM |
| <u>SB 2526</u> <u>Status & Testimony</u> | RELATING TO EMPLOYMENT OF RETIRANTS. Authorizes the rehiring of retirants for positions that are unique and critical to operations. Limits the duration of each retirant's reemployment to 4 years. | LBT, WAM |
