RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

LBT, WAM/JDC

Allows a retainer employed as an investigator identified by the Department of Law Enforcement or Department of the Attorney General as a labor shortage or difficult-to-fill position to be rehired without reenrollment in the Employees' Retirement System and without a loss or interruption of retirement benefits, subject to certain conditions. Requires annual reports to the Legislature to include details on the employment of retainers as investigators.

Decision Making to follow, if time permits.

- Testifiers for this hearing will be limited to **1 minutes** each.
