

HB 2347 Status	RELATING TO VEHICLE SAFETY. Requires the Director of Transportation to adopt rules allowing for mobile vehicle safety inspections.	TRN, CPC
HB 1882 Status	RELATING TO MOTOR VEHICLES. Exempts motorcycles and passenger cars from safety inspections.	TRN, JHA
HB 2022 Status	RELATING TO MOTOR VEHICLE REGISTRATION. Specifies that the county annual vehicle registration fee is equal to the state annual motor vehicle registration fee.	TRN, FIN
HB 1708 Status	RELATING TO TRAFFIC SAFETY. Specifies that operating a vehicle under the influence of an intoxicant while a highly intoxicated driver is a class C felony and outlines additional requirements for probation.	TRN, JHA



HB 2086 Status	RELATING TO HIGHWAY SAFETY. Amends the offense of negligent injury in the first degree to include injuries negligently inflicted by intoxicated drivers.	TRN, JHA
HB 2154 Status	RELATING TO TRAFFIC SAFETY. Establishes a framework for the use of intelligent speed assistance technology for habitual speeders. Requires a report to the Legislature.	TRN, JHA
HB 2027 Status	RELATING TO TRANSPORTATION. Prohibits vehicles from driving on the shoulder of a roadway, except in certain circumstances. Authorizes the Department of Transportation and county police departments to impound vehicles with expired registrations of three years or more and seize and dispose of vehicles with expired registrations of five years or more, under certain conditions. Requires an annual report to the Legislature. Increases the fine amount for owners of out-of-state motor vehicles who fail to register the vehicle in the State. Establishes minimum and maximum statutory penalties for violations relating to the use of high occupancy vehicle lanes.	TRN, JHA
HB 2025 Status	RELATING TO LAW ENFORCEMENT. Prohibits digital navigation applications from providing an alert, indication, or other type of notice to users of the presence of law enforcement personnel or a law enforcement operation at any specific location.	TRN, JHA
HB 1620, HD1 (HSCR16-26) Status	RELATING TO ENERGY. Increases the environmental response, energy, and food security tax and the amount collected from the tax that is deposited into the electric vehicle charging system subaccount. Transfers funds from the hydrogen fueling system subaccount to the electric vehicle charging system subaccount. Effective 7/1/3000. (HD1)	EEP, TRN, FIN
HB 2179, HD1 (HSCR71-26) Status	RELATING TO TRANSPORTATION. Requires, rather than authorizes, the Department of Education to develop and administer a Traffic Safety Program. Requires the Department of Education's Traffic Safety Education program to include electric bicycles. Effective 7/1/3000. (HD1)	EDN, TRN, FIN

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least **24 hours** prior to the hearing. Testimony received after this time will be stamped late and left to the discretion of the chair to consider. While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may not be processed.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.

The chair may institute a per-testifier time limit.

Committees meeting in the morning must adjourn prior to the day's Floor Session. Therefore, due to time constraints, not all testifiers may be provided an opportunity to offer verbal comments. However, written submissions will be considered by the committee.



Please refrain from profanity or uncivil behavior. Violations may result in ejection from the hearing without the ability to rejoin.

For remote testifiers, the House will not be responsible for bad connections on the testifier's end.
