Clarifies administrative driver's license revocation procedures by requiring timely disclosure of documents, aligning review timelines, and standardizing administrative review and hearing processes.	TRS, JDC/WAM
<a href="#">SB 3313</a> <a href="#">Status &amp; Testimony</a>	RELATING TO INTERISLAND AIR SERVICE. Establishes a Hawaii Interisland Air Service Stability and Transformation Program to be administered by the Department of Taxation. Requires a covered interisland air service operator to issue an equity interest to the State as a condition of participation in the Hawaii Interisland Air Service Stability and Transformation Program. Establishes the Interisland Air Service Stability and Transformation Tax Credit. Sunsets 6/30/2036.	TRS, WAM/JDC
<a href="#">SB 3337</a> <a href="#">Status &amp; Testimony</a>	RELATING TO TAXATION. Eliminates state taxes on gasoline and diesel fuel for motor vehicles.	TRS, WAM
<a href="#">SB 2896</a> <a href="#">Status &amp; Testimony</a>	RELATING TO COMMERCIAL DRIVER'S LICENSES. Lowers the age of who may drive commercially within the State from nineteen to eighteen. Repeals the requirement that a person only operates category 3 vehicles to qualify to drive commercially in the State. Requires the Department of Transportation to amend its rules to lower the minimum age required for a commercial driver's license.	TRS, JDC
