<a href="#"><u>HB1509</u></a>	RELATING TO WORKERS' COMPENSATION. Requires an employer to file a response, either accepting or objecting to a treatment plan, within seven days of receipt. Imposes a monetary penalty if an employer does not file a response within the seven-day period. Clarifies that a treatment plan is deemed accepted if an employer fails to file certain documents within the seven-day period.	LAB, CPC
<a href="#"><u>HB1510</u></a>	RELATING TO LICENSE PLATES. Conditions the issuance of a certificate of inspection upon a vehicle not being equipped with any cover or shield installed over the license plate. Amends the penalty for obstruction of a license plate. Allows state or county parking enforcement officers to issue citations for vehicles with a cover or shield obstructing the license plate. Repeals the requirement that a cover or shield be intended to alter or interfere with the visibility, legibility, or identification of a license plate by law enforcement or traffic enforcement systems. <a href="#"><u>HB1511</u></a>	RELATING TO CONSUMER PROTECTION. Prohibits certain entities from distributing unsolicited mail or electronic mail that is reasonably likely to cause a consumer to believe that a vehicle manufacturer, dealer, mortgage loan originator, mortgage servicer, or insurance company is asking the consumer to send money to extend a vehicle warranty or home warranty, unless certain disclosures are met. Makes contracts that fail to meet disclosure requirements voidable at the option of the consumer.	CPC, JHA
<a href="#"><u>HB1512</u></a>	RELATING TO HEALTH. Beginning 1/1/2027, prohibits the sale of flavored nicotine products and nicotine product flavor enhancers and the mislabeling of e-liquids as nicotine free. Establishes penalties for violations. Authorizes the Department of Health to appoint, commission, or contract for services of inspectors. Establishes positions. Appropriates funds.	HLT, CPC/JHA, FIN
<a href="#"><u>HB1513</u></a>	RELATING TO CONDOMINIUMS. Authorizes the issuance of reimbursable general obligation bonds to provide the necessary funds for the Condominium Loan Program. Appropriates funds from the Hurricane Reserve Trust Fund to provide initial coverage of the bond payments.	CPC, FIN

<a href="#"><u>HB1514</u></a>	RELATING TO WORKERS' COMPENSATION. Clarifies the process for selecting a certified provider of rehabilitation services. Requires providers to automatically approve vocational rehabilitation services for an injured employee if those services will likely be required for suitable gainful employment. Requires providers to file an employee's vocational plan no later than ninety days after submitting an initial evaluation report, with certain exceptions.	LAB, CPC
<a href="#"><u>HB1515</u></a>	RELATING TO WORKERS' COMPENSATION. Authorizes an attending physician to request a functional capacity examination and refer an injured employee for the examination without first obtaining permission from the employee's employer. Allows licensed occupational and physical therapists to be deemed qualified to perform functional capacity examinations.	LAB, CPC
<a href="#"><u>HB1516</u></a>	RELATING TO PRETRIAL RELEASE. Requires certain factors to be considered when determining a defendant's financial ability to afford bail.	JHA
<a href="#"><u>HB1517</u></a>	RELATING TO SENTENCING REVIEW. Establishes a procedure for incarcerated individuals who have served at least ten years of their sentence to petition the court for a sentence reduction. Requires the Department of Corrections and Rehabilitation to report to the Legislature Hawaii Paroling Authority, and Hawaii Correctional System Oversight Commission.	PBS, JHA
<a href="#"><u>HB1518</u></a>	RELATING TO THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM. By 1/1/2028, requires the Department of Human Services, upon obtaining a federal waiver, to establish a pre-release Supplemental Nutrition Assistance Program (SNAP) application process for inmates nearing release. Allows all individuals convicted of an offense involving the possession, use, or distribution of a controlled substance to apply for SNAP benefits, regardless of treatment status.	HSB, PBS, FIN

<a href="#"><u>HB1519</u></a>	<p>RELATING TO CAMPAIGN CONTRIBUTIONS.</p> <p>Requires disclosure of the names of compensated officers, and their immediate family members, of state or county contractors and grantees with contracts or grants exceeding \$250,000. Prohibits the compensated officers of state or county contractors, and their immediate family members, from making or soliciting certain campaign contributions for the duration of the contract exceeding \$250,000. Prohibits state or county grantees, including compensated officers and their immediate family members, from making or soliciting certain contributions for the duration of the grant exceeding \$250,000. Requires unlawful contributions to be returned to the contributor or escheat to the Hawaii Election Campaign Fund.</p>	JHA, FIN

<a href="#"><u>HB1521</u></a>	<p>RELATING TO GOVERNMENT CONTRACTS.</p> <p>Clarifies that records created, received, maintained, or used by private contractors performing government functions on behalf of public agencies shall be subject to the Uniform Information Practices Act.</p>	JHA, FIN
<a href="#"><u>HB1522</u></a>	<p>RELATING TO DISCRIMINATION.</p> <p>Lengthens the statute of limitations to file a complaint of discrimination with the Hawaii Civil Rights Commission to one year.</p>	JHA
<a href="#"><u>HB1523</u></a>	<p>RELATING TO THE STATEWIDE TRAFFIC CODE.</p> <p>Removes references to countdown timers as it relates to pedestrian-control signals, including the requirement that pedestrians must begin crossing a roadway before a countdown timer begins.</p>	TRN, JHA
<a href="#"><u>HB1524</u></a>	<p>RELATING TO PEDESTRIANS.</p> <p>Establishes that fines for pedestrian violations under chapter 291C, Hawaii Revised Statutes, shall not exceed \$25. Prohibits discrimination based on: (1) The perception that a person possesses certain characteristics; (2) The perception that a person is associated with a person who possesses, or is perceived to possess, certain characteristics; or (3) The intersection or combination of two or more specified characteristics in relation to a person. <a href="#"><u>HB1527</u></a>	RELATING TO GAMBLING. Prohibits any casino, gambling enterprise, or gambling facility from being located on state lands within or adjacent to the Aloha Stadium Development District project area or on any lands under the jurisdiction of the Stadium Authority. Prohibits athletic programs of the University of Hawaii from competing in venues that are operated by or physically integrated with a gambling enterprise while clarifying that standard naming-rights or advertising agreements do not constitute prohibited sponsorships. <a href="#"><u>HB1528</u></a>	PROPOSING AN AMENDMENT TO ARTICLE VI, SECTION 3, OF THE HAWAII STATE CONSTITUTION TO INCREASE THE MANDATORY RETIREMENT AGE FOR STATE JUSTICES AND JUDGES. Proposes a constitutional amendment to increase the mandatory retirement age for justices and judges from seventy to seventy-five years of age.	JHA, FIN

Requires any person applying to the Department of Health to contract or extend or renew a contract to operate certain residential treatment programs to, as a condition of the contract, obtain and maintain a general liability insurance policy with a certain minimum coverage amount; submit to the Department for review and approval a community safety action plan; and provide to the community association or neighborhood board in the community in which the program will operate a written notice of the program's establishment and location and the community safety action plan. <a href="#"><u>HB1531</u></a>	RELATING TO EMERGENCY ANNOUNCEMENTS. Requires the Governor or mayor of a county to provide an American Sign Language interpreter during each official announcement broadcast via television or the Internet during a state of emergency. Requires the Governor or mayor of a county to ensure, to the fullest extent possible, that the American Sign Language interpreter's face, body, arms, and hands are visible during the broadcast. Requires a news media outlet to display the American Sign Language interpreter in a picture-in-picture window during broadcasts of official emergency announcements.	PBS, JHA
<a href="#"><u>HB1532</u></a>	RELATING TO TAXATION. Excludes from the offense of unlawful shipment of tobacco products the direct sale of large cigars and pipe tobacco to adult consumers for personal use. Effective 1/1/2027.	HLT, CPC, FIN
<a href="#"><u>HB1533</u></a>	RELATING TO THE MINIMUM WAGE. Repeals the minimum wage and tip credit increases that are to occur on 1/1/2028.	LAB, FIN
<a href="#"><u>HB1534</u></a>	RELATING TO JURY DUTY. Allows actively practicing advanced practice registered nurses to claim exemption from service as a juror.	HLT, JHA
<a href="#"><u>HB1535</u></a>	RELATING TO AUTOMATED EXTERNAL DEFIBRILLATORS. Establishes an income tax credit for the purchase and installation of automated external defibrillator devices by certain places of public accommodation.	HLT, FIN

Requires insurers, mutual benefit societies, and health maintenance organizations to provide coverage for the cost of prosthetic devices, including activity-specific prostheses, and orthotic devices for policies, contracts, plans, and agreements issued or renewed on or after 1/1/2027. Establishes an unspecified minimum yearly benefit for prosthetic devices and orthotic devices.	HLT, CPC, FIN

Requires the Department of Health to adopt rules to allow hospitals to demonstrate compliance with all licensing inspections required by the State through accreditation or certification by any accreditation or certification organization recognized by the Centers for Medicare and Medicaid Services. <a href="#">HB1539</a>	RELATING TO PRESCRIPTION DRUGS. Repeals certain prohibitions on the imposition of fees, conditions, or requirements on community retail pharmacies that are not imposed on mail order pharmacies.	HLT, CPC
<a href="#">HB1540</a>	RELATING TO HOME HEALTH LICENSING. Authorizes the Department of Health to accept accreditation from an accreditation organization or a certification organization recognized by the Centers for Medicare and Medicaid Services as demonstration that a licensed home health agency is in compliance with all licensing inspections required by the State. Specifies conditions under which a home health agency may be exempt from a licensing inspection on a continuing basis. Requires information obtained in reports of survey and accreditation or certification letters to be public information.	HLT, CPC
<a href="#">HB1541</a>	RELATING TO THE DEPARTMENT OF HEALTH. Exempts certain positions in the Developmental Disabilities Division of the Department of Health and Hawaii State Hospital from civil service. Authorizes the Director of Health to appoint two additional associate administrators and two project managers for the Hawaii State Hospital or a secure psychiatric rehabilitation facility. Requires enforcement by the Department of Health.</p>	HLT, CPC, JHA
<a href="#"><u>HB1543</u></a>	<p>RELATING TO ENVIRONMENTAL REVIEW.</p> <p>Specifies a time limit for the validity of a finding of no significant impact of a final environmental assessment or acceptance of a final environmental impact statement for a proposed action. Requires an agency or applicant to commence a new environmental review process for the proposed action if the validity expires.</p>	EEP, JHA
<a href="#"><u>HB1544</u></a>	<p>RELATING TO ENVIRONMENTAL ASSESSMENTS.</p> <p>Requires that an environmental assessment be conducted and an environmental impact statement be prepared for any proposed use within historic properties considered significant or recognized as a traditional cultural property.</p>	EEP, WAL, JHA
<a href="#"><u>HB1545</u></a>	<p>RELATING TO HEALTH CARE PLANS FOR WORKERS.</p> <p>Requires the Department of Labor and Industrial Relations, in consultation with the Insurance Commissioner, to establish and implement a five-year voluntary Nontraditional Workforce Portable Health Care Benefit Plan Pilot Program that offers high deductible health plans or catastrophic health plans to nontraditional workers who are ineligible for health benefits provided by the Hawaii Employer-Union Health Benefits Trust Fund or prepaid health care plans under the Prepaid Health Care Act. Requires reports to the Legislature. Appropriates funds.</p>	LAB, CPC, FIN

<a href="#"><u>HB1546</u></a>	<p>RELATING TO HEALTH INSURANCE.</p> <p>Establishes a three-year Health Coverage Continuity Pilot Program within the Department of Human Services, in consultation with the Department of Commerce and Consumer Affairs, to assist individuals who have lost Medicaid health insurance coverage and lack access to other health insurance options. Authorizes the Department of Human Services to contract with a nonprofit health insurer or community-based organization to operate the Pilot Program; provided that the Department shall allow the operator to access state-backed reinsurance or risk stabilization support for the operator of the Pilot Program. Authorizes the Department of Human Services to: (1) Issue premium subsidies or vouchers; and (2) Accept employer contributions; provided that the benefit shall be portable and follow the individual without imposing compliance or administrative obligations on the State or an employer. Requires reports to the Legislature. Repeals 6/30/2029.</p>	HSB, CPC, FIN
<a href="#"><u>HB1547</u></a>	<p>RELATING TO HEALTH SAVINGS ACCOUNTS.</p> <p>For taxable years beginning 1/1/2026, establishes a tiered nonrefundable tax credit for qualified taxpayer insurers that offer one or more federally qualified health savings account-eligible high deductible health plans in the State, under certain conditions, and increasing the tax credit to incentivize more plans being written in rural medically underserved areas of the State. Requires qualified taxpayer insurers to match up to a certain amount of a policyholder's first-time contribution into a health savings account. Sunsets 12/31/2030.</p>	HLT, CPC, FIN
<a href="#"><u>HB1548</u></a>	<p>RELATING TO SENTENCING.</p> <p>Limits the maximum term of imprisonment for misdemeanors, or for offenses punishable by up to or not exceeding one year, to three hundred sixty-four days. Allows individuals previously sentenced to a one-year term of imprisonment to apply to the court for a sentence modification to conform to the new limit.</p>	JHA
<a href="#"><u>HB1549</u></a>	<p>RELATING TO CONTROLLED SUBSTANCES.</p> <p>Repeals the law prohibiting drug paraphernalia under the Uniform Controlled Substances Act.</p>	HLT, JHA
<a href="#"><u>HB1550</u></a>	<p>RELATING TO HEALTH.</p> <p>Excludes drug testing products from the definition of drug paraphernalia under the Uniform Controlled Substances Act.</p>	HLT, JHA

Requires any existing habitat conservation plan that does not include an agreement for emergency medical and rehabilitation services to affected native wildlife to be amended to include the agreement, and the amended rights and obligations under the habitat conservation plan to be recorded by a certain deadline. Beginning with the 2026-2027 school year, requires public charter schools participating in the National School Lunch Program to provide free meals to students whose family income is no more than three hundred per cent of the federal poverty level. Appropriates funds.	EDN, FIN
<a href="#"><u>HB1562</u></a>	RELATING TO YOUTH MENTAL HEALTH. Establishes and appropriates funds for a one-year Digital Youth Mental Health Platform Pilot Project that will enable the Child and Adolescent Mental Health Division of the Department of Health to develop and make publicly available a digital platform designed to help young people address and manage mental health challenges. Requires a report to the Legislature.	HLT/HSB, FIN
<a href="#"><u>HB1563</u></a>	RELATING TO TOBACCO PRODUCTS. Repeals existing law that preempts local ordinances or regulations that regulate the sale of cigarettes, tobacco products, and electronic smoking devices and voids any existing local laws and regulations conflicting with the state law governing smoking. Allows counties to adopt ordinances that regulate the sale of cigarettes, tobacco products, and electronic smoking devices that do not conflict with and are more stringent than the state law that governs smoking.	HLT, CPC, FIN
<a href="#"><u>HB1564</u></a>	RELATING TO TRANSPORTATION. Establishes safe riding behaviors for electric bicycles. Prohibits the operation of high-speed electric devices in certain locations. Beginning 12/31/2026, establishes labeling and signage requirements for electric bicycles. Prohibits the operation of a moped or electric motorcycle in certain locations. Amends the definition of "bicycle" for purposes of county vehicular taxes. Defines "electric bicycle" in place of "low-speed electric bicycle". Defines "electric micro-mobility device" and requires the same regulations as electric foot scooters. Prohibits a person under the age of sixteen from operating a class 3 electric bicycle. Authorizes a person under the age of fourteen to operate class 2 electric bicycles under supervision. Prohibits a person from riding a class 3 electric bicycle on a sidewalk. Authorizes a person to ride a class 1 or class 2 electric bicycle on a sidewalk under certain circumstances. Prohibits a person from operating a bicycle or electric foot scooter under the age of eighteen without a helmet. Repeals the requirement that moped drivers use bicycle lanes. Substitutes the term "motor-driven cycle" with the term "motor scooter".	TRN, JHA

<a href="#"><u>HB1566</u></a>	<p>RELATING TO ENERGY EFFICIENCY.</p> <p>Requires each state agency to expeditiously use energy efficient lighting. Requires the Hawaii State Energy Office to provide technical assistance and survey state agencies for compliance, prioritizing first responder facilities. Requires the Department of Accounting and General Services to assist the Hawaii State Energy Office in conducting the survey. Requires a report of the survey to the Legislature.</p>	EEP, FIN
<a href="#"><u>HB1567</u></a>	<p>RELATING TO ENERGY EQUITY.</p> <p>Requires the Public Utilities Commission to establish residential electricity rate structures that prioritize affordability and equity. Requires the Public Utilities Commission to establish a lifeline baseline performance standard, a medical essential needs energy program, and a new tariff. Requires electric utilities to file revised tariffs no later than twelve months after the Public Utilities Commission has issued a final decision and order under this Act. Requires the Public Utilities Commission to convene a stakeholder process for developing and implementing this Act.</p>	EEP, CPC, FIN
<a href="#"><u>HB1568</u></a>	<p>RELATING TO ENERGY.</p> <p>Prohibits, after 6/30/2026, the importation or storage of liquefied natural gas; the construction, expansion, or operation of liquefied natural gas infrastructure; and state agencies or counties from issuing a permit or lease that enables the development or expansion of liquefied natural gas, with certain exemptions. Authorizes the Public Utilities Commission and Department of Health to adopt rules for the enforcement and compliance of the prohibition. Repeals a provision from the Hawaii State Planning Act making it a policy of the State to use liquefied natural gas as a transitional, limited-term replacement of petroleum. Prohibits, after 6/30/2026, the approval of a new or renewed purchase agreement that proposes to supply a utility with liquefied natural gas and the modification of an existing liquefied natural gas purchase agreement that proposes to extend the term or increase the amount of liquefied natural gas that is supplied under the existing agreement.</p>	EEP, CPC, FIN

Phases in requirements that all newly manufactured washing machines sold within the State by January 1, 2042, be equipped with a microfiber filter. Requires certification that newly manufactured washing machines have microfiber filters. Establishes penalties.	EEP, CPC, JHA
<a href="#"><u>HB1570</u></a>	RELATING TO NEONICOTINIDS. Beginning 1/1/2027, prohibits the sale, possession, or use of a pesticide containing one or more neonicotinoid pesticides, under certain conditions.
