- 1 **Department Position:** The Department of Health ("Department") supports the nomination and
- 2 confirmation of Mary Pat Waterhouse to the State Council on Mental Health ("Council").
- 3 **Department Testimony:** Hawai'i Revised Statutes §334-10 establishes the State Council on
- 4 Mental Health within the Department for administrative purposes to advise the Department on
- 5 the allocation of resources, statewide needs, and programs affecting two or more service areas.
- 6 It serves as an advocate for adults with serious mental illness, children with serious emotional
- 7 disturbances, other individuals with mental illnesses or emotional problems, and individuals
- 8 with combined mental illness and substance abuse disorders. The Council's mandate includes
- 9 reviewing and commenting on the statewide comprehensive, integrated service plan. It also
- 10 serves as the State Planning Council for purposes of the federal Mental Health Block Grant
- 11 program. The Council can have up to twenty-one members, of whom a majority should be non-
- 12 providers of mental health services. The majority should also be non-state employees. The
- 13 mandate seeks that all service area boards of the State are represented, and there is adequate
- 14 representation of parents and children with serious emotional disturbances. It requires the

1 Council to have members from the principal state agencies concerning mental health,
2 education, vocational rehabilitation, criminal justice, housing, Medicaid, and social services;
3 Public and private entities concerned with the need, planning, operation, funding, and use of
4 mental health services and related support services; Adults with serious mental illnesses who
5 are receiving, or have received, mental health services; The families of such adults or families of
6 children with serious emotional disturbances; and the Hawai'i Advisory Commission on Drug
7 Abuse and Controlled Substances.

8 This nomination represents a second term of Mary Pat Waterhouse in the non-provider
9 family member seat, and we are grateful for her continued commitment. Her diligent,
10 collaborative leadership has elevated the work of the Council. She was elected Secretary by her
11 peers, chairs the ad hoc legislative committee, and contributes actively to several others. Her
12 ability to bridge perspectives comes not only from her lived experience as a family member, but
13 also from her service in government and long-standing community volunteer work.

15 Mary Pat Waterhouse.
