Executive Office on Early Learning's Position: **SUPPORT**

The Executive Office on Early Learning (EOEL) offers the following comments in support of H.B. No. 2567 and defers to the Department of Budget and Finance regarding implementation and funding of the proposed special fund.

EOEL appreciates the Legislature's consideration of a dedicated revenue stream to support early childhood education. This proposal follows the lead of states such as Connecticut and Montana, which recently established trust funds or endowments to provide sustained support for early learning initiatives. Establishing an investment fund seeded with a general fund appropriation, with investment returns deposited into the Early Learning Special Fund, represents a thoughtful and forward-looking approach to long-term system financing.

A dedicated revenue stream for the Early Learning Special Fund would create new opportunities to pursue a broader range of initiatives that strengthen Hawai'i's mixed-delivery system statewide. Stable, ongoing funding would allow the State to plan strategically and respond more effectively to the needs of families with young children.

The early years are critical for brain development and lay the foundation for lifelong learning, health, and well-being. We appreciate the Legislature's ongoing investment and shared commitment to strengthening Hawai'i's early learning system for our youngest keiki and their 'ohana. Thank you for the opportunity to share these comments in support of H.B. No. 2567.

Dear Chair Woodson, Vice Chair La Chica, and Respected Committee Members,

Hawai'i Children's Action Network (HCAN Speaks!) writes in **strong support** of **HB2567**, which establishes an Early Childhood Education Investment Special Fund to be administered by the Department of Budget and Finance, with investment returns transferred to the Early Learning Special Fund.

Hawai'i has made significant strides in its efforts to deliver on Act 46 (2020) to provide Universal Access to early learning for all three- and four-year-olds by 2032. These efforts have been instrumental in helping to support working families and prepare children for kindergarten. However, relying solely on budget cycles creates volatility and threatens the long-term sustainability of these efforts.

HB2567 creates a financing mechanism designed to generate ongoing investment income dedicated to early learning, helping stabilize supports and continued investment. A growing number of states have implemented similar models to that proposed in HB 2567.

- Connecticut Early Childhood Education Endowment: a structured invest-and-distribute model<sup>1</sup>.
- New Mexico Early Childhood Education and Care Fund: an endowment-like fund within the state treasury, with investment income credited back to the fund and managed through the state's investment framework<sup>2</sup>.
- Montana Early Childhood Account: funded through a share of interest earnings from a broader state trust structure, with eligible uses tied directly to childcare/early learning workforce and access strategies<sup>3</sup>.

Early Childhood Action Strategy (ECAS) is a statewide cross-sector collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS partners work to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki.

**ECAS supports House Bill 2567 which would establish the Early Childhood Education Investment Fund.**

In recent years, communities around the country have voted to establish dedicated taxes, levies, and trust funds in order to adequately fund early childhood education and care. Many of these communities have been highly successful in using these strategies to create new and consistent revenue streams to support early childhood initiatives.

For example, New Mexico passed a constitutional amendment directing a portion of funds generated by oil and gas production to support early childhood education. Meanwhile, Massachusetts established a “millionaire’s tax” which adds an additional tax to income over \$1M and dedicated a portion of these tax revenues to fund education efforts.

**With this in mind, ECAS is in support of this measure as it would create a dedicated funding mechanism to support early childhood education programs.** However, we do feel strongly that additional language must be included in this measure, detailing clear parameters regarding how funds in the Early Childhood Education Investment Fund may be directed.
