My name is Dr. Mel Ona, and I am a resident of East Honolulu. I write in strong support of HCR 165, which advances the installation of permanent lighting and pickleball infrastructure at Kamilo Iki Community Park.

This resolution builds directly upon a meaningful step already taken by our community. On March 25, 2026, the Honolulu City Council adopted Resolution 26-045, accepting a gift from my wife, Jennifer, me, and our pickleball friends to install three permanent pickleball net systems at the park. This initial phase represents half of the six dedicated courts and reflects both the growing demand and the community's commitment to activating this space.

What we have witnessed is remarkable! Pickleball has become a unifying force. Families, keiki, working adults, and kupuna are coming together in a shared space of movement, connection, and joy. It is one of the rare activities that transcends age, skill level, and background.
