Thank you for the opportunity to testify on this bill. The Campaign Spending Commission (“Commission”) strongly supports this bill.

Hawaii’s partial public financing program mandated by the State Constitution is funded by the Hawaii election campaign fund (“HECF”) which receives its funds in large part from the state income tax check-off program. Currently, an individual whose state income tax liability is \$3 or more may designate \$3 of the liability to be paid to the HECF. For joint income tax returns of spouses, spouses with an income tax liability of \$6 or more, may each designate \$6 to be paid to the HECF. This bill aims to double the income tax check off option for individuals and joint spouse filers thereby increasing the potential for money to be paid to HECF.

As of June 30, 2025, the HECF has \$2,412,282.94 which is enough money to fund the partial public financing program for candidates for the primary election but is not sufficient to fund candidates for the general election. In order to have a more robust and viable partial public financing program, the Commission would need to boost income to the HECF. Increasing the income tax check off would help make the partial financing program a viable option for candidates.

The Commission requests that this committee pass this measure.

The Department of Taxation (DOTAX) offers the following comments regarding S.B. 2462 for your consideration.

S.B. 2462 increases the amount that taxpayers may designate from their individual income tax refunds to the Hawai'i Election Campaign Fund. Specifically, Section 2 amends section 235-102.5(a), Hawai'i Revised Statutes (HRS), by increasing the designated income "check-off" amount from \$3 to \$6 for taxpayers filing individual returns with \$6 or more of state income tax liability, and from \$3 to \$6 for each taxpayer spouse filing joint returns with \$12 or more of state income tax liability.

Upon approval, the bill applies to taxable years beginning after December 31, 2025. DOTAX can administer the bill with this effective date.

Aloha Chair Rhoads, Vice Chair Gabbard and Members of the Committee,

BILL NUMBER: SB 2462

INTRODUCED BY: RHOADS, CHANG, MCKELVEY, San Buenaventura

EXECUTIVE SUMMARY: Increases designated income check-off amounts for the Hawai'i Election Campaign Fund to \$6 for taxpayers filing individual returns with \$6 or more of state income tax liability and for spouses filing joint returns with \$12 or more of state income tax liability.

SYNOPSIS: Amends section 235-102.5, HRS, to double the existing \$3 income tax check-off for the benefit of the Hawai'i Election Campaign Fund.

EFFECTIVE DATE: Taxable years beginning after December 31, 2025.

STAFF COMMENTS: In the long run, the cost of administering the income tax checkoff merely siphons resources that should otherwise be used for providing needed public services. If lawmakers believe certain programs are of great importance, then they can prioritize those programs through the appropriations process. With the Hawaii tax burden already so heavy, why should taxpayers turn any more of their hard-earned dollars over to government? What lawmakers also do not recognize is that by creating these checkoffs, they add to the cost of administering the law, a cost which steals funds from other programs including those enumerated for a checkoff designation.

Aloha, my name is Jordan Kapono Nakamura and I'm a Honolulu resident testifying in strong support of this bill. This will help rectify the stagnancy of Hawai'i's funding amounts and expenditure limits which have remained unchanged for 30 years and counting. The value of a dollar in Hawai'i is far lower than in other places with higher wages and lower costs of living and rent averages, making the already expensive endeavor of running to be a public servant holding office almost exclusively the province of individuals who have numerous wealthy contacts, are well-off themselves, or are willing to take corporate money to run successful campaigns.
