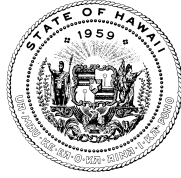

Aloha Chairs Richards and San Buenaventura, Vice Chairs Lamosao and McKelvey,
and members of the Committees:

The Department of Hawaiian Home Lands (DHHL) **supports** this resolution requesting the Department of Hawaiian Home Lands and the Statewide Office on Homelessness and Housing Solutions to develop a coordinated support and stabilization pathway for Native Hawaiian beneficiaries experiencing homelessness or extremely low income.

DHHL supports the intent of this resolution which notes much of the work that DHHL is currently doing. In January 2026, DHHL commemorated the completion of DHHL's first transitional housing facility for native Hawaiians experiencing houselessness, named Hale o Kumumamo. DHHL began the renovation process for this federally funded project, amounting to more than \$6.4 million, in September 2024.

DHHL appreciates that this resolution prioritizes its beneficiaries and recognizes how crucial partnerships are in serving native Hawaiian houseless populations and extremely low-income beneficiaries. DHHL supports developing coordinated support and stabilization pathways for Native Hawaiian beneficiaries in coordination with the Statewide Office on Homelessness and Housing Solutions.

Comments:

Aloha,

At the outset, I wish to commend the author of this resolution for recognizing the unique responsibility to Native Hawaiian beneficiaries and the urgent need to address homelessness and extreme economic hardship within our lāhui. The intent of this measure—to bring together the Department of Hawaiian Home Lands and the Statewide Office on Homelessness and Housing Solutions—is both timely and necessary.

For too long, our beneficiaries have had to navigate fragmented systems of care. This resolution appropriately acknowledges that without coordination, individuals and ‘ohana may fall through the cracks. A more unified pathway that aligns housing, supportive services, and long-term stabilization resources reflects a mālama-centered approach that is consistent with our values as a community.

We especially support the resolution’s focus on:

- Identifying the scope of need among beneficiaries experiencing homelessness or extremely low income;
- Evaluating gaps in housing stabilization and supportive services;
- Exploring partnerships with nonprofit providers; and
- Identifying funding sources to better align existing resources.

These are practical and necessary first steps toward building a more responsive and effective system of care.

COMMENTS AND RECOMMENDATIONS

While I support the intent of this resolution, I respectfully offer the following comments to strengthen its implementation:

First, the scope of work requested is broad and spans multiple complex systems, including data integration, interagency coordination, land use considerations, and housing development models. Each of these areas presents unique challenges. As such, I emphasize that this effort should be approached as a **phased planning process**, with clear prioritization of achievable near-term actions and longer-term strategies.

Second, the evaluation of transitional housing models, including kauhale or tiny home villages on Department of Hawaiian Home Lands lands, must be undertaken with careful attention to the **Hawaiian Homes Commission Act and the State's trust obligations**. Land use decisions within the trust require thoughtful analysis to ensure that proposed uses are consistent with the intent to benefit beneficiaries and do not create unintended legal or operational complications.

Third, while identifying funding sources is important, we note that alignment and access to those funds—particularly across federal, state, and trust-based programs—may require additional policy changes, administrative coordination, and sustained resources beyond the scope of this resolution.

Finally, encourage that any coordinated pathway developed through this process include **clear beneficiary-centered design**, cultural grounding, and meaningful engagement with organizations that serve Native Hawaiian communities to ensure that solutions are both effective and appropriate.

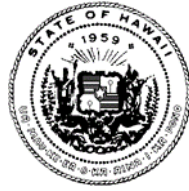
CONCLUSION

AGENCY'S POSITION: The Statewide Office on Homelessness and Housing Solutions (SOHHS) supports this resolution and offers comments. This resolution urges the Department of Hawaiian Home Lands (DHHL) and SOHHS to develop a coordinated support and stabilization pathway for Native Hawaiian beneficiaries experiencing homelessness or extremely low income. The coordinating agencies are requested to submit a report regarding the development of a coordinated support and stabilization pathway to the Legislature no later than twenty days prior to the convening of the Regular Session of 2027.

SOHHS welcomes the opportunity to continue to partner with DHHL to identify opportunities to support Native Hawaiian beneficiaries experiencing homelessness. Compared to the general population, Native Hawaiians are over-represented in the state's homeless

population. Furthermore, Native Hawaiians often experience higher rates of food insecurity and health disparities compared to other ethnic groups, which can exacerbate housing and economic challenges that lead to homelessness.

The recent opening of the Hale o Kumumamo transitional living facility for Native Hawaiian beneficiaries experiencing homelessness is one example of leveraging State and federal resources to create transitional housing specifically for beneficiaries experiencing homelessness. Hale o Kumumamo provides safe, supportive living spaces to 18 beneficiaries identified through DHHL and the Continuum of Care. The creation of intermediate housing resources, including transitional housing and rental housing, is a key component of the housing ladder, as these resources give households the opportunity to continue to transform their lives and work toward upward mobility with increasing levels of independence. SOHHS will continue to partner with DHHL and other public and private sector partners to create housing opportunities for Native Hawaiian beneficiaries experiencing homelessness and housing instability.
