**SUBJECT:** SCR179 – Urging the County of Maui to Enforce the Provisions of the Fire Code of the County of Maui Relating to Fire Hazards, Brush Clearance, Fuel Breaks, Roadside Vegetation Clearing, and Emergency Access.

Chair and Members of the Committee:

Aloha Independent Living Hawaii (AILH) **supports SCR179**, which urges the County of Maui to actively enforce Fire Code provisions relating to fire hazards, brush clearance, fuel breaks, roadside vegetation clearing, and emergency access. Disabled residents, including wildfire survivors, continue to live in temporary and permanent housing in West Maui, and their safety depends on reliable evacuation routes, accessible ingress and egress, and proactive management of hazardous fuels near homes and roads. Strong, visible enforcement of these existing Fire Code requirements is essential to protect lives, housing, and major access corridors into and out of Lahaina, particularly for people who may need more time, assistance, or equipment to evacuate.

AILH also supports the Resolution's emphasis on enforcement near residential communities, temporary housing sites for wildfire survivors, and major evacuation corridors. From a cross-disability and Independent Living perspective, enforcement of brush clearance and fuel breaks must be paired with ongoing communication and coordination that reaches disabled
