Chair Hee, Vice Chair Shimabukuro, and members of the Committee:

I am pleased to express strong support for the confirmation of Judge Richard W. Pollack to the Supreme Court as Associate Justice.

As I stated when I announced his appointment at a press conference on June 5, 2012, "[t]he core values of the Constitution and Hawai'i are well met in Judge Pollack." I wholeheartedly believe and stand by that statement.

In looking at his background and extensive work experience, and community involvement, Judge Pollack has displayed superlative knowledge and character in all duties -- most recently as a judge, but also in his practice of the law and his teaching of the law and his writings about the law. I have complete confidence that he will excel as Associate Justice of the Hawai'i Supreme Court.

He has been serving as a judge in the Circuit Court since 2000, presiding over the civil and criminal trial calendar. He served as a substitute justice and substitute Intermediate Court of Appeals judge on numerous occasions.

Prior to his appointment to the circuit court bench, Judge Pollack served as the State Public Defender from 1987 to 2000. He managed a statewide office of 99 attorneys and was actively involved in appellate work during his tenure.

Notably, in 1983, Judge Pollack served as Trial Practitioner, supervising the Maui

branch of the Office of the Public Defender. In this capacity, Judge Pollack handled such cases as *State v. Poepoe* – the first case in the State and one of the few nationwide at the time relating to PTSD in a criminal case.

In addition to his work experience, Judge Pollack is a notable instructor. Currently, Judge Pollack is an Adjunct Professor at the University of Hawai'i William S. Richardson School of Law. Over the past two years, he has been teaching on a pro bono basis, devoting around 500 hours annually to educating our future leaders. Over the past twelve years, Judge Pollack has also been a faculty presenter for attorneys as well as judges at numerous venues, notably the National Institute of Trial Advocacy Outreach Program for public sector lawyers, Roscoe Pound Institute Regional Judges Forum and the Hawai'i State Bar Association.

Judge Pollack earned a B.A. with honors from the University of California at Santa Barbara and his J.D. from Hastings School of Law in San Francisco. Typical of his character, he soon afterward dedicated a year to teaching at Kapsowar Secondary School in Eldoret, Kenya.

A distinguished author, he has written and co-authored numerous Training Manuals for deputy public defenders. Judge Pollack has also served on many committees, some of which include the Hawai'i Advisory Commission on Drug Abuse and Controlled Substances, Corrections Population Management Commission, and the Hawai'i State Bar Committee on Judicial Administration.

It is for these reasons that I am confident that the core values of the Constitution and Hawai'i are well met in Judge Pollack. His confirmation to the State's highest court will benefit the lives of the people of Hawai'i. I encourage you to confirm Judge Pollack to the Supreme Court as Associate Justice.

The Board of Directors of the Hawaii State Bar Association appreciates the opportunity to comment on the qualifications of Richard W. Pollack for the position of Associate Justice of the Hawaii Supreme Court.

The HSBA Board has established criteria for determining the qualifications of judicial appointments generally utilizing the American Bar Association Guidelines for Reviewing Qualifications of Candidates for State Judicial Office. The HSBA uses the following criteria in its deliberations: integrity and diligence, legal knowledge and ability, professional experience, judicial temperament, financial responsibility, public service, health, and responsibilities and duties required of the position for which the applicant has been nominated. The HSBA Board's rating system includes the categories of "qualified" and "not qualified."

As part of its procedures for evaluating and taking positions on judicial appointments, the HSBA Board utilizes a subcommittee of the HSBA Board to review materials presented by the nominee and input from members. The subcommittee is also tasked with checking references and contacting others who have knowledge of the nominee's experience and qualifications. The full Board reviews the materials prepared by this subcommittee, the materials submitted by the nominee and members, and conducts an interview of the nominee.

Taking into consideration all of the information presented by and about the nominee and an interview with the nominee, the Board of Directors of the Hawaii State Bar Association finds Richard W. Pollack to be qualified for the position of Associate Justice of the Hawaii Supreme Court.

GM1: Nomination of Richard W. Pollack to the Supreme Court of Hawai'i

Chair Hee and Committee Members:

It is a privilege for me to support Richard W. Pollack's nomination to be an Associate Justice of the Supreme Court of Hawai'i. For Judge Pollack, elevation to the Supreme Court would be the culmination of a legal career spent serving the public and the justice system. I worked closely with Judge Pollack for 15 years in the Office of the Public Defender before he became a First Circuit Court judge. His knowledge of the law is exceptional and his writing abilities are second to none.

While Judge Pollack was the State Public Defender, I worked with him on many projects such as office manuals which covered substantive law as well as office operations and the drafting of model criminal jury instructions. I consulted with him in the trial and appeals of numerous cases. Judge Pollack always possessed a wealth of legal knowledge and his superb writing ability produced a very large body of briefs and substantive legal materials of the highest quality.

For the last twelve years as a Circuit Court judge, he has continued his high quality of work. Our office routinely appears before him and he has a reputation as a very learned jurist who is always well-prepared and knowledgeable on the relevant law. He has excellent judicial demeanor and is always respectful to all the parties who appear before him.

Most importantly, Judge Pollack believes in a strong Hawai'i Constitution. I am writing in support of the confirmation of Judge Richard W. Pollack as an Associate Justice of the Hawaii Supreme Court.

As a matter of introduction, I am currently the supervising deputy public defender for the Hilo Office of the Office of the Public Defender. I have been an attorney since 1981 and have been continuously with the public defender's office since 1984. However, please be advised that these comments are my personal views and recommendations and not made as an employee of the Office of the Public Defender.

I have known Judge Pollack for a long time. I have both worked with and for Judge Pollack while at the Office of the Public Defender.

I first became acquainted with Judge Pollack when he was the supervisor of the appellate section of the Office of the Public Defender. At the time, I was working in our Honolulu office as a novice trial attorney. The appellate section was, and is still, responsible for litigating all appeals generated statewide by our office. As the supervisor of that section, Judge Pollack had a reputation as an exacting leader of our appellate deputies and staff. It was clear that Judge Pollack was committed to our mission to provide zealous trial and appellate advocacy, though clear and concise presentation of the merits of each case. Judge Pollack was known for suggesting rewrite after rewrite of appellate filings so that our submissions to the courts reflected the best efforts of our appellate deputies. This effort was in keeping with Judge Pollack's personal and high standards of preparation, thoroughness and ability.

It was also common, for Judge Pollack and his staff of appellate deputies to provide, we, the trial attorneys of the office, advice and research assistance on complex legal issues. This counsel was essential in our representation of our clients before the courts.

In 1987, shortly before Judge Pollack was appointed State Public Defender, I transferred to our Hilo office. In 1999, I assumed the supervision of the Hilo Office. Obviously, during the time that Judge Pollack was the State Public Defender, I worked closely with Judge Pollack. I found him fully accessible to discuss any issues or problems of the office. In these discussions, Judge Pollack addressed the issues rationally and thoroughly.

It is quite natural to surmise that being a defense attorney for nearly my entire career, that my recommendation and support of Judge Pollack's nomination is based on perceived philosophical leanings. This would not be correct. Rather my recommendation is based upon the certainty that Judge Pollack will without question follow the law and interpret the constitution with due regard to judicial precedence, all with a clear understanding of how the decision of the Court will resolve not only a case in controversy, but also guide our courts in the future.

As a trial attorney, we are committed to represent our clients with requisite skill and competence. We are sworn to follow the constitution and to protect and preserve those rights owing to our clients. It is a truism that we as attorneys, however hard we fight, win some and lose some. But, ultimately it is the effect that these cases have on real people – the parties and the community at large - that is most important. And so it can also be said that our appellate courts are the fail safe for real people and our system of justice. There is great comfort in this thought.

In this regard, the Hawaii Supreme Court is a court of last resort under our State Constitution. As a court of last resort, we rely on the appellate courts to ensure that justice prevails. This is certainly my hope in the many of the cases that I have tried. I am fully confident that Judge Pollack has the courage and wisdom to see that justice is done and in so doing, render his duties as a justice of the Court with distinction.

Although I am unable to personally attend Judge Pollack's appearance before this committee and before the full Senate, please consider this written testimony as a statement in full support of Judge Pollack's confirmation.

Dear Chairman Hee, Vice Chairman Shimabukuro, and Members of the Committee:

I am writing this letter in support of the Honorable Richard W. Pollack for Associate Justice of the Supreme Court of Hawai'i.

I have been a public defender for two years and served a one-year clerkship for Judge Pollack.

Upon hearing Governor Abercrombie's appointment of Judge Pollack for this position, I called his chambers to express my congratulations. Judge Pollack graciously accepted the call but quickly cut short any further celebratory chat and ended the conversation with a simple, "Thank you." Some may think this response odd, but I realized why he was not willing to partake in celebration at that time. In many ways this two-word response illustrates the qualities that will make him an excellent Associate Justice of the Supreme Court of Hawai'i.

His reply, while only two words, is a reflection of his thoughtfulness and careful approach to issues. Given that the confirmation is still pending and that was not the appropriate time for jubilation. In clerking for him, I observed and learned the importance of cautious deliberation. When we would discuss issues, he would foresee the many possible outcomes and not just the most obvious answer. He would take his time, often focusing on minute details; a placement of a comma, for example. On many occasions, he would write, revise, and re-write findings to most accurately reflect the evidence or legal conclusions. Such mental gymnastics never seemed too tedious a task for him. He willingly shared his thought process and critical thinking skills with me and served as a remarkably mentor in my first job as an attorney. But more importantly for this Committee, it is clear that this focused, insightful, and metered approach to the law will translate well to the role of a Supreme Court Justice.

Judge Pollack's reply, while only two words, was genuine and humble; an accurate reflection of who he is. He was clearly a seasoned attorney and a judge while I was just a recent graduate of law school, yet he valued my ideas and opinions. He treated me with respect. His demeanor did not reflect an air of superiority, but instead, personified a real interest in my input. Moreover, this attitude continued in his interactions with many individuals, whether they were court staff, attorneys, witnesses,

defendants, or high-school students in the gallery. This innate sense of humility and respect for others has served him well in the past and if confirmed, he will translate these attributes to the highest court of our state.

Lastly, that two-word reply embodies his attitude in general—one of thankfulness. Judge Pollack has a personal appreciation for the State of Hawai'i and the people of Hawai'i. He is proud of his wife's Native Hawaiian heritage and supports her as Kumu Hula of her Halau. I had the pleasure of attending her annual Hula show and observed him beaming with pride at her accomplishments. Additionally, Judge Pollack would speak of his children, raised in Hawai'i, all of whom share an appreciation for the wonders of our State, including, hiking, surfing, and hula. As an Associate Justice for the Sate of Hawai'i, Judge Pollack would take special care in his role for the state which has provided him so much and that he has clearly grown to love. He would have pride in his work and realize the importance of interpreting the laws of Hawai'i for the people of Hawai'i. His connection to Hawai'i makes him a particularly appropriate candidate for this position.

I respectfully submit this testimony in support of appointing the Honorable Richard W. Pollack for Associate Justice of the Supreme Court of Hawai'i.

I have the highest regard for Judge Richard Pollack's background, intelligence, ability, work ethic, commitment, independence, moral character, and other factors relating to serving on Hawaii's Supreme Court. I strongly urge you to confirm him as an Associate Justice.

I am a Professor of Law at the William S. Richardson School of Law where I have taught since 1978. I have known Richard for more than 25 years. My early professional contacts with him came when he was the Public Defender. We later hired him at the Law School as an Adjunct Professor to teach the Criminal Defense Clinic in 1990. He was voted by the students as the "Adjunct Professor of the Year" in his last year of teaching before being appointed to the bench.

Richard taught at the U.H. Law School for more than a decade before he was appointed to the bench. I worked closely with him when he was teaching his clinic, and in a sense I was his "supervisor," or at least "advisor," because I am the Co-Director of the Clinical Programs. Richard and I frequently worked together to coordinate the criminal Prosecution and the Defense Clinics, and our students tried mock trials against each other every semester. He now teaches evidence and criminal procedure every year in our new, part-time night program at the Law School. Richard and I have worked very closely together on the evidence class, which I teach in the day program. We use a set of case materials and problems that we have jointly created for the course.

I think Richard's teaching at our school since he became a Circuit Court Judge merits special attention. He is the only active state-court judge that teaches at our school. He is a real "work-horse." He has taught evidence four times and criminal procedure twice since becoming a judge and now teach both those courses every year. His experience as a trial judge greatly benefits his students.

As you might know, it is the policy of the Hawaii Judiciary that state-court judges are not allowed to receive pay for any other state work, including teaching as adjuncts at the Law School. Before that policy was put into place, several former Circuit Judges taught at the Law School when they were sitting judges but all stopped teaching after the nopay policy was implemented. (Incidentally, a few other states have such an

interpretation of their constitutions, but most states do not. Judges are frequently law school adjunct professors in other states, and they are very popular with the students.). So, Richard Pollack is a "work-horse" who works for no pay if the conditions are right.

Richard not only enjoys teaching, he knows that teaching evidence and criminal procedure gives him an even better understanding of Hawaii law and requires him to keep abreast of national developments in the law. His teaching experience should also benefit him and his colleagues on the Supreme Court. Every appeal can have evidence issues, and about one-half of all published Supreme Court opinions involve criminal cases.

I think Judge Pollack's teaching indicates his dedication to high quality legal practice, his continued self-improvement, and his commitment to this legal community. It speaks very highly of him as a person.

In addition to Pollack's teaching, he and I have served together on the Hawaii Supreme Court's Standing Committee on the Rules of Evidence and have twice served together on committees to select the Federal Criminal Defender for Hawaii. In every capacity I have worked with Richard over these many years, he has been bright, hard working, conscientious, and independent. He has shown a great concern for his work and the legal community.

Finally, I want to comment on Richard's collaborative nature and temperament. Although he clearly very independent, moving from the trial bench to the Supreme Court will require not only independence, but also the ability to collaborate with other Justices to work effectively. I have seen him disagree, do it respectfully, and effectively persuade people. He is the kind of guy you are happy to disagree with, because the disagreement is not unpleasant, and you learn from him.

Judge Pollack is the only active, full-time state-court judge who has taught at the law school in many years. The students, faculty, and administration are very proud of him. He cares deeply about legal education and educating the next generation of lawyers. We at the law school also care about him, and we support his confirmation as an Associate Justice of the Hawaii Supreme Court. We are honored to be associated with him.

Thank you for the opportunity to testify on behalf of Richard Pollack.

Dear Chairman Hee and fellow members of the Committee on Judiciary and Labor:

I am writing to provide my enthusiastic support for the confirmation of the Hon. Richard W. Pollack to the position of Associate Justice of the Supreme Court of the State of Hawaii.

I first met Judge Pollack in 1981, when he was a Deputy Public Defender in Honolulu, and I was a Deputy Prosecuting Attorney. My recollection of Judge Pollack at that time, and in the years that followed before he was appointed to serve as a Circuit Court Judge of the First Circuit Court, is of a very intelligent and dedicated attorney, at both the trial and appellate levels. I would describe Judge Pollack's approach to trial work as a public defender as being in large part cerebral. He would analyze his cases to a fault. This approach ensured that Judge Pollack's advocacy before the court and juries would be thorough in the analysis of all pertinent facts, as well as in the application of the law to those facts. Judge Pollack's particular forte included a complete understanding of the rules of evidence and procedure, as well as a thorough familiarity with the relevant cases that were most helpful to his client's interests.

Judge Pollack was not a particularly "flashy" lawyer. He never used showmanship over the clear statement of the law in attempts to persuade the courts and juries before whom he appeared. From my perspective, his approach was far more persuasive, as it cut through potentially digressive matters and went directly to the legal issues at hand. In other words, Judge Pollack was a lawyer's lawyer, and as such, was demonstrably the best kind of attorney for elevation to the bench.

I write in wholehearted support of nominee Richard W. Pollack as an Associate Justice of the Hawaii Supreme Court. Richard, now Judge Pollack, was the Public Defender who, together with our late First Deputy Public Defender Dean Yamashiro, interviewed and hired me back in 1989. All new deputies begin their careers in the Appellate Section; at that time, Judge Pollack was both my immediate supervisor, as well as the overall head of the Office. Although very quiet and low-key, Judge Pollack always maintained extremely high expectations of both himself and those who worked for him. His work ethic, and of course his resultant work product, have always been exceedingly high. Judge Pollack has always been very "cerebral," which can be intimidating to "baby" deputies. However, he was always very patient and maintained a teaching/professorial approach in editing our briefs. Back then around the office, he was often described as (intellectually) brilliant and a "walking encyclopedia" of case law, adjectives with which I agree. After cycling through the misdemeanor and felony trial sections of our office before returning to the Appellate Section nine years ago, I have had some time to experience appellate jurisprudence full time. At this point, I can think of no better candidate than Judge Pollack to fill the current vacancy.

Judge Pollack's principal strength, as well as I believe his personal interest in the law, has always been his omniscient knowledge of the law. In addition to strong legal research skills and writing abilities, a must for appellate work, Judge Pollack possesses the rare ability to see trends in the law, to envision potential untoward consequences of appellate decisions (e.g., recognizing when a ruling might sweep unduly broadly beyond what is needed to determine the case at bar), and to recognize analogous situations far beyond the "average" legally-trained mind. Although I can only imagine that he has enjoyed the challenges of the circuit court bench, presiding over trials, I believe that Judge Pollack's true destiny lies with the highest level appellate courts.

I have been in practice as an attorney in Honolulu for 42 years. A high percentage of my professional practice has constituted trial work on the civil calendar. In that capacity, I had the pleasure of working with Judge Pollack when he was assigned to the civil calendar.

I had a number of cases with Judge Pollack which resolved before trial, frequently with Judge Pollack's work as our settlement conference judge. During the settlement conferences and throughout his presiding over the many cases in which I appeared before him, including motions practice, etc., I had the highest regard for Judge Pollack's brilliant mind, his dexterity in dealing amicably and productively with attorneys and their clients and the compassion he exhibited in all of his dealings.

Immediately before Judge Pollack returned to the criminal court calendar, I had the pleasure of Judge Pollack's presiding over the trial of a difficult case, which included a quadriplegic injury to a young mother. As I was representing the State of Hawai`i, the trial was a non-jury trial and Judge Pollack was dealing with four experienced, crafty and effective trial attorneys.
