It is with extreme pleasure and honor that I offer my whole-hearted support of Richard W. Pollack's nomination for Associate Justice of the Supreme Court. I retired in 2008 as the supervisor of the appeals division of the Office of the Public Defender after working for twenty-two years in all levels of the office. For many years, I worked on a daily basis with Richard Pollack as a trial and appellate attorney while he served as the supervisor of the appeals division and subsequently, as the Public Defender from 1987-2000.

Through my years of working with Richard, I am able to attest that Richard's personality and his years of experience as the administrator of a state-wide office demonstrate that he possesses in high measure, the quality of "judicial temperament" which is so desirable, and rare, in a judicial candidate. Judicial temperament is typified by recognition that there must be compassion as the judge deals with matters put before him or her.

Richard matches this definition. I have seen through my many years of working with him – analyzing cases, developing arguments, discussing administrative decisions and sharing day-to-day observations, how Richard was mindful of the consequences his decisions or judgment calls may have had beyond the immediate case. The wisdom and compassion Richard exhibited as a Public Defender make him an exceptional candidate for associate justice.

For these reasons and more, I am honored to offer support of Richard Pollack's nomination for Associate Justice of the Supreme Court.
