The Department of Land and Natural Resources (Department) supports Governor's Message 24 to appoint Ulalia Woodside to the Natural Area Reserves System Commission (Commission) for a term to expire 6-30-2017. Pursuant to §195-6, Hawaii Revised Statutes, Ms. Woodside will serve on the Commission as the member possessing a background in native Hawaiian_traditional and cultural land and water preservation and management practices and customs.

Ms. Woodside attended the University of Hawaii at Manoa where she earned a Bachelors of Arts in both Political Science and Hawaiian Studies as well as a Masters Degree in Urban and Regional Planning. She has been a Kumu Hula since her completion of Uniki Rites and Requirements at Pau o Hiiaka in 2008. Ms. Woodside is currently Kamehameha Schools' Regional Asset Manager for Natural and Cultural Resources where she is responsible for the management of a 190,000 acre property portfolio. She is also responsible for the development and implementation of programs on Kamehameha Schools' lands that preserve cultural resources and promote environmental stewardship statewide. Ms. Woodside's recent publications demonstrate her interest in both cultural and ecosystem services. Her extensive background in native Hawaiian traditional and customary practices will improve the effectiveness of the Commission in overseeing and advising on the management of cultural and archeological resources within natural area reserves. Ms. Woodside's membership would benefit the Commission and the Department.

The Department supports Governor's Message 24 on the appointment of Ulalia Woodside to the Natural Area Reserves System Commission.

Aloha Madam Chair Solomon, Vice Chair Galuteria and members of the Senate Committee on Water and Land. I am Soulee Stroud, President of the Association of Hawaiian Civic Clubs (AHCC) here to testify in support of Governor's Message 24 nominating **ULALIA WOODSIDE** to the Natural Area Reserves System(NARS) Commission.

During the regular legislative session of 2013 the Senate introduced and passed Senate Bill 1172 which would change the makeup of the commission to include a Hawaiian cultural resource person and remove the Superintendent of Education. The Department of Education seemed to have no objections to being moved off of the commission. The Association of Hawaiian Civic Clubs testified in favor of that bill in the Senate but the House has not yet given it a hearing.

The AHCC believes that the confirmation of Ms. Ulalia Woodside to the NARS commission would be in keeping with the Senate's intent of naming a commissioner with a background in Native Hawaiian traditional and customary practices. We also agree that Ms. Woodside would be an asset in oversight and consultation on management of cultural and archaeological resources within the natural area reserves.
