### Nomination to the Hawaii Teacher Standards Board Lisa DeLong

1. Why did you decide to apply to serve on the Hawaii Teacher Standards Board?

The HTSB plays a pivotal role in ensuring that every Hawaii public school student is taught by a highly qualified and effective teacher. This board sets and reviews teacher licensing standards, issues and renews teacher licenses, and approves teacher education programs. With my background as a teacher, administrator, and complex area superintendent, I believe that, as a board member, I can both inform the board and make informed decisions. The United States was founded on principles of democracy. As an HTSB board member, I want to ensure that every public school student in the state of Hawaii is guaranteed a viable education and well prepared for college, career opportunities, and productive citizenship.

2. Given your understanding of the roles and responsibilities of a member of the Hawaii Teacher Standards Board, why do you believe that you are qualified for the position?

As an HTSB board member, it will be my responsibility to ensure that every student in Hawaii's public school system is taught by a highly qualified and effective teacher. I decided that I wanted to become a teacher when, as a student at Kalaheo High School, I had the opportunity to tutor students with hearing impairments at a nearby elementary school. At the University of Hawaii, I majored in elementary education and eventually earned a Masters degree in special education. While in college, I volunteered in a variety of settings, from working with severely disabled students at Leahi Hospital and the Special Education Center for Oahu to participating in an exchange program at Boston College where I worked with students with learning disabilities at a progressive elementary school in Brookline, Massachusetts. I have since served as a teacher. vice principal, principal, and complex area superintendent in the Hawaii public school system. As the principal of Kahuku High and Intermediate School from 2000 to 2009 I worked with the school community to launch the AVID program to promote a college going culture, move the school into Smaller Learning Communities, and was recognized as the Hawaii's 2005 National Association for Secondary School Principal of the Year. These experiences have provided me with a foundation from which I can build as I work on the HTSB board.

3. What do you perceive the role and responsibility of the Hawaii Teacher Standards Board as it relates to teacher quality and student achievement?

Good teaching matters. Irrefutable evidence from researchers such as Judith Warren-Little, Rick Dufour, and Mike Shmoker shows that teacher quality impacts student achievement. As an HTSB board member, I will influence policies and practices that promote the high quality training and selection of

teachers. I understand that my decisions will impact 184,213 students who attend 291 schools within the Hawaii public school system. I will work to boost student achievement by attending to the quality of teacher preparation, recruitment, licensure, hiring, assignment and ongoing professional development.

4) Because of long-standing legislative concerns, Hawaii Teacher Standards Board was audited by the State Auditor in 2009. What progress has been made in your tenure and what more could or should be done to improve the perception and effectiveness of HTSB?

The HSTB has significantly improved oversight and management since the 2009 audit. For example, almost 100% of Hawaii Department of Education teachers are now current with their licensing requirements. As the principal of Kailua Intermediate School, I work with teachers who are applying to both the Department of Education and the Hawaii Teacher Standards Board to earn basic teaching credentials. I can use their feedback about this process to inform and improve HTSB work.

5) Can you foresee any possible conflicts of interests that could arise during your service on the Hawaii Teacher Standards Board? How would you overcome any possible conflicts of interest?

I can't think of any conflicts at this time.
