begs leave to report as follows:

Your Committee has reviewed the personal history, resume, and statement submitted by the nominee and finds Kenneth Chang to possess the requisite qualifications to be nominated to the Board of Private Detectives and Guards.

Your Committee received testimony in support of the nomination of Kenneth Chang from the Department of Commerce and Consumer Affairs and four individuals.

Upon review of the testimony, your Committee finds that Mr. Chang's background, experience, and commitment to his profession qualify him for appointment to the Board of Private Detectives and Guards as a licensed private detective member. Your Committee notes that Mr. Chang spent over twenty years with the Honolulu Police Department, retiring as a Lieutenant in 1993.
